Shooting Spree In Kewaskum Township Leaves Three Dead

Three Washington County men are dead after a shooting spree occurred in the Town of Kewaskum on Wednesday, Feb. 3.

Two innocent citizens, ages 72 and 77, were killed at different residences on Forest View Road in the Town of Kewaskum. The lone suspect, a 30-year-old West Bend man, died after being shot by a Washington County sheriff's deputy.

"There is no indication at all that the suspect had any knowledge of his victims or any vendettas at all. It was tragically just a completely random act," Washington County Sheriff Martin Schulteis said.

The Washington County Sheriff's Office will not be releasing names of the victims, but family members have identified the 72-year-old victim as Ray Engelking. The name of the suspect will be

released following an investigation by the Wisconsin Department of Justice's Division of Criminal Investigations, according to Schulteis.

According to the Washington County Sheriff's Office, the incident started around 2:30 p.m. on Wednesday, Feb. 3, when a 30-year-old City of West Bend man stole a car in the City of West Bend. At around 2:45 p.m., the suspect crashed the car on Forest View Road north of Ridge Road in the Town of Kewaskum after he failed to negotiate a curve. The suspect survived the roll-over crash and was able to get out of the vehicle.

He then forced entry into a nearby unoccupied residence. At the same time, a 52-year-old Port Washington woman came upon the accident and pulled over to check to see if anyone needed assistance. She encountered the suspect, who physically assaulted her and

attempted to take her car. The suspect crashed that car while leaving the driveway.

The suspect then ran to another nearby residence in the 8100 block of Forest View Road. At 2:50 p.m., he forced entry into the locked front door of the home and encountered the homeowners. The suspect demanded and obtained their car keys. He attempted to drive away, but was not able to start the car.

The suspect came back into the residence and physically assaulted the elderly couple. He once again exited the home in an attempt to steal the car. The male homeowner retrieved a handgun for protection. The suspect was able to overpower the victim and took control of the gun.

The club also provides the lighting for one mile of the trail. It works in partnership with the State Forest staff in maintaining and improving these trails for skate and classical skiers. They are located off Kettle Moraine Drive between County Road T and Hwy 67 near Greenbush. You can access the six loop trails either from the Trailhead or from the Greenbush Group Camp parking lot, which provides much more parking than the Trailhead.

The Zillmer Trails, located off County Road SS between County Road G and Hwy 67 near New Prospect, offer a second set of four groomed loop trails. The State Forest staff keeps the Zillmer trails in great condition for both classic and skating styles of cross-skiing. For trail conditions, checkout skinnyski.com.

Because of COVID-19 protocols, the warming shelters at both Zillmer and Greenbush are

closed this year, so plan accordingly. There are vault toilets and drinking water available at each location along with outside grills, picnic tables, and campfire rings. For a great skiing adventure and whole body workout, come dressed for the weather, and bring drinking water, high energy snacks, and dry clothes for the ride home.

If you don't have any gear, don't fret. You can rent cross-country ski equipment from Attitude Sports in Fond du Lac and Mountain Outfitters in West Bend. If you decide to purchase cross-country skis, you can with a modest investment. Talk with the experts to figure out the best set ski, poles, and boots to meet your needs. Be warned that this year you may find certain sizes in short supply due to an increase in the sport's popularity.

Unlike downhill skiing where you need to pay each time you ski, cross-

country skiing at a State Park System property only requires a valid Wisconsin State Park System vehicle admission sticker and an individual trail pass for those 16 years old and older. The vehicle admission sticker allows you access to any property in the State Park System. The trail pass is not only good for cross-country skiing, but can be used for mountain biking, in-line skating, biking on many State Trails, and horseback riding at properties that require it. These may be purchased on-line, over the phone, at a self-registration kiosk, or in person at a State Park System Property with window service.

For information, call the Kettle Moraine State Forest – Northern Unit headquarters at 262-626-2116. Winter's snow won't last long, so hit the trails soon to enjoy a great cross-country ski workout in the beautiful winter woods!

Kewaskum's Days Gone By

5 Years Ago February 18, 2016

Nancy Rodenkirch is not sure how long she has been working as an election inspector for the Town of Farmington, but according to town records, it has been at least 47 years. She remembers that she did work the polls in 1968. One of her memories included when a man came in with his daughter to introduce her to voting when she became eligible. A police officer made Rodenkirch move her vehicle because it had a political sticker on it and was supposedly parked too close to the door of the town hall. Rodenkirch received a plaque of appreciation when she retired recently.

Farmington Elementary was recognized as one of 11 schools across the state to have met the criteria to be a Title I High-Achieving and High-Progress School. This is the first time a Kewaskum school has been recognized with such a distinction.

On February 11, Gov. Scott Walker ate lunch at Slinger House Pub and Grille before holding a listening session in Jackson. He also met individually with local newspaper reporters. Also meeting with the governor was Mitchell Smith of Campbellsport who has been a fan of Walker for many years.

Area firefighters responded to a milk truck fire on the corner of State Road 28 and Fond du Lac Avenue on February 13.

Holy Trinity Parish received approval from the Kewaskum Board of Appeals on February 11 to construct a new parish center within the 25-foot minimum street allowance and to use crushed asphalt for its parking lot surface. The village board and plan commission have both already given approval for the building project.

Beginning in 2016-17, the Kewaskum School District could lose about \$56,000 a year under a proposal from Rep. Robin Vos (R-Rochester) that would limit the amount a school district can tax for new voucher students. The proposal came in the form of an amendment to Assembly Bill 751, which was slated to go before the House Floor on February 16.

Kewaskum High School's two mock trial teams competed in regionals February 13 in Green Bay. Ten teams competed. The Kewaskum teams finished in the middle of the pack.

The February Kiwanis Students Of The Month are Alyssa Heberer and Lindsey Du Charme.

Kewaskum Middle School students will present Peter Pan February 19 through 21.

Eric Bauer, Alex Deheck, Ben Watzig and Riley Donovan have advanced to the K-2 sectional tournament. The wrestlers were in Campbellsport for regional action. Bauer's record is 44-1, Watzig's is 25-2, Deheck's is 36-5, and Donovan's is 8-11.

15 Years Ago February 16, 2006

Michael Krumm has been approved by the Kewaskum Board of Education to lead the district's administrative affairs. The Iowa native's contract was approved by the board for \$107,000 annually. Krumm will come to Kewaskum July 1 from Ballard Community School District, which encompasses approximately 85 square miles and a district population of almost 7,000 residents. He is expected to attend the board's March 13 meeting. Interim Superintendent of Schools Scott Peterson will remain on the district's payroll until June 30.

The Kewaskum Statesman office will be moving again. In 2004, the office moved because the space it was in was deemed too small. The space it now has is deemed too large. The office will be closed March 1-6.

St. Francis Bank in Kewaskum presented a check of funds raised through St. Francis' COMMUNITY Banking fundraising program that is available for local groups through St. Francis. The bank makes a one-time contribution for every participant who opens a new personal checking, savings, IRA, CD or money market account and asks that the account benefit the participating organization.

The Town of Kewaskum has a new clerk. On Monday, town supervisors voted to hire Nancy Boden for the job. Boden will be sworn into office immediately and be ready for her first meeting February 20. Previous Town of Kewaskum clerks have been paid an annual salary of \$18,000 because the clerk has also been an administrative assistant and zoning secretary. The town will ask taxpayers to create an additional position of zoning secretary and administrative assistant. The clerk will have an annual salary of \$12,000; and will have the opportunity to also earn \$12 per hour for administrative assistant and zoning secretary duties.

A 24-year-old Racine man who has confessed to being involved in numerous home intrusions in the Townships of Addison, Polk, Kewaskum and Wayne was arrested February 9 in Baraboo. During the intrusions, Michael Shaun Weymier took the time to make coffee, cook and eat meals, take showers, pick out a change of clothes, watch television and check his e-mail.

A 16-year-old male from Kewaskum has been referred to juvenile authorities after being accused of taking \$411.90 from his Kewaskum employer. The employer set up a camera and photos revealed the 16-year-old took the cash.

The New Fane Sportsman's Club recently donated \$500 to the Kewaskum Police Department's 2005 DARE program. The DARE program consists of bringing a uniformed officer into the fifth grades of the local elementary schools, where the officer instructs the students about drug and alcohol abuse and how to resist becoming involved in those destructive behaviors.

February's feature is from 1910 and is the former Corner Drug Store, located on the corner of Fond du Lac Avenue and Main Street. At one time, it also housed The American Hotel. The landmark remains at the corner today. Susen has already begun working on the calendar for next year.

Two resolutions that authorize borrowing a total of \$685,000 to finance two municipal projects were given village board approval. Included in the \$490,000 sum is finance additions and improvements to the village sewage treatment plant and \$195,000 to finance the sewer and water installation in Bel-Ric Acres subdivision.

Father William Bonesho, pastor of St. Michael's Church located three miles east of Kewaskum, said "we will rebuild." The church was entirely destroyed by fire on January 4 when it was struck by lightning in a freak mid-winter electrical storm. The congregation has designated a building committee and has begun plans for the project. It has not yet been determined whether the congregation will rebuild the old church using the wall shell of the structure or construction a new building.

The board of education agreed to hire the architectural firm of Schutte-Mochon, Inc. for the proposed building expansion program when it met Monday night. A referendum will be dated February 22, a general informational meeting on April 1 and a referendum on the proposed expansion at the April 6 spring election. Four architectural firms have been interviewed by the board. Schutte-Mochon was chosen because of its competence, because it is familiar with the district and because it saved the district about one-half million dollars in recommending that the present high school site be expanded instead of building a new high school on another site.

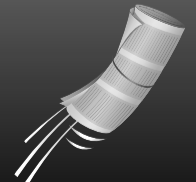

Agnesian HealthCare Extending Vaccinations To Patients 65 Years And Above

Since the Wisconsin Department of Health Services (DHS) gave approval for adults age 65 and older to begin receiving the COVID-19 vaccine, Agnesian HealthCare has been planning and implementing vaccine clinics in Fond du Lac, Ripon and Waupun.

Shooting Spree In Kewaskum Township Leaves Three Dead

He then fatally shot the 72-year-old homeowner, whom family has identified as Ray Engelking. The suspect then attempted to shoot Engelking's wife, identified by family as Deborah Engelking, but the firearm did not fire.

The suspect then fled on foot to another residence in the 8200 block of Forest View Road, where he encountered another resident. The suspect obtained a shotgun in the resident's home and fatally shot the 77-year-old male resident just outside his garage. The suspect then fled the residence. This homicide was unwitnessed.

Moments later, the first-arriving deputies encountered the armed suspect on Forest View Road near the scene of the second homicide as he was leaving that area around 3:05 p.m. A deputy and the suspect exchanged gunfire, and the suspect was struck with a law enforcement round.

Law enforcement established a perimeter, and a drone located a person matching the suspect's description a short distance north of the initial encounter with deputies. Officers approached and found the suspect deceased from an apparent gunshot wound. A firearm was also located near the decedent.

The shooting deputy is a nine-year veteran of Washington County law enforcement and has been placed on administrative leave as a standard protocol pending the outcome of an independent investi-

gation by the Department of Criminal Investigations. He was not injured as a result of this incident.

"This horrific incident has struck this community and our agency at its core. We lost two valuable members of our community at the hands of this senseless crime spree. Their absence will impact many and we mourn with you. Our thoughts, prayers, and sympathies go out to the surviving victims and families of the deceased whose lives are forever changed. There are many more questions to be answered as to why this occurred. I assure the community that investigators are working diligently to be able to provide those answers. In the meantime, we ask that the public respect the privacy of the victims and their families and allow them to grieve," Schulteis said.

"Our deputies never want to be placed in the position where they are required to use lethal force against our citizens. I am proud of the overwhelming law enforcement call to action which no doubt mitigated further violence from occurring; however, that does not provide peace to the loved ones of our victims. I believe the deputy's actions were tragically necessary to protect the deputy and the community he took an oath to protect. Ultimately the independent investigation will be forwarded to the Washington County District Attorney's Office to review, but our deputy's

actions ended a murderous rampage within our community," Schulteis added.

Internally, the Washington County Sheriff's Office is conducting a critical incident debrief this week for all staff members who were involved in the case. This will allow staff members to talk with professional counselors about the incident.

"It's not a tactical review of this; it's more on the emotional end of it. We want to care for our staff," Schulteis said.

The complex crime scene spans approximately 0.6 mile on Forest View Road in the Town of Kewaskum. The Washington County Sheriff's Office received assistance from the Wisconsin State Patrol and the West Bend Police Department.

During last week's incident, the Command Center was set up in the parking lot of St. Michael's Catholic Church, located on the corner of State Road

28 and Forest View Road in the Town of Kewaskum. The church was planning to hold a Holy Hour and Rosary this Wednesday, Feb. 10, at 7 p.m. to pray for the victims of the recent tragedy in the community and an end to violence.

Washington County Sheriff's Office investigators continue to piece together the tragic events that occurred.

"We are doing a 72-hour pre-incident history investigation on the suspect, and really the goal of that is to

provide the community with as many answers to the 'why' questions as we can. It is our intent to release the suspect's name as soon as we complete that investigative process," Schulteis said.

Engelking Statement On The Killing Of Ray Engelking

The following statement was made on behalf of the Engelking family by Rhett Engelking, a son of Ray L. Engelking, who was a victim of last week's shooting. He requested that the full statement be published in its entirety.

The Engelking family of Forest View Road in Kewaskum would like to provide this statement to address the public inquiries into the events of Wednesday February 4th, 2021. Our family has read the details of the Press Release prepared by the Washington County Sheriff's Department, and we want to affirm that the details contained therein are consistent with our

understanding of what occurred at our family residence during the timeline set forth by law enforcement. First of all, we want to thank local law enforcement for their respectful and thorough response to the assault, forced entry, and murder at our family residence by a previously unknown individual. We also want to extend our deepest condolences to the other families traumatized during these events; we join in their sorrow. Secondly, we want to confirm that while protecting the security of Deborah Engelking—the mother to his three boys and grandmother to three girls—our "Papa," Ray Leonard Engelking was

indeed killed by a bullet fired during a violent confrontation with the intruder, who assaulted Mrs. Engelking. She has not exhibited any lasting physical injury thus far, but the emotional wounds are considerable. Without hesitation, she handed over keys to her vehicle but it wasn't enough. Similarly, Papa was an avid sportsman with deep reverence for life and commitment to research-backed gun safety measures. He would have gladly relinquished every gun he owned if it meant preserving any life lost or traumatized that day. Tragically, our family has now joined a long suffering group of families who have lost loved

ones to the ongoing epidemic of gun violence. Despite all of this, and despite the constraints the COVID-19 pandemic has placed on our interactions with loved ones, we are not giving into fear.

We are navigating difficult emotions at this time, but with the limited distance we currently have from the situation, our only regret is that the young white man who came rampaging through our peaceful neighborhood had not had the opportunity to sit for a semester in one of Mr. Engelking's classes or spend a season with him on one of the many sports teams Papa coached in this community. Sadly, the fugitive did not know a man who would have been willing to be a coach, teacher, or Big Brother to him or any individual navigating

the struggles of poverty, addiction or an otherwise troubled past. Papa compassionately practiced the Christian value of forgiving those who knew not what they were doing, and he labored for a criminal justice system that prepared and supported offenders to fully rejoin society as equal citizens. We have been disappointed by the lack of context in some of the responses expressed on our behalf by members in our community. Frustratingly, the 72 bright years of our father's life have been reduced politically to the circumstances of the last 5 minutes. Our family deeply believes in the transformational power of publicly accessible education to give people hope, support, and options in the midst of a challenging world. As

the community mourns our loss at the hands of a manic individual we hope they will also be aggrieved at the tragic and violent circumstances that originated in our community and set him on this course long before any confrontation with our neighborhood. Like his personal hero, Dr. Martin Luther King Jr. Papa was convinced that in the presence of justice, a beloved community could create a "qualitative change in our souls and a quantitative change in our lives." Finally, we request that our family be granted a generous time to grieve and process in private how our family can continue to carry on the heroic light Papa brought to each of our lives.

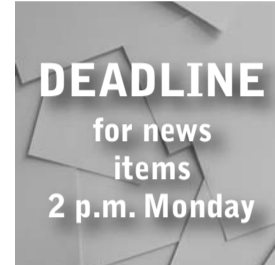

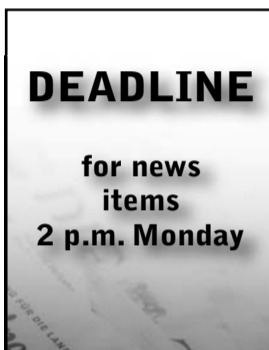

INFORMATION TO VOTERS

Upon entering the polling place, a voter shall state his or her name and address, show an acceptable form of photo identification and sign the poll book before being permitted to vote. If a voter does not have acceptable photo identification the voter may obtain a free photo ID for voting from the Division of Motor Vehicles. If a voter is not registered to vote, a voter may register to vote at the polling place serving his or her residence, if the voter presents proof of residence in a form specified by law. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall retire alone to a voting booth and cast his or her ballot except that a voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An election official may inform the voter of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

The voter shall fill in the oval next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote and fill in the oval next to the write-in line. On referendum questions, the voter shall fill in the oval next to "yes" if in favor of the question, or the voter shall fill in the oval next to "no" if opposed to the question.

When using an *electronic ballot marking device ("ImageCast Evolution-ICE")* to mark an **optical scan ballot**, the voter shall touch the screen or use the keypad to select the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the voter shall touch the screen or use the keypad to select "yes" if in favor of the question, or the voter shall touch the screen or use the keypad to select "no" if opposed to the question.

The vote should not be cast in any other manner. Not more than five minutes' time shall be allowed inside a voting booth.

Sample ballots or other materials to assist the voter in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone in a manner that would reveal how the ballot is marked.

Spoiled Ballots

If the voter spoils an **optical scan ballot**, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official, who shall issue a proper ballot in its place.

After Voting the Ballot

After an official **optical scan ballot** is marked, it shall be inserted in the security sleeve, so the marks do not show. The voter shall insert the ballot in the voting device and discard the sleeve or deliver the ballot to an inspector for deposit.

If a central count system is used, the voter shall insert the ballot in the ballot box and discard the sleeve or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

A voter may select an individual to assist in casting his or her vote if the voter declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

OFFICE OF THE FOND DU LAC COUNTY CLERK TO THE VOTERS OF FOND DU LAC COUNTY:

Notice is hereby given of a spring primary election to be held in Fond du Lac County on the 16th day of February 2021, at which the officers named below shall be nominated. The names of the candidates for each office, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, in the sample ballot below.

INFORMATION TO VOTERS

Upon entering the polling place, a voter shall state his or her name and address, show an acceptable form of photo identification and sign the poll book before being permitted to vote.

If a voter does not have acceptable photo identification the voter may obtain a free photo ID for voting from the Division of Motor Vehicles. If a voter is not registered to vote, a voter may register to vote at the polling place serving his or her residence, if the voter provides proof of residence in a form specified by law. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall retire alone to a voting booth and cast his or her ballot except that a voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An election official may inform the voter of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

Where Optical Scan Voting is Used

The voter shall fill in the oval next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote and fill in the oval next to the write-in line.

The vote should not be cast in any other manner. Not more than five minutes' time shall be allowed inside a voting booth. Sample ballots or other materials to assist the voter in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

Spoiled Ballots

If a voter spoils an optical scan ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official, who shall issue a proper ballot in its place.

After Voting the Ballot

After an official optical scan ballot is marked, the voter shall leave the booth and insert the ballot in the voting device.

The voter shall leave the polling place promptly.

A voter may select an individual to assist in casting his or her vote if the voter declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

Waupun Sweeps Kewaskum

On Friday, Jan. 29, the Indians hosted the first-place Waupun Warriors. Kewaskum battled and hung around throughout the first half and trailed 32-20 at the half.

Despite Madi Dogs' 16-point, nine-rebound, five-steal performance, the rest of the Indians went cold, shooting 24 percent for the game. The game felt very similar to the game earlier in the season in Waupun. The one improvement was Kewaskum's ability to keep Waupun off the offensive glass much more effectively.

Muellenbach And Blanchard Qualify For State Wrestling

This past Saturday, five Campbellsport wrestlers participated in the sectional wrestling tournament at Kiel.

Junior Drake Muellenbach (113 pounds) and sophomore Ostin Blanchard (120 pounds) qualified for state by finishing in second place. The top two in each weight class moved on. JJ Ksioszk placed fifth, Sam Koth sixth, and Joseph Volz just missed going to state by finishing third.

In Drake's first match he faced Jake Shaver (7-2 record) from Sheboygan Falls. Drake found himself down 3-2 going into the second period, but used a reversal and a three-point near fall in the second to take a 7-4 lead heading into the third. Drake got a takedown in the third before giving up a late reversal to take a hard fought 9-6 decision.

In the semi-finals, Drake faced 9-0 Chase Rodriguez of Big Foot/Williams Bay. Rodriguez was leading Drake 2-1 after two periods. In the third, Drake chose the down position and got a reversal and wrapped up Rodriguez in a cradle for three near fall points and held on for a 6-2 decision.

In the finals, Muellenbach ran into a buzz saw and fell to Devin Gore (12-0) by technical fall. Gore is currently ranked fifth in the state. Drake did not have a wrestleback for second as Chase Rodriguez came through on the back side and since Drake already beat him, he automatically took second.

This is Drake's third trip to state.

Ostin started off the day by facing Deondre Williams of Martin Luther and wasted no time by taking him down and putting his shoulders to the mat in 1:17. His semi-final match found him pitted against freshman sensation and

fourth-ranked Eyan Dessellier from Kiel (9-0). Ostin wrestled to a 0-0 first period, but in the second he got caught in a cradle and pinned.

Ostin got refocused, and in the consolation semi-finals he pinned Aiden Miller (9-3) of Sheboygan Falls in 1:59.

In his third place match he battled Cole McPherson (11-2) of East Troy. Ostin got a takedown in the first, while Cole got a takedown in the second to tied things up 2-2 and set up an intense third period. Each wrestler fought off shots from their opponent, but it was Blanchard who used a snap down and spin to get the takedown and he rode McPherson out the last 45 seconds to get the 4-2 win.

Meanwhile, Ostin needed Dessellier from Kiel to win the championship so he could get his wrestleback for second place and that's exactly what happened. Ostin faced Chris Karbash (7-3) of Delavan Darian for the right to go to state. Ostin used three takedowns in the first period to establish a 7-5 lead. Ostin chose down in the second period, got an escape and used a hard snap down and spin to get the takedown. He then ran a half nelson and pinned Karbash in 3:00 to earn his first trip to state.

Joseph Volz finished the day 2-2, placing him third. Volz pinned Samuel Haeuser (Racine St. Catherine's) and Phoenix Fortune (Chilton/Hilbert) in the first period and faced Jackson Funderburg of Big Foot/Williams Bay (11-0) for the championship. Funderburg took advantage of his size and experience to pin Volz in the second period.

Volz would have a wrestleback for second and faced Aaron Socha of Ripon. After a score-

less first period, Volz chose down and, after a small scramble, got caught on his back and pinned. Volz finished his amazing freshman season with a record of 15-3 with 10 pins.

Freshman JJ Ksioszk lost a hard-fought 5-4 decision to Kade Novak of Plymouth in his quarterfinal match. In his second match, he faced Melvin Finkley of Martin Luther and took an 8-0 lead into the third period. JJ reversed Finkley and pinned him in 4:36.

After losing his consolation semi-final match, Ksioszk faced Daniel Sanchez from Racine St. Catherine's.

Sanchez was leading 5-2 in the second and had the boots in on JJ. Sanchez got high and JJ grabbed his head and pulled him down onto his back and got the pin in 3:25 to earn fifth place.

Sophomore Sam Koth lost his first match by fall and then wrestled Jacob Dalton from Delavan Darian. Sam got a reversal in the second period to give himself a 4-3 lead heading into the third. Dalton chose down and Koth countered every move Dalton threw at him and rode him out the entire period to earn the win. Koth would finish in sixth place.

Sturgeon Spearing Season Forecast

Wisconsin's annual sturgeon spearing season begins this Saturday, Feb. 13, and runs for 16 days, or until any of the pre-determined harvest caps are met. This year, the Wisconsin Department of Natural Resources (DNR) predicts that harvest caps will be met prior to the 16-day season limit.

System-wide harvest caps for the 2021 Winnebago system sturgeon spearing season are 430 juvenile females, 950 adult females and 1,200 males.

Sturgeon spearing in Wisconsin is a sport rich in tradition and culture. Photos are a great way to preserve highlights of the season. The DNR encourages spearers to share their stories using the photo submission form at <https://www.surveymonkey.com/r/SturgeonSpearing>. Photos of spearers with their catch, cutting in, shanty life, scenic views observed during the season or any other captivating spearing traditions are encouraged. Please include a brief description for use in future outreach efforts.

Clear Waters Will Likely Result In High Harvests

This year, with more snow cover and less runoff leading up to the season kickoff, the DNR anticipates better water clarity than seen in recent years. Since water clarity is crucial in spearing success, the DNR expects higher harvests from Lake Winnebago in 2021 and for harvest

caps to be met before the 16-day season cutoff.

Spearers who have already scouted for the best areas for fish activity have reported clearer water, which was confirmed by DNR staff during a preliminary clarity check showing between 10 to 16 feet of clear water. Historical harvest data shows that an average lake-wide clarity of 12 feet or greater typically results in a shortened season with harvest caps being met more quickly. As the season approaches, the DNR will monitor water clarity since conditions can change rapidly.

Additional season forecasts and daily season harvest reports will be available throughout the season on the Winnebago system sturgeon spearing webpage.

Important Season Changes

Spearers should review the 2021 sturgeon spearing regulations for essential changes to the registration process, including new spear size and time arrangement restrictions.

For the 2021 season, all DNR registration stations will be contactless. Spearers should place harvested sturgeon on tailgates or in an easily accessible location before entering the registration area and then remain in their vehicles throughout the registration process.

The 2021 season will also be the first year that spear size and time

arrangement will be restricted. The maximum spear head width is now limited to 18 inches and tines can only be arranged in a single plane.

2021 Ice Safety Measures

Although recent cold weather has strengthened ice conditions throughout the Winnebago system, the DNR reminds spearers that no ice is ever 100 percent safe. The DNR does not monitor ice conditions, so spearers should check with local fishing clubs and conservation groups near the area they plan to spear. These groups monitor conditions and maintain access points and ice roads around the lake system.

Regulation Changes

As you get ready, make sure to keep the following regulation changes in mind:

- Spear head width is restricted to 18 inches or less, and tines can only be arranged in a single, straight line.

- Registration stations have been relocated to parking lots at boat landings, city parks and government buildings. We plan to return to previous registration locations once it is safe to do so.

- To help keep spearers and staff safe, stations will operate as drive-thru only. Spearers must remain in their vehicle throughout the registration process.

DNR Now Accepting Submissions For 2022 Stamp Design Contests

Have your artwork featured on a piece of history and contribute to environmental restoration efforts by entering the Wisconsin Department of Natural Resources' (DNR) 2022 Wisconsin wild turkey, pheasant and waterfowl stamp design contests. Artists must submit their entries by July 15th for the 2022 contests.

"The contests offer a unique opportunity for Wisconsin artists to showcase their artwork statewide while also promoting wildlife management," said Alaina Gerrits, DNR assistant upland wildlife ecologist.

Turkey, pheasant and waterfowl hunters are required to purchase a species-specific stamp to legally harvest game birds in Wisconsin. The DNR's wild turkey, pheasant and waterfowl stamp programs provide opportunities for wildlife and habitat management, with efforts directed toward key species.

Funds derived from

the stamps' sale support species management throughout the state, including habitat management, restoration, education and research projects.

Wisconsin residents 18 years of age or older who are U.S. citizens or legal permanent residents are encouraged to enter the 2022 contests. Artwork must meet technical requirements to be eligible, and applicants should review contest

rules carefully to ensure their entries' eligibility. Read full contest rules and reproduction rights agreements on the DNR's website.
