Stoffel Brothers Celebrate 154 Years Of Service With The Campbellsport Fire Department

The Stoffel brothers of Campbellsport recently celebrated a very unique mark with the Campbellsport Fire Department. Three of the brothers have each been recognized for 50 years of service to the Campbellsport Fire Department.

Don Stoffel has served the longest with 53 years on the department. Melvin has been with the department for 51 years and Tony for 50 years. Both Melvin and Tony received their plaques for 50 years of service to the department at the annual banquet on Saturday, March 13.

To the three brothers, this is nothing unusual. Members of their family have a strong record of service with the volunteer fire department. When totaling up the years of service of their father, brother Ralph,

uncles and children, the Stoffel family members have served the department for centuries.

"We have over 400 years," Tony said.

Their father served for about 40 years. Their brother Ralph was with the department for 20 years before he moved to Green Bay for work. The three other brothers all agreed that he probably would have put 50 years in too if he didn't have move out of the area.

They all agreed that service is in their blood but the community and fellow firefighters keep them volunteering.

"It's the people," Melvin said. "I enjoy serving the people."

"I've never regretted it," Don said. "The community has always been good to us."

The three laughed as they recalled one fire call

Washington County Opens Back Up UK Variant Of COVID-19 Detected In Washington County

Washington County Executive Josh Schoemann issued a statement on Thursday, March 18, announcing that the county is reopened to full capacity.

"It is with measured optimism and a hopeful spirit that today I announce and acknowledge the people of Washington County have begun a new phase of this COVID journey. This new phase is best characterized as a movement toward a full return to life as we have long known it, free from government restrictions and recommendations, and renewed in our commitment to fully embracing personal responsibility and individual liberty with love for our neighbor," Schoemann stated. Schoeman also stated that he has directed the

Washington Ozaukee Public Health Department (WOPHD) to assist in reopening churches, businesses, civic organizations, schools and more "in order to restore normalcy to our daily lives."

The following day, on Friday, March 19, the Washington Ozaukee Health Department announced that a Washington County resident had tested positive for the new B.1.1.7 COVID-19 variant strain (UK variant).

The Washington County resident was tested in February, and the Wisconsin Department of Health Services notified the county health department on March 12 of the test results, according to the Washington Ozaukee Health Department. This strain

Kewaskum Community Remembers James Manthei

Service Held 50 Years After Manthei Was Killed In Action

It has been 50 years since James Walter Manthei was killed in action in Vietnam, but the Kewaskum community has not forgotten him.

About 75 people attended the event a memorial service that was held for Manthei at the Wisconsin 9/11 Memorial in Kewaskum on Sunday, March 21, exactly 50 years after Manthei was killed on March 21, 1971. Manthei's family members and friends, as well as community members were at the service. They wanted to recognize Manthei's ultimate sacrifice.

On March 21, 1971, Warrant Officer James Walter Manthei was working as a co-pilot for the Army's First Aviation Brigade when the tail rotor of the helicopter he was flying was shot by enemy fire while he was supporting ground troops in Laos. He was 20.

"It has been 50 years, but it is still hard. Jim was my brother, and I miss him," Bob Manthei said.

Chuck Theusch, a member of the American Legion Robert G. Romaine Post 384 in Kewaskum, organized the service to in honor of James Manthei, who was his friend. Theusch said that when he put the program together, he aimed part of it at why Manthei died.

"He died because he believed in freedom," Theusch

This is a vastly different village than the one some of us remember. My family moved away from its outskirts in 1977

and wound up just 10 miles or so up the road in Marblehead, then itself a whole different community than it is now. More populous anyway.

The Campbellsport called to remembrance was a gathering of around a thousand souls. Summers were much the same except for the slap of a rickety wood screen door behind us.

We lived a half mile north of the village on Country Trunk W in a farmhouse below the hill. A routine enough event was a walk into town. Usually to Straub's Red and White Grocery on Main Street. When Mom needed fixins for supper or the like.

The trek was often with my older brother Lee, who guided me down Elm Street. If we had to go farther uptown, it meant a shortcut along the edge of Stella Cheese's parking lot and

a shimmy down the alley alongside Rheimer's tavern or up behind and

around the post office.

Barnes' grocery store lay across Main Street but the profusion of businesses farther west, the Ben Franklin, Heldt's Drugstore or Schlaefer's Hardware (when one of the kids broke something around the house) often found us wandering in that direction.

A brief pit stop at the bakery just the other side of the dime store refreshed us, then it was homeward bound. The point here being that vast gulf between then and now.

How the village has grown and moved forward into the the unforeseen future. Were those past times better? Probably not. Simpler? Only from a less advanced technology state. But that's the approach this writer comes from.

It will deal with both what was and is now. If that's a journey you'd like to share, c'mon along.

was first identified in Wisconsin on January 12.

As new strains of SARS-CoV-2 emerge and spread more easily, the Washington Ozaukee Public Health Department wants to remind community members to practice safe hygiene by wearing a mask when in public, practice physical distancing, get tested after an exposure and, most importantly, get the vaccine when able.

According to the Washington Ozaukee Public Health Department's website, the COVID-19 risk status on Monday, March 22 was: "moderately high" burden (total number of confirmed cases in the last two weeks); "decreasing" trajectory (percent change in the last two weeks); and "moderately high case status (total number of confirmed cases compared to percent change in the last two weeks). According to the website, there were 596 active cases in Washington and Ozaukee counties on March 22, with a total case count of 21,434 cases and 220 total deaths.

Wisconsin is currently under a public health emergency, with Gov. Tony Evers issuing Executive Order 105 and corresponding Emergency Order 1, which is set to expire on April 5. Under the order, people over the age of 5 are required to wear face coverings whenever they are indoors or in an enclosed space, other than a private residence, and other people are

present in the same room or space.

In his statement that was released last Thursday, Schoemann said, "While the needs of public health, at the onset of a novel virus, took on additional weight and attention; so now, as the vaccine and mitigation strategies force the virus to recede, we must recalibrate to fully restore balance with economic, mental, spiritual, and social health needs that have been exacerbated by COVID-19. Just as we provided guidance to protect our vulnerable population and assist our hospitals, WOPHD will continue to support the community by providing testing and access to vaccine. WOPHD will continue to assist in reopening by providing recommendations to community members, businesses, civic and community organizations who feel so compelled to seek such guidance. We are here to serve you, the people of Washington County, not to tell you how to live and operate. As we move forward restoring Our Great Community, follow your conscience out of love for your neighbor and with personal responsibility."

COVID-19 testing is available Mondays through Fridays at the Ozaukee County Fairgrounds and Washington County Fair Park for qualified residents. To register, visit www.curative.com. More information about vaccine eligibility and availability can be at www.washozwi.gov.

To the voting citizens of the Town of Farmington,

For the first time in many years, there are two men competing for the town chair position in the town of Farmington. Chris Elbe, the incumbent, is facing competition from Doug Neuman. Elbe has been town chair for 10 years now and is seeking another two-year term.

Under Elbe's leadership, the township took on the responsibility of snowplowing its own roads several years ago. While it was a learning curve with older equipment in the beginning, the town has been able to upgrade to much newer, more modern equipment over the years. The snow plowing has gotten consistently better each year while also saving the town over \$100,000 annually in snowplowing costs from when they contracted the service out to a private company.

Secondly, under Elbe's guidance, Farmington became the first in the county to offer township-wide curbside garbage pick-up. Anyone who already had been paying for garbage pick-up service is saving money and for those who had no pick-up service, this is an economical way to get rid of garbage without having to burn it.

This service was offered with the hope that people will get rid of their garbage rather than throw their litter in the ditches. After seeing the success in our town, several other townships are looking into curbside garbage pick-up also.

With Elbe in charge of the town, things "get done." With him and his family working on their farm, they have equipment and tools readily available. Countless times, he has used his own equipment to get a job done with no cost to the town.

When the sheriff's department calls that a tree is down on a road, Elbe and his family take care of it. When a snowplow breaks down in the middle of the night, the driver goes to Elbe's farm shop and they fix the problem. This is something that is often taken for granted, but few understand how these "minor" is-

sues save the town money and downtime.

Finally, town chair Elbe did not take a paycheck the first few years he was in office. While he does get paid now, he makes a personal commitment to support the various organizations in the community. His family has been a long-time supporter of the Boltonville Fire Department by making a significant contribution to their Rain Days Picnic Fundraiser every year.

The Elbe family also recently made a significant donation to the Fillmore Fire Department to help purchase some farm rescue equipment. A few years ago, the Farmington recreational fund, a township sponsored fund that is used to help maintain the ball diamonds, was extremely low on funds. Elbe personally donated \$1,500 of his own money two years in a row to keep the fund afloat.

As you can see, Chris Elbe goes above and beyond the call of duty for the people of Farmington. With his "can do" attitude and his fiscally conservative ways, the town has been able to start expediting the repairing and resurfacing of the roads. While it's going to take quite some time to fix all the roads, the town of Farmington is headed in the right direction with Elbe in charge. Vote Elbe for chairman April 6th.

The Kewaskum Village Board voted on Tuesday, March 16, to extend the application deadline for the Kiwanis Pool supervisor position to March 30.

The village posted the position in February, but is still seeking an applicant, Village Administrator Matt Heiser told the board during last week's meeting.

According to the posting, it is a seasonal position, from June through late August/early September. The pool supervisor is responsible for day-to-day operations of the Kiwanis Park Pool, supervision of lifeguards and beach attendants. Qualified candidates must be able to become a certified pool operator.

Women of the Kewaskum area are kindly asked to assist with the sewing of 135 children's slippers for war relief in devastated countries.



said. At the service, John Koerble, commander of American Legion Post 384, gave the opening remarks and welcomed all those who were gathered. The Rev. Eric Kirkegaard, pastor of Peace United Church of Christ led the invocation and farewell prayer at the service.

Members of Manthei's family were recognized, with several sharing their memories.

Kathy Fellenz, Manthei's cousin, remembered Manthei as a "ray of sunshine, so happy-go-lucky smile, perfect."

Theusch also recalls Manthei's happy disposition, going back to his days as a student at Kewaskum High School.

"Jim had a sense of humor that the football team will remember. Every time the Indians would return from an away game and the team bus would cross the railroad tracks in the home stretch back to the high school, he would tell the same lame joke," Theusch said.

"Hey, how can you tell a train has just been through town? You can still see the tracks!" Manthei would joke.

"The fact is he did it so often that it became a disappointment if he didn't tell it. He got a lot of mileage out of that joke in a creative way and, win or lose, brightened up the team spirit in the process with laughter," Theusch recalled.

Theusch vividly remembers hearing the tragic news about Manthei being killed in Vietnam.

"When I was working at Scott's Station close to what then was Billy Edwards' Wigwam Restaurant and Dance Hall, Alan Bohn stopped by, came in and blurted out the terrible news in a sad deadpan way he had, 'Manthei was killed' - one of those times in life when you remember who, when and where you were when you got bad news," Theusch said.

James Manthei was born on May 23, 1950, to Willard and Anna Manthei. He grew up in Kewaskum and was an Explorer Scout and received the Eagle Award with the bronze and silver leaf. He was a member of the varsity football and basketball teams at Kewaskum High School and was active in the high school band.

Manthei graduated from Kewaskum High School in 1968. He went on to graduate from E.C.P.I. Computer School in Milwaukee in 1969 and was employed at Regal Ware, working in the finish department as a ware handler on the second shift.

He entered the service on Sept. 17, 1969. He completed a helicopter pilot course at the Army Primary Helicopter School in Fort Walters, Texas, following which he underwent advanced flight training at the Army Aviation School, Fort Rucker, Ala.

James Manthei is buried at Peace Church Cemetery on Highway 28, just west of Kewaskum.

The memorial service was held at the Wisconsin 9/11 Memorial because a portion of the memorial is dedicated to those who have served in the armed services. The memorial, which is located at 1308 Fond du Lac Ave. in Kewaskum, is slated to officially open to the public this summer.

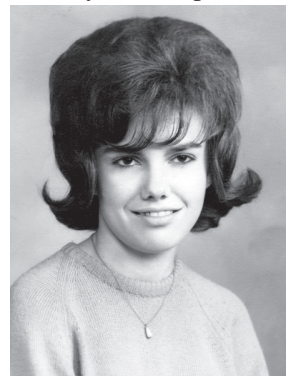

many years ago out in the country. There were weapons so the ATF was also called out to the scene. They quickly found out that it was the birthday of one of the ATF agents. Well, Campbellsport's hometown hospitality was quickly felt by that agent as local cake guru Alice Ketter heard this news.

"Two hours later, she came walking down the road with a cake," Melvin said. "I'll never forget that."

All three smiled while remembering that. They also mentioned that Alice's daughter has also helped the department out by bringing cookies for the firefighters to a lot of their calls.

All three agreed that the hardest calls were the ones in the middle of winter during frigid temperatures. You had to try to stay warm and keep the equipment from freezing.

They recalled a particularly tough call near St. Kilian in the middle of winter. It was probably the coldest call ever for the department.

"It was 32 below," Melvin said, almost 70 below with wind chill. "We were so close to being done and then everything froze up. If I could have got that open (the valve), we could have saved that house."

They explained that winter calls can be treacherous for firefighters but not for the reason you would think. Once the water gets flowing, it obviously freezes and causes very slippery situations for the firefighters and the water trucks going back and forth.

"Usually you call for salters and sanders to help," Tony said.

Barn fires seem to be down today from years ago. The brothers gave a few reasons for this fact. They said the lower number of farms and the decrease in storing hay in barns like they did in the past for the reason for this.

When they were called out to a barn fire, they knew it could be a long call. With hay in the barn, these fires could burn for a long time and need the fire department on the scene for quite a while.

"I remember going to a barn fire and being there for 24 hours," Tony said.

All three said they have had their surprises over their five decades. Melvin remembered one house fire where the fire flashed at him and a fellow firefighter as they opened a door in the house. He said that one surprised him and the fellow firefighter, both got a bit scared with that one.

"There's so much that goes through your mind in such a short time," Don said. "There is no such thing as a regular fire. They're all different and they all have their little quirks and surprises."

One thing they all agreed was on what was very important to firefighters in the past — response time. Especially when you had to rely on the siren to get you to a call.

"Response time was huge," Melvin said.

At that time, they also relied on everyone's knowledge of the area. There was no GPS to guide you to an address. They were mostly guided by the fact that back then they knew almost everyone in the area and where they lived.

As the department grew, they had fire trucks at the old village garage and a secondary garage further west on Main Street. They didn't know who was going to show up for a call back then, so they hoped they had enough personnel at both locations to man the trucks.

They all agreed that the pagers and alert system today helps with response time. This is important because the way houses are built today, they tend to go faster if there is a fire than in the past.

They also talked about all of the changes the department has gone through in the last 50 years. When the brothers joined the department, the trucks were kept in the old village garage on the corner of Main and Poplar Streets. The department only had three fire trucks at

that time.

"When I joined, there were three trucks and an ambulance," Don said.

No one had pagers at the time. They would listen for the siren to sound and know they had to get to the fire house because there was a fire. Eventually they started using pagers and now they can even get the calls with an app on their cell phones.

"The siren would blow," Tony said. "That's how we got everyone together. Back then you didn't know what the fire would be (no pagers to give them the information ahead of time)."

All three also worked with the ambulance. According to the brothers, the early ambulances were basically large station wagons. Members also didn't have to have the extensive training the EMTs need today.

"The only thing I had to have for ambulance duty was advanced first aid," Tony said.

If you had ambulance duty back then, you had to stay very close to home. You had to be close to a phone so they could call you about a call. This was before cell phones, so someone always had to be in the house to listen for the phone to ring just in case.

"When we took ambulance duty back then, there were no pagers," Tony said.

All three said they mainly helped drive the ambulance. As more training and more procedures were needed for the ambulance crew, they all left the ambulance part of the department. Though they all had their turn in the back with a patient at one time or another.

In 1993, all three along with the rest of the department, helped build the new fire station. They had more than grown out of the two locations where fire department equipment and trucks were being stored.

"Everyone really worked together on that," Melvin said.

Don served as the fire chief for five years. Tony and Melvin were each captains with the department for many years. Neither of them wanted the position of chief like their brother.

"That was enough for me, taking a weekend," Tony said of being in charge for weekend while the chief was gone at one point.

They all admit that you may not find many 50-year members in the future. The time constraints on people today is much more than in the past. Firefighters today are more busy with other things, especially activities with their children.

The training that is required now to be a firefighter is a lot greater than it was in the past. Time needed away from home for this is a lot.

"It's taking so much of your personal time," Tony said.

Don added, "The average for a person to stay with the fire department now is five years."

They also mentioned the way they have to leave at a moments notice when called. That can be hard for some people to do.

"How many of us just up and left," Tony said about calls.

Melvin added, "We just did it."

The three laughed about a house fire on Christmas. The entire family was at Don's house for the holiday and they were just about to sit down for Christmas dinner when they were called about — about 11:30 a.m. They laughed that half of the family members there for Christmas all got up and left to report to the fire.

Today, all three assist where they can with the department but they are no longer the ones running into a building or on the front lines of the fire anymore. Tony talked about driving the water truck to keep water coming to the fire in Eden recently at Guelig Waste Removal.

"There are so many other jobs to be done," Tony said. "That's why you keep doing it too. It keeps you active. It keeps your mind young."

All three said it is their love for their community and their fellow firefighters that has kept them on department for five decades. They knew they were doing what they could to help and the community has supported the department in that mission too. They are all very proud of the Campbellsport Fire Department.

"I never regretted a day, never," Melvin said.

"It's just the commitment to the community," Don said. "I always said we (CFD) don't take a back seat to anybody. We're not perfect, but we're right up there."

"I wanted to do something," Blake said. "We're close to all of the family."

Last year, he thought about changing the number of his car but it was too close to the racing season. So this year, Blake decided to make the change.

Blake's car number is now 47, which was the number Kenny used for his baseball uniform.

"He played in college and he was really good," Blake said. "He was my baseball coach."

Blake enjoys racing and carrying on the family tradition. He is especially excited for this season as he pays tribute to family friend Kenny Immel.

Washington County Sheriff's Deputy Cleared Of Charges

A Washington County sheriff's deputy has been cleared of any charges in the fatal shooting of Nicholas S. Pingel, who is accused of killing two men in the Town of Kewaskum on February 3.

The Wisconsin Department of Justice identified the deputy as Lee Goodman, a nine-year Washington County law enforcement veteran.

Goodman's actions were cleared as justifiable homicide by Washington County District Attorney Mark Bensen last week, according to the Washington County Sheriff's Office. Bensen determined that Goodman, who was on duty at the time of the incident, was acting within the scope of the law by protecting himself and others when he used deadly force.

An autopsy revealed that Pingel, 30, died as the result of a law enforcement round. Following the incident, Goodman was placed on administrative leave as a standard protocol pending the outcome of the independent investigation. He returned to duty last week, according to the Washington County Sheriff's Office.

"Our deputy was placed in a situation that necessitated the use of deadly force in the course of his work to safeguard the community he took an oath to protect. This entire incident is a tragedy on many different levels. The fact that the district attorney determined the deputy's actions were clearly nec-

essary, justified and authorized under law, reaffirms the deputy stopped further victimization of innocent citizens that afternoon," Washington County Sheriff Martin Schulteis stated on March 17.

Pingel, who was a West Bend resident, is accused of shooting and killing 72-year-old Ray Engelking and 77-year-old Carl Halvorsen.

An independent investigation of the incident was conducted by the Wisconsin Department of Justice - Division of Criminal Investigations.

According to the Washington County Sheriff's Office, Goodman was responding southbound on Forest View Road from County Highway H to the initial scene that afternoon at approximately 3:05 p.m. At that point, Goodman knew he was responding to a "shots fired" altercation. Before he arrived at that scene, he saw Pingel standing along the east side of Forest View Road about 0.6 mile north of the first crime scene. Pingel was armed with a shotgun, according to Schulteis.

This location was later determined to be the scene of the second homicide victim where Halvorsen's shotgun was stolen, and where Pingel subsequently murdered Halvorsen, according to Schulteis.

According to a statement Schulteis released last week, as Goodman, who was in uniform, approached in his fully marked squad car, Pingel leveled the stolen shotgun at Goodman and fired one round. The round did not hit

the Goodman or the squad car. Goodman quickly backed his squad car in a northern direction around a curve in the roadway to establish a north perimeter, out of Pingel's view, in an attempt to deescalate the incident. Goodman then got out of his squad car and positioned himself behind the engine block of his squad with his rifle as he began to coordinate a response. As additional units arrived, Pingel, who still had the shotgun, rounded the corner in the road. Commands were given for Pingel to drop the gun, and he once again decided to escalate the situation by shouldering the weapon and pointing it at the deputies.

There was an exchange of gunfire from about 120 yards, and Pingel was hit with one fatal round in the chest. Goodman shot first during this second altercation. Life-saving measures on Pingel were not immediately started since the deputies lost visual contact with him after the second exchange of gunfire, and were unsure if the suspect was hit, or still posed a danger. The deputies maintained their perimeter position to contain the scene until the suspect was located, deceased, with a drone.

"Our office will conduct our own independent internal investigation and tactical debrief to determine what we could have improved on; we owe that to the community we serve. Having said that, all facts point to the unfortunate reality

In Memory of...

On March 5, 2021, the Kewaskum community lost someone who was a great advocate for kids. Mr. Jerry Gosa passed away from COVID-19-related pneumonia for almost two months.

Jerry was a long-time teacher at Kewaskum High School — teaching for 38 years. He was also a long-time track and field coach for both the high school and middle school teams, having been the head boys and girls coach for 25 years.

I was fortunate to have worked with a veteran teacher and coach like Mr. Gosa, especially in my early years as an athletic director for the high school. We, together, started the Kewaskum Track & Field Invitational many years ago, when we got our rubberized track. Over that time, we have also hosted conference and Washington County meets, plus WIAA Regionals and Sectionals.

While Jerry leaves a long legacy through his wife and family, he also leaves a remarkable one beyond his teaching and coaching. Jerry helped found the Kewaskum Youth Scholarships organization, better known as KEYS. Jerry was a long-time president of

the organization and during my time here in Kewaskum they surpassed the one million dollar and two million dollar marks in assets.

They have awarded over \$2 million in scholarships to KHS students to help further their educations. This is a remarkable feat and Jerry was always able to tell a story about the awarded scholarships at the KEYS ceremony each spring.

On top of that, Jerry was also a key player in Kewaskum obtaining the portion of a steel beam from the World Trade Center and our Village being named the site of the Wisconsin 9/11 Memorial.

Jerry's passing made me reminisce about another community member. Mr. Larry Ammel passed away four years ago, on Easter Sunday. I never had the chance to teach with Larry, but became a friend of his through his involvement in the community with the serving on the Village Board and directing music at Peace United Church of Christ for over 30 years.

Larry was a long-time band director

WIAA Alternate Fall Season Culminating Events Planned

The Wisconsin Interscholastic Athletic Association is planning culminating championships and tournaments for an alternate fall season created by the Board of Control last August as a COVID-19 accommodation for member schools opting to not conduct interscholastic athletics last fall.

The boys and girls volleyball tournament series will culminate with championship matches Saturday, April 17, at Kaukauna High School. The girls tournament features two divisions, with the Division 2 championship match at 1 p.m. and the Division 1 match at 7 p.m.

The state semifinals will be held Thursday, April 15, at two locations to be determined. The one-division boys state tournament will only have a championship match, which will be held at 4 p.m. There are 116 girls programs opting into the alternate fall tournament series and 16 boys programs.

There will be two divisions of boys soccer for the alternate fall season tournament series. The state tournament will consist of two semifinals and a championship game for both divisions held on Saturday, May 15, at two locations to be determined. There are 85 boys soccer programs that have declared to partici-

pate in the tournament this spring.

The one division of the girls golf championships are scheduled for Monday-Tuesday, May 17-18. The site of the event has not been determined. There are currently 38 girls golf programs declaring for one division in the alternate tournament series this spring.

The football fall alternate season includes a seven-week, regular-season schedule of games beginning with first allowed contest slated for March 24. There are currently 127 programs that have declared anticipating to play in the alternate fall football season this spring, including 113 in 11-player and 14 in 8-player.

Planning for the alternate fall tournament series is ongoing with details of seed meetings, as well as regional and sectional competitions to be forthcoming when available and will be posted on the WIAA website on each respective sport's Tournament page.

The WIAA, as defined by its Constitution, is a voluntary, unincorporated, and nonprofit organization. The membership oversees interscholastic athletic programs for 515 senior high schools and 48 junior high/middle level schools in its membership.

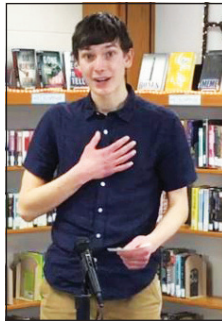

Face Masks Required In Kewaskum Schools For Remainder Of School Year

The Kewaskum School District will continue to require face coverings to be worn in school buildings for the remainder of the 2020-2021 school year.

The school board discussed vaccination and continued mitigation updates at the March 11 board meeting, with all members agreeing that face coverings should be required for the remainder of the school year. Board President Jim Leister said that he put the item on the agenda because board members had requested that the topic be discussed.

"One of the reasons we had it put on [the agenda], and I talked to all the board members, is that we wanted to make sure everyone understands that we are going

to stay with what we are doing. We have 53 more days to get to the finish line," Leister said at the March 11 meeting. "What we have done, and what the administration has done, has succeeded. We're not changing it. But if we had to change something tonight, the board has the flexibility to give the administration the latitude they need."

About 100 people attended the meeting, and several people spoke about the mask requirement during the public comments portion of the meeting.

"I have had three of my employees here in Washington County who have lost a parent to covid. Two of those employees of mine have school-aged children. Those grandparents won't be there to watch them graduate, they won't be there to watch them get married. We are getting close to the end; we have a vaccine. I know people don't like masks. I know it's not fun. I know it's not enjoyable to be in this situation. We are in the fourth quarter here, we're on the 10-yard line, down by six. There's a minute left on the clock. Push all the way to the goal, it's not time to fall back and punt. Hang through it, wear your masks, take care of social distancing, try and save as many people as we can so we don't lose more of these grandparents. Pretty soon everyone who wants to be vaccinated can, and we can get out of this. We just got to hang on for a couple more months," Trevor Owen said during the public comments.

"Let our district be an example to our students, our community and our state," said Angie Petersen, a teacher at i4Learning Community School. "Mask up and focus on communication and cooperation."

"Please keep our students and staff safe by keeping the mask mandate. Our school has stayed open. Our students have been able to participate in school. Our teachers have stayed healthy. And I feel it is because we are wearing masks. The pandemic is not over. Why would you want to change the procedures that are changing now?" commented Carol Gonwa, Kewaskum Middle School building secretary.

However, not all of the public comments were in favor of keeping the mask mandate.

"I am here tonight to ask the board to consider removing all mandatory restrictions related to COVID-19, including the use of fear mongering propaganda on our children. I am not asking that no one be allowed to wear a mask or social distance themselves, I am just asking that the decision be put back in the hands of the individuals or family," said Nate Weseman, father of three in the district.

The board has discussed mitigation efforts at several board meetings throughout the year. At this month's meeting, each of the board members voiced their opinions on the topic.

"I felt strongly that we should continue to do what we are already doing," Board Member Stephanie Bird said. "I am hoping that by continuing the masks we can continue the in-person learning."

"With the 53 days left, we might as well keep progressing forward. It is working," Board Member Sue Miller said.

"For me, it is kind of a practical decision, whether you believe in the science of the masks or the psychology of the masks, it has worked," Board Member Ric Leitheiser agreed.

"We only have a few days left in the school year. I wouldn't want to upset that train as we go forward," Board Member Doug Gonring added.

"I would agree to continue as we have to finish out the year," Board Member Dennis Aupperle said.

"We are a team of seven and we should all be rowing the boat the same way in this matter as well," Board Member Tim Ramthun said about the board's decision on requiring face coverings in Kewaskum schools.

Ramthun added that he shares many of the concerns about wearing masks that were mentioned in the public comments. However, he said that he also has to look at the big picture, and there are employees who have

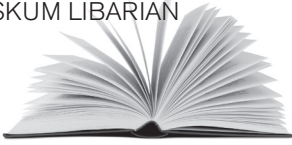

NOTICE IS HEREBY GIVEN that the Board of Review for the Town of Kewaskum, Washington County, Wisconsin shall hold its first meeting on the 5th of May from 5:30pm to 7:30pm at the Town of Kewaskum Community Center, 9019 Kettle Moraine Drive, Kewaskum, WI 53040.

Please be advised of the following requirements to appear before the board of review and procedural requirements if appearing before the board:

1. *No person will be allowed to appear before the board of review, to testify to the board by telephone, or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the assessor to enter onto property to conduct an

exterior view of such property being assessed.

2. After the first meeting of the board of review and before the board's final adjournment, no person who is scheduled to appear before the board of review may contact or provide information to a member of the board about the person's objection, except at a session of the board. Open book shall occur no less than 7 days prior to the board of review.

3. The board of review may not hear an objection to the amount or valuation of property unless, at least 48 hours before the board's first scheduled meeting, the objector provides to the board's clerk written or oral notice of an intent to file an objection, except that upon a showing of good cause and the submission of a written objection, the board shall waive that requirement during the first 2 hours of the board's first scheduled meeting, and the board may waive that

requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days with proof of extraordinary circumstances for failure to meet the 48-hour notice requirement and failure to appear before the board of review during the first 2 hours of the board's first scheduled meeting.

4. Objections to the amount or valuation of property shall first be made in writing and filed with the clerk of the board of review within the first 2 hours of the board's first scheduled meeting, except that, upon evidence of extraordinary circumstances, the board may waive that equipment up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days. The board may require objections to the amount or valuation of property to be submitted on forms approved by the Department of Revenue, and the board shall require that any forms include stated valuations of the property in question. Persons who own land and improvements to that land may object to the aggregate valuation of that land and improvements to that land, but no person who owns land and

improvements to that land may object only to the valuation of that land or only to the valuation of improvements to that land. No person may be allowed in any action or proceedings to question the amount or valuation of property unless the written objection has been filed and that person in good faith presented evidence to the board in support of the objections and made full disclosure before the board, under oath, of all of that person's property liable to assessment in the district and the value of that property. The requirement that objections be in writing may be waived by express action of the board.

5. When appearing before the board of review, the objecting person shall specify in writing the person's estimate of the value of the land and of the improvements that are the subject of the person's objection and specify the information that the person used to arrive at that estimate.

6. No person may appear before the board of review, testify to the board by telephone, or object to a valuation if that valuation was made by the assessor or the objector using the income method of valuation, unless the person supplies the assessor with all the

information about income and expenses, as specified in the assessor's manual under s.73.03 (2a), Wis. Stats., that the assessor requests. The Town of Kewaskum has an ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph that provides exceptions for persons using information in the discharge of duties imposed by law or the duties of their officer or by order of the court. *The information that is provided under this paragraph, unless a court determined that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35(1), Wis. Stats.

7. The board shall hear upon oath, by telephone, all ill or disabled persons who present to the board a letter from a physician, surgeon, or osteopath that confirms their illness or disability. No other persons may testify by telephone unless the Board, in its discretion, has determined to grant a property owner's or their representative's request to testify under oath by telephone or written statement.

8. No person may appear before the board of review, testify to the board by telephone, or contest the amount of any

assessment unless, at least 48 hours before the first meeting of the board, or at least 48 hours before the objection is heard if the objection is allowed under s.70.47 (3) (a), Wis. Stats., that person provides to the clerk of the board of review notice as to whether the person will ask for the removal of a member of the board of review and, if so, which member, and provides a reasonable estimate of the length of time the hearing will take.

that the tragic outcome was dictated by the suspect rather than the law enforcement response. The deputy acted with courage and bravery. The actions he took were consistent with his training, and in accordance with the law, while facing extreme stress and danger. I welcome the deputy back to serve the citizens of Washington County," Schulteis said.

Pingel, who was released from prison on December 1, 2020, struggled with substantial mental health issues and displayed signs of extreme paranoia in the weeks leading up to the February 3 incident, according to the Washington County Sheriff's Office.

"The tragic sequence of events that afternoon has left a lasting impression on both our community and agency; I keep the families affected in my thoughts and prayers," Schulteis said.

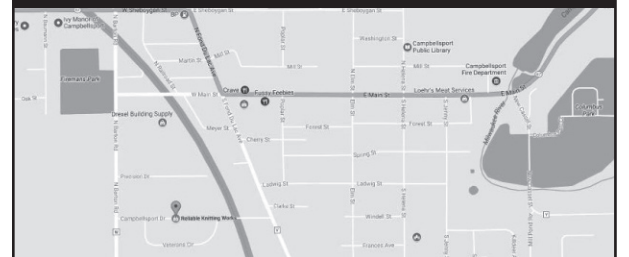
