Kewaskum Village Administrator Resigns

After serving as the village administrator for the Village of Kewaskum for 13 years, Matt Heiser has resigned from the position to accept a job as village manager for the Village of Harrison.

"It is with a mixture of excitement and sadness that I announce my resignation to you," Heiser wrote in his resignation letter to the Kewaskum Village Board. "While I am excited to serve the Board and people of Harrison, I am also sad to finish that role here in Kewaskum. I thoroughly enjoyed serving the people of this wonderful community."

The Kewaskum Village Board accepted the resignation at the regular board meeting on Monday, May 17. Heiser's final day as Kewaskum village administrator will be June 18.

The board directed staff to post the job opening immediately. At Monday's meeting, the board discussed options for filling the position. The board discussed the likelihood of hiring an interim administrator to serve the village until a permanent administrator is chosen.

Ultimately, the board decided to hold a special meeting once costs have been determined for going through another agency, such as GovTempsUSA, to fill the position. No final decisions were made Monday night as to how the position would be filled.

During Monday's meeting, Village President Kevin Scheunemann thanked Heiser for his years of service.

"Over the six or seven years, he has really helped preside what I call the Golden Age of the village. Not only did we fix the TIF district, we got a 30-acre park donation but we also got the 9/11 Memorial done," Scheunemann said. "Not only are we going to lose Matt Heiser as the village administrator, but it is his civic involvement that is going to be the biggest loss in the community."

"I can't list any of these as my personal accomplishments. They were all team efforts with Board leadership, staff dedication and volunteer energy," Heiser responded.

Campbellsport School Board Leaves Mask Mandate Until Summer School

Members of the Campbellsport Board of Education decided to leave the mask mandate in place until the end of the regular school year. For summer school, masks will be optional, but not required.

"The original motion for the mask mandate was only through this school year," said Deb Senn. "We can re-look at summer school. I'm concerned that if we are to remove the mask mandate now, we will just create a whole lot of confusion and there are only nine days left. I

think we can reconsider summer school."

Most of the board members agreed for the same reason. With only nine days of school left (at meeting time), they felt it would be better to leave the mandate in place to finish the school year.

"One thing that someone brought up to me was 'why don't we finish the year strong,'" said Sharon Gazzola. "We don't want kids getting bullied for keeping a mask on. I feel like, my personal opinion, is leave it for the last nine days. I

Masks Are Now Optional In Kewaskum Schools

Masks are no longer required in Kewaskum School District facilities.

The Kewaskum School Board unanimously voted on Thursday, May 13, to make masks optional and to no longer follow Washington Ozaukee Health Department guidelines. The board's vote was received with a standing ovation from about 50 parents who attended the school board meeting.

Board member Timothy Ramthun was absent from last week's meeting. Ramthun had made a motion to no longer require masks on school grounds at the regular board meeting in April,

but the measure was voted down at that time.

Earlier that day, the U.S. Centers for Disease Control and Prevention (CDC) announced that in most cases, people who are fully vaccinated no longer need to wear masks or socially distance. However, the CDC still recommends that masks be worn in schools.

However, dozens of other school districts across the state also do not require face coverings to be worn in school facilities, including Waukesha School District, where the mask mandate was dropped on May 12.

Parents have spoken at Kewaskum School Board meetings over the past several months,

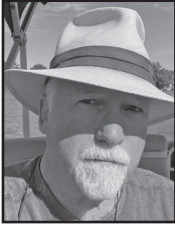
How would you like to die?

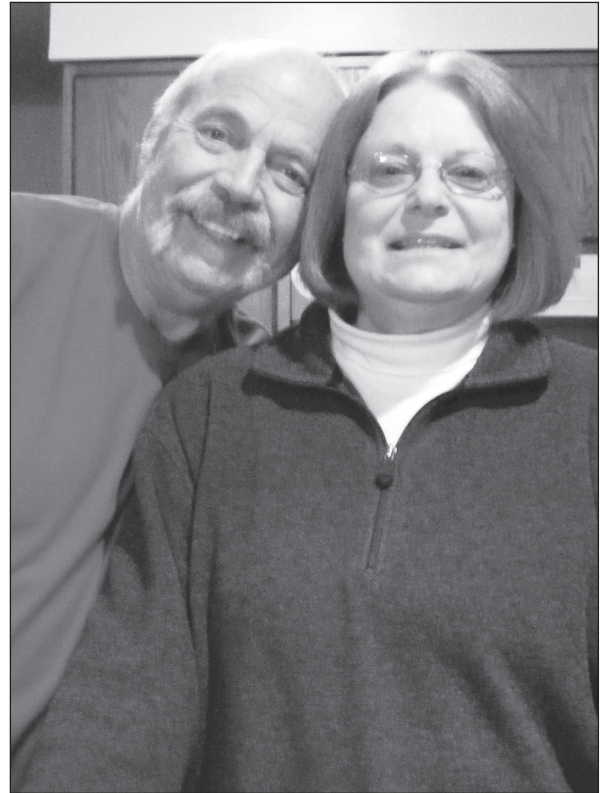

Wisconsin Offering COVID-19 Vaccinations To Children Ages 12-15

The Wisconsin Department of Health Services (DHS) announces that children 12-15 years old are now eligible to receive the Pfizer COVID-19 vaccine and vaccinations can begin starting Thursday, May 13. The Pfizer COVID-19 vaccine requires two doses for full protection and is the first and only vaccine available for this age group.

“This pandemic has been tough on everyone, but I know it has been especially hard for our kids,” said Gov. Tony Evers. “Now with a COVID-19 vaccine available for the first time, we can offer our children protection against the virus. Whether they are at school, playing ball with their friends, or taking a family vacation, vaccinating your kids means they can get back to doing the things they love while also staying safe and healthy.”

After successful clinical trials and a rigorous review of all available data, the U.S. Food and Drug Administration (FDA) authorized Pfizer’s request to expand the emergency use authorization (EUA) to include adolescents ages 12-15. On Wednesday, May 12, the Centers for Disease Control and Prevention’s (CDC) Advisory Committee on Immunization Practices (ACIP) confirmed the vaccine is safe and voted to rec-

ommend the vaccine to the age group.

“Our nation’s leading medical experts deemed the Pfizer vaccine safe for this age group, and the initial data shows the vaccine is 100 percent effective in preventing COVID-19,” said DHS secretary-designee Karen Timberlake. “This is a game changer — especially as we are experiencing an increase in cases, hospitalizations, and reports of long-term symptoms in younger people. We are asking parents and guardians to get their children vaccinated as soon as they can.”

Parents and guardians of children ages 12-15 can schedule a vaccination using a variety of options, including with their health care provider, at community-based vaccination clinics, local and tribal health departments, or pharmacies. 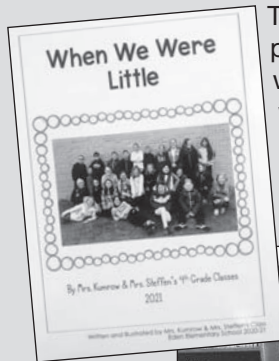
Paige Gitter, and many others.

would be open to changing it for summer school. I think there are some other things you could stir up if you changed it now.”

Two parents spoke at the beginning of the meeting knowing this was on the agenda.

Calyn Strobel stated that she understood there was only a short time left in the school year but asked the board to consider lifting the mandate for summer school.

“I’m really hoping, for summer school, you really consider masks optional,” she said. “It’s been really hard on these kids inside and outside of the school with these mask mandates.”

Julie Skelton asked the board to keep the mandate at least until the end of the school year, which is May 28th. She brought up all the events and activities happening in the next two weeks that will bring a lot of people into the schools — graduation, kindergarten graduations, grade promotions, art show, etc.

“I am here to talk about the mask mandate that is listed on the agenda,” Skelton said. “I am asking that you leave the mask mandate for the rest of the school year. There are only nine days left. Nine days, truly a miniscule amount of time. If you lift this mandate, you are inviting hundreds of people into the buildings maskless.”

Because in February the board approved leaving the mandate in place through the end of the school year (May 28th) they did not have to take any action to leave the mandate in place. Mike Weiss did make a motion to get rid of the mandate but no one seconded the motion.

The board then approved lifting the mask mandate starting with summer school. It was a 6-1 vote with Danielle Neitzel voting against lifting the mandate.

After the meeting, Neitzel said, “My reasoning for voting no is that the motion was to make masks optional for summer school, however there was nothing to indicate if we would follow the other protocols, like social distancing in classrooms, to try and still mitigate the spread of COVID or any other viral activity.”

In other business, Amundson told the board that the Fond du Lac County Health Department reached out to see if they could hold a vaccine clinic in the school. With the Pfizer vaccine approved for children ages 12 and up, the department wanted to work with the school.

With the end of the school year so close, Amundson explained that they couldn’t figure out how to get this done while school was still in session. They did offer a different option.

“The school was given the opportunity from the county health to set up a vaccine clinic the last week of school,” Amundson said. “We just felt it was too late and too disruptive for that. We did offer to the county our facilities if they would want to offer a clinic in the summer.”

Board members approved waiving student fees for the 2021-2022 school year.

The board also approved the formation of a safety and transportation committee.

“I see a lot of benefits to this,” said Maureen Koch. “We’ve faced a lot because of COVID, we shouldn’t let that drop. I also like the way the communication with our community is part of the safety committee. I think it could be beneficial. It can always be disbanded again, it was once before. But, I think things in the world have changed and the safety side of it would be good.”

Board members approved the formation of the committee on a 6-1 vote, with Deb Senn voting no.

requesting that the school district drop the mask mandate. The board had repeatedly decided to not change the policy.

“This was the right time to change the policy,” Board President Jim Leister said on Sunday.

Since Thursday, Leister has heard from dozens of community members about the decision. He said that he has received nothing but positive comments about the board’s decision.

At last week’s meeting, several people spoke during the public comments portion of the meeting, requesting that the district end the mask mandate.

“Kewaskum has to stand up for freedom, it is enough. No more masks. It is unconstitutional. It is child abuse,” community member Mike Koepke said.

A parent in the district, Nate Weseman, presented a petition to the board with 250 signatures collected over the past week to end the mask requirement for this school year.

“This is about being able to have a choice,” Weseman said.

While the majority of schools across the country have not offered in-person instruction for at least a portion of the past academic year because of the COVID-19 pandemic, the Kewaskum School District has remained fully open for in-person learning throughout the 2020-21 school year.

Teachers in Wisconsin have been eligible to receive the covid vaccine since March 1. Last week, anyone 12 years and older was eligible for the vaccine.

The Kewaskum School District partnered with the Washington Ozaukee Health Department to offer vaccinations at the i4Learning Community School in Wayne on Saturday, May 15.

Following last week’s CDC announcement, some municipalities across the country loosened their restrictions. By Saturday, large stores such as Walmart, Costco and Trader Joe’s had announced that people who are fully vaccinated no longer were required to wear masks in the stores located across the country. Locally, Geidel’s Piggly Wiggly followed the new CDC guidelines and no longer required customers who are fully vaccinated to wear masks in the store.

Find Your Adventure During Free Fun Weekend

The Wisconsin Department of Natural Resources is hosting the 9th annual Free Fun Weekend June 5-6. Park admission fees, fishing licenses and trail passes will be waived for Wisconsinites to find their adventure outdoors.

“We truly have something special here in Wisconsin, especially when it comes to outdoor recreation opportunities,” said DNR Secretary Preston Cole. “Explore a state park, hit the trails or try your hand at fishing. There’s no better time to get out and explore what Wisconsin’s outdoors has to offer.”

Wisconsin is home to 49 state parks, 15 state forests, 44 state trails, 84,000 miles of rivers and streams, roughly 15,000 lakes and so much more.

Before heading to a state park, trail or waterbody near you, here are some helpful things to know:

State Parks

Admission stickers will not be required.

All state parks will be open from 6 a.m. to 11 p.m.

Drive-up windows, playgrounds, bathrooms and observation towers are open.

Stand-alone concession facilities are open to the public at 50 percent capacity.

Office buildings, visitor centers, enclosed shelters and nature centers remain closed until further notice.

Adaptive rental equipment at state park properties is unavailable until further notice.

Due to high demand during peak seasons, some properties may reach their pre-determined capacity limits. When this happens, properties will

close until existing visitors leave, and capacity is reduced.

Trails

Trail passes will not be required for both residents and non-residents.

All linear/rail trails will be open to the public, including ATV trails and horseback riding trails.

Fishing

Residents and non-residents will not be required to have a fishing license or trout/salmon stamps.

All 2021-2022 fishing regulations apply, including bag and length limits.

Due to COVID-19 precautions, loaner equipment will not be available. Anglers should bring their own equipment and bait.

Events such as fishing clinics have been canceled.

Locate launches and shorefishing access points near you.

Boat Launches

All DNR boat launches are open.

Boats must be registered, which can be done either online or via mail.

Minimize the spread of aquatic invasive species by removing plants and animals from boats before and after launching, draining all water from compartments, and never move live fish from any waterbody.

Safety

Wear a life jacket at all times when fishing from a boat, kayak, canoe or paddleboard.

Use boat lights after sunset.

Never consume alcohol or drugs before or during an ATV ride or while operating a boat.

Wear a helmet and protective clothing such as eye protection, gloves, long pants, and a long-sleeved shirt while riding an ATV.

All children under the age of 18 must have a minimum Department of Transportation standard motorcycle or ATV helmet — bicycle helmets are not legal.

Keep your speed in mind as weather and terrain conditions vary or change.

Free Fun Weekend is a wonderful way to enjoy the outdoors. Participants are encouraged to join the Wisconsin State Parks’ OutWiGo initiative. Make sure to tag your Free Fun Weekend photos with #OutWiGo.

Reaching Above And Beyond

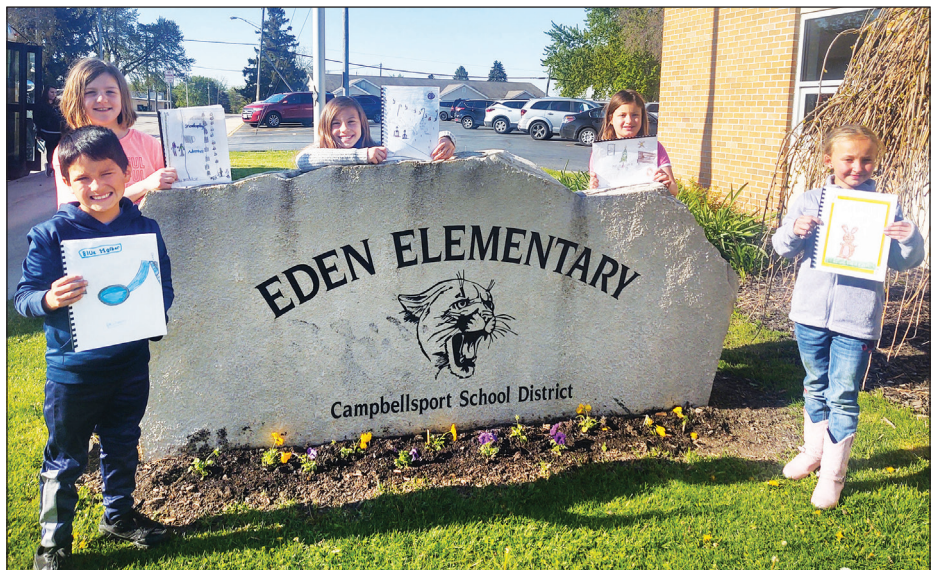
As part of the third grade writing program at Eden Elementary School, students spent three weeks working on personal narratives from their daily free writes.

Washington County Sheriff's Office Reports

Fugitive Captured

Dmonte Williams, 27, was arrested by the U.S. Marshal's Fugitive Task Force and a Washington County sheriff's detective on Thursday, May 13, in the City of Milwaukee without incident. He was wanted by Washington County authorities since December of last year for his alleged involvement in a home invasion robbery in the Village of Richfield last October.

Cheryl Bodoh, 52, of Richfield pled guilty and was sentenced in March to eight years in prison for her involvement in the incident.

The victim, an 85-year-old woman, was home alone on the morning of October 23. Two masked individuals believed to be Bodoh and Williams entered the house through a rear patio door. It is alleged that Williams started pushing the victim in her wheelchair toward the basement stairs until Bodoh stopped him just before reaching the stairs, fearing that he was going to push her down them.

Bodoh stole a bag of jewelry from the victim's bedroom while Williams took the victim's cell phone; they then fled the area. The victim was not physically injured in the incident.

Washington County sheriff's investigators recovered some of the stolen jewelry after executing a search warrant at Williams's residence in the City of Milwaukee several days after the incident.

Williams has been charged in Washington County Circuit Court with one count of felony burglary (with a person present) with an additional enhancer for elder abuse. He remains in custody at the Washington County Jail.

The Washington County Sheriff's Office would like to extend its gratitude to the United States Marshal's Office Fugitive Task Force and the Milwaukee Police Department for their assistance in this case, which led to the arrest of this dangerous fugitive. The department also would like to recognize FOX 6 News for profiling Williams on its "Wisconsin's Most Wanted" segment and all the community members who stepped up and responded with information. This type of community collaboration allows the sheriff's office to be successful in fulfilling its mission.

Child Sex Offender

Washington County sheriff's investigators arrested a 29-year-old

man on Tuesday, May 11, on numerous felony child sex offenses after serving a search warrant at his residence in the Town of Germantown.

Washington County sheriff's investigators received information from the Internet Crimes Against Children Task Force (ICAC) indicating that unlawful images had been downloaded at a specific residence in the Town of Germantown, at which point an investigation was opened. Investigators learned a 29-year-old man, who recently changed his name, resided at the residence and was wanted out of the State of Louisiana on several felony counts of bank fraud and theft.

Washington County sheriff's investigators, with the assistance of personnel from the Wisconsin Division of Criminal Investigation, executed the search warrant on Tuesday morning. Over 1,500 videos and images of sexually explicit material involving underage victims were located on the initial screening of the suspect's electronic devices. Investigators uncovered that the suspect had been engaging in an online relationship with a 12-year-old boy who lived in another state for the past five years. This relationship started when the two would play video games together and progressed to an online sexual relationship over a several-year period. In the beginning, the suspect even developed false social media accounts posing as young females to obtain explicit images from the victim. During this relationship, there were well over 1,000 explicit videos and pictures exchanged between the two. They had plans to meet in person on July 5.

The suspect appeared in Washington County Circuit Court on Wednesday and was charged with 10 counts of possession of child pornography. He appeared before Judge Poulos and received a \$150,000 cash bail. He remains in custody at this time. The Washington County Sheriff's Office is not releasing his name at this point as more charges relating to child enticement will be filed. Upon the completion of this case, he will be extradited to the State of Louisiana.

Washington County Sheriff Martin Schulteis would like to use this case to demonstrate the importance of a parent's involvement in their children's online activities.

"The sad reality is that there are

predators out there who victimize the vulnerable. This case illustrates the classic grooming behavior that the predators deploy on their victims. This started as an online gaming relationship that transformed over time into a dangerous sexual relationship. These predators are master manipulators and over time they gain the trust of the vulnerable and exploit them. We implore all parents to be active and involved in their children's online activities. Finally, I am grateful that there is an entire ICAC network that works cooperatively every day to ensure these dangerous predators are brought to justice; I am proud that our agency is part of the ICAC Task Force. People like this do not belong living alongside us in our communities and, thankfully, he no longer will be," Schulteis said.

Pursuit

A 34-year-old City of Milwaukee man remains in custody in the Washington County Jail and is facing charges of fourth offense OWI, OWI causing great bodily harm, fleeing and first degree reckless endangering safety charges after an incident that began in the Town of Polk on May 9.

A Washington County sheriff's deputy on patrol observed a car parked on the side of State Highway 60 near Hillside Road in the Town of Polk around midnight with their hazard lights on.

The deputy stopped to see if the motorist needed any assistance. Upon making contact, the deputy saw that the driver appeared to be passed out in the lap of an adult female passenger. A second deputy observed a 1-year-old who was sleeping, lying down in the backseat of the car, unrestrained.

Deputies also learned that the driver was wanted by the United States Marshal's Office on outstanding weapons charges and had several prior OWI convictions.

Deputies re-approached the car and asked the driver to step out of the car. The driver refused and immediately fled in the car at a high rate of speed.

Based on the fact that there was a small unrestrained child in the car as well as another passenger, the deputies made the immediate decision to not pursue the car in hopes that the driver would slow down and reduce the risk to the passengers. A deputy that was in the area

observed the suspect vehicle traveling at around 100 mph, even though police were not chasing him. As the suspect vehicle entered the Village of Jackson on State Highway 60, the suspect failed to negotiate a roundabout and crashed into a marshy area. The suspect then fled the car on foot, leaving his passenger critically injured in the car, as well as the unrestrained infant.

An arriving deputy was able to deploy one of the agency's drones just minutes after the crash and quickly located the suspect by utilizing the drone's infra-red technology.

The suspect still refused to comply and come out of the marsh. With assistance from the Germantown Police Department K9 Unit, the suspect eventually surrendered without further incident to sheriff's deputies.

The female passenger and her infant son were transported by Jackson Rescue to a local hospital. The infant was uninjured and was released from the hospital. The adult passenger remains hospitalized with serious injuries as a result of the crash.

The car crash remains under investigation by the Village of Jackson Police.

Washington County Sheriff Martin Schulteis spoke about the important decisions that his deputies encounter on a daily basis and how appreciative he is of their efforts.

"In this case, the deputy was stopping out to do his job and provide help to someone in need, and moments later they are having to make split-second decisions based on the information they have at the time; the decisions they make have the potential to have long-lasting repercussions," Schulteis said. "These officers recognized the need to mitigate the risk to the passengers, especially an unrestrained baby, and not push this suspect to drive any more reckless than he already was, even if it meant allowing him to temporarily escape. They monitored the suspect from a safe distance, which allowed them to render aid to the injured shortly after the crash and utilized technology to quickly locate the suspect. In the end, the suspect's actions alone showed utter disregard for precious human life, including a defenseless child. He will now face the consequences."

5 Years Ago

May 26, 2016

Four men from Kewaskum who died during the Vietnam War will be remembered when Memorial Day is observed May 30. Two of the men, E. James Fickler (21) and James Manthei (20), were listed on the Vietnam War Memorial Wall. The other two, Clifford Bales (22) and Charles Dreher (31), died while serving during the Vietnam War era, but they were not killed in Vietnam.

Clarissa Justmann, a trooper for the Wisconsin State Patrol, talked about her friend and fellow trooper Trevor Casper during the Washington County Law Enforcement Memorial Service, which was held May 19. Casper lost his life May 19. He had located a serial bank robber responsible for at least nine holdups in three states. Steven Snyder shot at Casper nine times, hitting him three. Casper shot at Snyder 12 times, with one of them killing Snyder.

It was an extra-inning game when Kettle Moraine Lutheran hosted Kewaskum as the two teams were tied 4-4 after seven innings. The Indians scored three runs in the top of the eighth. In the bottom of the frame, the Chargers were set down in order by sophomore pitcher Cole Surprenant.

Going into the conference tournament, the Kewaskum High School golfers had only one mini-tour win to their name. Everything was going on all cylinders during the conference tournament as the Indians beat second place Plymouth by 37 strokes. The team also earned the conference medal for the day and three of the four seniors awarded won all-conference awards. Sam Schlosser led the team with an even par 72. Andrew Otto finished second, six shots behind Schlosser. The two are first team All-ECC. The other two counters - Sean Murray and Jacob Schlosser - earned second team honors.

After a 3-0 victory on May 19, the Indians softball team finished with a 10-4 record and third place in the East Central Conference. Kennedy Lehn threw a two-hitter and drove in the first run of the game.

Campbellsport School District Finishing School Year And Looking Forward To Next Year

The Campbellsport School District is wrapping up the 2020-2021 school year and looking forward to 2021-2022.

With only about a week left of school, the high school will be hosting graduation on Sunday, May 23. For anyone who would like to watch the graduation ceremony but not attend in person, you can do that through "Cougar TV," which is the district's Youtube channel. Just look for the link on the top right of the school district website.

In addition to graduation, you can go to "Cougar TV" to see past events that were live-streamed. This includes the high school band and chorus concerts and many sporting events.

Another item that has been going on already this year is the final portion of the building referendum project. The first and main portion of that project was the tearing down of the old part of the middle/high school building and rebuilding it.

Then came upgrades to Eden Elementary School. This included a secure entrance to the building, lighting upgrades and HVAC (heating, ventilation, air conditioning) system upgrades.

The third portion of the project was updating the HVAC in the north wing of the high school. This is the portion along Highway V.

"We are changing it to one HVAC unit," said Paul Amundson, district administrator. "The teachers in that wing are excited about it."

The ag room will be put on its own unit. This will prevent the smells from the animals in the ag room from lingering in that entire wing.

This project was started earlier this year and continues. Amundson estimates it will be done around August. In addition to the HVAC, new LED lighting is also being installed in that portion of the building.

"The majority of those costs are coming out of the referendum money (which has to be used by the end of June)," Amundson said. "There will be some referendum money left after that and it will be used to pay off debt."

Another project that has just been completed is upgrades to the drainage on the soccer and softball fields. This project was started at the end of the summer and was just completed.

Students helped out with portions of this project. The fields were re-seeded by students in the horticulture classes at the high school.

"We re-leveled the soccer and softball fields," Amundson said. "Those will be ready in the fall. Our soccer and softball teams went there and picked rocks."

Summer School

Plans for summer school have been made and students have signed

up for classes. It will start on June 3rd.

"It will be an abbreviated summer school," Amundson said.

Another exciting option for students will be at the Eden Elementary School library. As in the past, students will be able to utilize the library all summer for their reading needs.

"The Eden library will be open during the summer a few days a week," Amundson said.

2021-2022 School Year

As for the upcoming school year, plans are underway.

"Next year we are hoping that with what we've learned, we will be able to move to a more normal year," Amundson said. "We are anticipating no masks, except for those who want to wear one. The main thing is we will be in school unless things go crazy."

"At the high school/middle school we are moving into our new schedule," Amundson said.

The school board had approved a new schedule system for the high school in December 2019. It was to begin this school year but because of the Coronavirus pandemic, the schedule was not exactly what it was supposed to be.

The old schedule was a block schedule where students had four classes a day. The new schedule will be a hybrid block schedule. On two days of the week, there will be four classes. For three days, there will be eight classes in a day.

Also had the high school, sports should be back to their regular schedule.

"Fall sports will be where fall sports are supposed to be," Amundson said.

Elementary Schools

Last month, the school board approved a pilot program for four-year-old kindergarten.

"We will be offering a full-day 4K pilot program at CES, which has al-

ready filled up," Amundson said. "I think it will be both ways for a while. We will see how it goes."

The Eden Elementary School four-year-old kindergarten class will continue to be a half-day program. So parents will have the choice to put their youngster in the half-day or full-day program.

Amundson is predicting that all school events will be back to normal in the next school year. This includes concerts, parents' nights and any other similar activity. It should all return in 2021-2022.

"Those are the major things that we see happening," Amundson said.

Virtual School

One thing that Amundson said will not be returning is virtual school through the Campbellsport School District. But those who want their children to stay in virtual learning will have an option.

"We're not planning on doing virtual school," Amundson said.

The district will be working with the Kiel School District on this. It will be open to all grade levels.

"We are offering a virtual school in a partnership with Kiel," Amundson said. "So if students want to sign up for that, they can."

These students would still be considered Campbellsport School District students, but they will be taking classes through Between the Lakes Virtual Academy. This gives the students the opportunity to still participate in Campbellsport sports, music, etc.

"That student will still be able to participate in our activities," Amundson said. "It is no cost to the parents. That's going to be an option for our parents. There will be info coming out to parents soon."

Amundson feels this will be the best option for those families who would feel better with their students staying virtual yet next year. It will also be an option for students in the future.

Objections to the amount or valuation of property shall first be made in writing and filed with the clerk of the board of review within the first 2 hours of the board's first scheduled meeting, except that, upon evidence of extraordinary circumstances, the board may waive that requirement up to the end of the 5th day of

Ordinance 21-1: Disorderly Conduct

This ordinance supersedes all previous Osceola Disorderly Conduct Ordinances. The intent of this ordinance is to control disorderly behavior, to protect public health and welfare, and to allow peaceful enjoyment of property.

I. Definitions:

- A. **DISORDERLY CONDUCT.** Whoever, in a public or private place, engages in violent, abusive, indecent, profane, boisterous, unreasonably loud, or otherwise disorderly conduct under circumstances in which the conduct tends to cause or provoke a disturbance, is guilty of a violation.
- B. **DBA.** The abbreviation for the sound level in decibels determined by the a-weighting network of a sound meter.
- C. **DAYTIME HOURS.** 7:00 am to 11:00 pm CST.
- D. **NIGHTTIME HOURS.** 11:00 pm to 7:00 am CST.
- E. **SOURCE.** Any person or property, real or personal, contributing to noise pollution.
- F. **MEASUREMENT** of noise levels shall be conducted at the property line of the complaining party's residence, the residence for which they are responsible, or business.
- G. **EVENT.** A planned public or social occasion not lasting more than three consecutive calendar days.

II. General Rules:

- A. **LOUD AND UNNECESSARY NOISE PROHIBITED.** It shall be unlawful for any person to make, continue, or cause to be made or continued any loud and unnecessary noise.
- B. **TYPES OF LOUD AND UNNECESSARY NOISES.** The following acts are declared to be loud, disturbing, and unnecessary noises in violation of this section, but this enumeration shall not be deemed exclusive:
 - 1. **Horns or signaling devices.** The sounding of any horn or signaling device on any automobile, motorcycle or other vehicle on any street or public place in the Town for longer than five seconds in any period of one minute or less, except as a danger warning; the creation of any unreasonable loud or harsh sounds by means of any signaling devices and the sounding of any plainly audible device for any unnecessary or unreasonable period of time; the use of any signaling device when traffic is, for any reason detained/restricted.
 - 2. **Watercraft motors.** Boat/PWC motors shall not exceed 85 Db when measured at a distance of 50 feet.
 - 3. **Animals and birds.** The keeping of any animal or bird which by causing frequent or long-continued unnecessary noise.
 - 4. **Construction repair of buildings or structures.** The erection (including excavation), demolition, alteration or repair of any building or structure involving equipment attended by loud or unusual noise, other than between the hours of 7:00 am and 11:00 pm; provided, however, the Board shall have the authority, upon determining that the loss of inconvenience which would result for any party of interest would be extraordinary and of such nature warrant special consideration, to grant a permit for a period necessary within which time such work and operation may take place within the hours of 11:00 pm and 7:00 am.
 - 5. **Schools and churches.** The creation of any excessive noise on any street adjacent to any school, institution of learning, or church while in use, or adjacent to any school, institution of learning, or church while in use, which unreasonably interferes with the normal operation of the institution, or which disturbs or unduly annoys.
 - 6. The **provisions** of this section shall not apply to:
 - a. Any vehicle of the Town while engaging in necessary public business.
 - b. Excavators or repairs of streets or other public construction by or on behalf of the Town, County or State at night when the public welfare and convenience render it impossible to perform such work during the day.
- C. **STATIONARY NOISE LIMITS:**
 - 1. **Maximum Permission Sound Levels.** Noise from a stationary source shall not exceed the following levels measured at the property line:

Zone	Noise Rating Daytime 7AM-11PM	Noise Rating Night-time 11 PM-Close
Residential	80	70
Business	85	75
Industrial	90	80

- 2. **Construction Noise.** Construction equipment in any zone may be operated between the hours of 7:00 am to 11:00 pm.
- 3. **Noise in Residential Districts.** In residential zones, the person in violation of this section shall be ordered to reduce the sound pressure to an acceptable level immediately by the monitoring officer.
- 4. **Exemptions.** Operation of emergency equipment shall be exempt from this chapter. Snow blowers shall be exempt from this chapter when used to gain access to a Town street. Emergency equipment shall include ambulance, police, fire, snow removal, civil defense sirens, etc., necessary for the health, safety, and protection of the citizens of the Town.
- 5. **Methods of Measuring Noise.**
 - a. Equipment. Noise measurement shall be made with a sound level meter.
 - b. Location of Noise Meter. Noise measurement shall be made at the nearest lot line of the premises from which a noise complaint is received. The noise meter shall be placed at a height of at least three feet above the ground and at least three feet away from walls, barriers, obstructions, and all other sound reflective surfaces.
 - c. The equipment necessary to measure sound shall reside within the Town of Osceola Police Department and must be calibrated every six months.
 - d. A designated enforcement official of the Town may, based on first impression, if he/she has reasonable suspicion to believe a violation of this ordinance is being committed in his or her presence, view, or hearing, may issue a municipal citation.
 - e. A noise that exceeds the rating allowed must exceed the Db permitted for more than five seconds within a one minute period to be in violation of this ordinance.

III. PENALTIES:

- A. The penalty for violation of Ordinance 21-1 shall be \$100.00 for first offense; \$200.00 for second offense; \$400.00 for third offense.
- B. Each day that the violation continues shall be considered a separate offense and therefore, forfeiture may be imposed for each day the violation continues.

IV. EXEMPTIONS:

- A. The provisions of this chapter do not apply to devices used solely for the purpose of warning, protecting or alerting the public of the existence of an emergency or hazardous situation.
- B. This provision of this chapter does not apply to the following:
 - 1. Household tools and portable appliances in normal usage between the hours of 7:00 am and 10:00 pm
 - 2. Lawn care and snow removal equipment when used in accordance with manufacture's specifications
 - 3. Motor vehicles on public roads, exclusive of electronically produced railroad signal.
 - 4. Emergency operations
 - 5. Air conditioning or heat pump equipment used to heat or cool housing on residential property.
- C. If the location of the complainant cannot be determined, no action will be taken.

V. SPECIAL EVENT PERMIT:

- A. A request may be made to the Town Board for a permit allowing for the standards as provided to be exceeded within the limitation of said permit. In issuing the permit, the Board shall consider the type of sound, the proximity of the source of the sound to neighbors and surrounding properties, the time of day when the noise will be generated, and whether reasonable steps have been taken to contain the sound have been made. The application fee shall be \$25.
- B. Special Event Permit may be approved by the Town Board. The number of Special Event Permits issued per year is at the discretion of the Town Board.
- C. **The Special Event Permit application must be submitted to the town clerk at least one week prior to the next scheduled Board Meeting for their review.**
