Eden Village Board Discusses Increase In Sewer Rates

During a public hearing on Tuesday, July 20, members of the Eden Village Board and village residents listened to discussion about a major increase in sewer rates for the village.

This is something the village board has been discussing for more than a year. Extensive upgrades are needed at the wastewater treatment plant, which is the reason for the increase in rates.

During the public hearing, Leo Kucek of Applied Technologies explained the upgrades, the reason for the upgrades and the rate increas-

es. The village's current facility can no longer keep up with the capacity it receives on a daily basis. There are also new regulations coming that the plant is not able to handle.

"There have been many days that it (the plant) has been above capacity," Kucek said. "The fact that Ed Costello (DPW director) has been able to continue to make this thing work is great. The new standards will not be achievable with the current plant."

Applied Technologies did look into two different options. One was to upgrade the current facility. The other was to hook up to the City of

The position became open after Doug Gonring resigned from the board on June 30. Gonring was elected to a three-year term on the board in April 2019.

Candidates include: Andy David, Frederick Luft, Nicole Fideler, Archie Graham, Connie O'Neill, Andrew Mazurek, Rhett Engelking, Bradley Petersen, Randy Reysen, Nathan

Weseman and Karen Strobel.

The Kewaskum School Board is expected to interview candidates and appoint someone to fill the seat for the remainder of the term, which ends in April 2022. At that point, voters will decide who is on the board during the 2022 Spring Election.

Interviews are expected to be held in August, but no date had been scheduled as of press time for this newspaper. The appointment may occur following the interviews.

Letters of interest were due on July 23.

SWAT Team Responds To Incident In Farmington

The Washington County SWAT team responded to a call about a neighbor dispute involving alleged death threats at the 8100 block of State Highway 144 in the Town of Farmington on Thursday, July 22.

Marc E. Herman, a 43-year-old Town of Farmington man, was charged with several crimes in Washington County Circuit Court on Friday, July 23, after the overnight tactical incident at his residence, 8177 State Highway 144. Herman was charged with felon in possession of a firearm, possession of a firearm while intoxicated and disorderly conduct.

The incident began on July 22 when the Washington County Sheriff's Office received a 911 call at approximately 8:30 p.m. from a neighbor reporting that Herman was highly intoxicated and threatening to kill the neighbor from outside the neighbor's house.

When deputies first arrived in the area, they im-

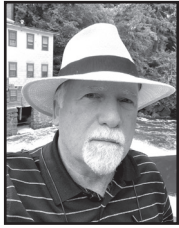

Dear Editor,

The bipartisan Wisconsin Elections Commission held three levels of canvassing of the 2020 election to prove accuracy. An audit of the voting machines and other equipment was done and the results were publicized. These audits declared our 2020 election was held safely and accurately.

Since then, Rep. Vos had ordered a partisan election committee to again investigate our election process. The results were unproven partisan testimonies and wild conspiracy accusations. No concrete evidence of fraud or irregularities.

Not satisfied with those results, Rep. Vos has hired three retired police officers and a former judge to perform another audit, at taxpayer expense, to the tune of \$63,000, so far.

On top of this, Wisconsin State Rep. Timothy Ramthun wants a more comprehensive “forensic audit” on five Democratic counties, with no evidence of fraud or irregularities. A recent “forensic audit” in Pennsylvania has resulted in the decertification of their voting equipment, because the auditors were inexperienced and jeopardized the machines for future elections. The cost to replace these machines will be around \$2.7 million.

Enough of this foolishness. Wisconsin already has one of the most stringent voter identification laws in the nation. If the goal is to pass even more restrictive voting laws and make the voting process more burdensome instead of easier, Ramthun should find a cheaper way to convince the public that they are necessary. So, how about getting to work on issues that actually need some work?

Heroes Of The Holyland — Andy Bartel

Andy Bartel was born and raised in Marytown, where his father operated a creamery “in town,” and a fox farm on the outskirts. When the United States entered World War II, Andy was in high school, first in DePere (St. Norbert's), and then Milwaukee (Pio Nono). He graduated in 1944, turned 18 on July 26, and in September, entered boot camp in Perris Island, SC, for the United States Marine Corp.

Upon completion, he went to Camp Pendleton, CA, assigned to the 1st Battalion, 5th Marines. The Battalion had been re-activated in January, 1942, at New River, NC. In June of that year, it was deployed and saw action in the Pacific. Andy joined the unit in time for the Okinawa campaign. After that, they were preparing for the invasion of the home islands when word came that the Japanese forces had surrendered.

In October of 1945, the unit was deployed to Tangku, China, as part of Operation Beleaguer, where they were involved with the repatriation of Japanese and Korean troops to their home countries. Andy was honorably discharged in 1946. For his service, he was awarded the Combat Action Ribbon, the American Campaign Ribbon, the Asiatic Campaign Ribbon, and the World War II Victory Ribbon.

While events were going on, one of the actions undertaken by the Congress and the President was enactment of the Servicemen's Readjustment Act of 1944, the “GI Bill.” When Andy returned to the Marytown after his service, he contacted officials at the University of Wisconsin and asked what he needed to do to enroll. According to him, their response was “just come on down to Madison,” so he did, beginning a lifelong love of and loyalty to the University, both as to its academics and its athletics.

When he entered as a Freshman, the University was unprepared for the number of servicemen who would take up the offer to “come on down.” As a result, Andy (and other servicemen) wound up spending their first year in quonset huts at Truax Field and bussing in to classes. While accommodations were spartan, he always com-

mented that it was a “step up from tents.”

Andy enrolled in the College of Agriculture, getting his degree in dairy science, planning an eventual return to the creamery. Something he grew to appreciate was that the college allowed for a number of elective courses from other parts of the University. He took full advantage of that to take courses on “the Hill,” which at that time housed most of the liberal arts departments.

Upon graduation, he returned to Marytown. The original plan was to work in the creamery, but a hand injury requiring multiple stitches meant a short term re-assignment to the fox

Fond du Lac's sewer system, but this option was much more expensive.

“We did look at regionalization,” Kucek said. “When all was said and done, you were basically looking at \$9 million to go six miles north and hook up to what Fond du Lac has up there.”

The upgrades will be less than half of that amount. “When all is said and done, it is just shy of \$4 million,” Kucek said. “We try to figure a 10-20 percent range of where we think the bids will come in at and I don't think we are far off with this.”

The village has found some options for grants and other funding sources to help pay for these costs. One of those areas is in phosphorus reduction forgiveness. This should reduce the cost by around 44 percent.

“The principal forgiveness grant is a big deal and that is going to change that cost,” Kucek told the board at a previous meeting. “We believe there should be \$1.8 of forgiveness. It's almost half off

when you think about it.”

With that reduction, the annual cost to the village to pay off the loans for this upgrade will be around \$639,000. To be able to pay off these loans, sewer rates will need to increase around 40 percent.

The village board will approve these rate increases in a sanitary sewer rate ordinance at the August meeting and the rates will go into effect on October 1, 2021. The new rates per quarter will be: \$240-residential, \$330-mercantile, \$450-light commercial, \$1,245-heavy commercial, and school-\$15 per student/teacher.

The design phase of the project is already completed. The Department of Natural Resources is in the process of approving the plan. A next step will be to put the project out for bids with an anticipated start date for construction of spring 2022.

“I am really impressed with how Ed (Costello) started this whole process and the project,” said Mark Stanek with the DNR. “He went way above. I think he interviewed around 10 consulting firms. Things have gone really smooth from our per-

spective. You are going to end up with money well spent and a nice project.”

After the public hearing, the village board continued with their regular meeting.

They discussed the issues with garbage pick up. There have been some troubles in the past couple months, but they are working with Waste Management on the issues.

“We have been faring better than other municipalities around us,” said Kari Schlefke, village clerk. “My suggestion would be to put your bins out the night before.”

Village president Cory St. Mary added, “At least they are picking up the garbage. It may be a day late but...”

The board is also going to look golf carts on village streets. They are going to check with other communities who allow it through ordinances and try to get something like that for Eden.

“I don't have a problem with them myself, but it is a different ordinance than the ATV one,” said Jay Baumhardt.

Those years were the only time that Harvey was separated from his older brother, Edward, who says that the army training served them well when Harvey returned to the farm.

That training was also useful for Harvey during the 10 years he worked at Gehls. There he was involved in the testing and support of new farm equipment. The company would send prototypes and new models to farmers to try and Harvey was the one sent out to the farms to troubleshoot the new equipment and support farmers as they start using it.

In 1965, Harvey and his brother Edward took over the family farm. Com-

monly referred to as "the boys," the brothers had been involved in 4-H as teenagers which led to their passion for breeding high-quality purebred Holsteins. By the time they retired from milking cows, they were known for having one of the best home-bred herds in the country.

Washington County Sheriff's Office Reports

House Fire

On July 23 at approximately 8:18 p.m., the Washington County Sheriff's Office was notified of an explosion and house fire at a single-family residence in the 3100 block of Norman Drive in the Town of Barton. The incident was reported by a nearby neighbor.

There were two occupants at the residence at the time of the explosion. Both occupants received severe burns. They were taken by ambulance to a local hospital, where they were then med flighted to a regional burn unit. Both victims remain in stable but critical condition at a local burn unit. The son was visiting from California and his father resides at the Norman Drive house alone. Evidence suggests that the explosion was natural gas-related and is not being considered a criminal matter.

The next-door neighbor was at home at the time and heard the explosion. He immediately ran to the house and located the homeowner's 48-year-old son, who was in the process of self-evacuating. The neighbor asked where the homeowner was. The son said he thought he was with him as they were evacuating together. The neighbor quickly entered the burning house and located the 78-year-old homeowner, who had become disoriented and was unable to find his way out. He was able to evacuate the victim and get him to the arriving medical personnel from the West Bend Fire Department, who were in the area on another assignment at the time of the 911 call.

Deputies with the Washington County Sheriff's Office reported to the scene along with West Bend Fire Department personnel. The call was quickly upgraded to a MABAS call. The fire department was assisted by Lifestar Ambulance, WE Energies, and Jackson, Allenton, Kewaskum, Newburg, Slinger, Germantown, Boltonville, Kohlsville, Fillmore, St Lawrence, Hartford, Grafton and Richfield fire departments. State Patrol assisted the Sheriff's Office with traffic control. Traffic to the area was shut down for nearly four hours. Neighboring residences were temporarily evacuated.

The residence sustained severe damage due to the fire, smoke and water. The house and contents appear to be a total loss. Preliminary damage estimates were believed to exceed \$300,000. Minor damage occurred to a neighboring home.

The investigation into a house explosion that occurred on Friday night in the Town of Barton continues. Washington County Sheriff's investigators are working alongside investigators from the West Bend Fire Department and the Wisconsin Division of Criminal Investigation Fire Marshal's Office.

Washington County Sheriff Martin Schulteis wants to express his respect and appreciation for the neighbor's actions on Friday night.

"This man reacted in a manner

that is nothing short of heroic. After hearing the explosion, he quickly responded and identified that the elderly homeowner was missing. Without pause, he ran into the burning house to rescue him without concern for his safety. This fire was rapidly spreading, and the window for a rescue to be possible was small. Without delay or hesitation, this man ran towards the fire to rescue the victim. Had this hero not taken immediate action, this victim would most likely not have made it out of that house. We ask that you join us in keeping these victims in your thoughts and prayers," Schulteis said.

Car vs. Bicycle Crash

On Saturday, July 24, at 10:08 a.m. the Washington County Sheriff's Office Dispatch center received a 911 call reporting a bicycle versus vehicle crash with serious injuries on Church Road south of Highway 60 in the Town of Jackson. Personnel from the Jackson Fire Department, along with the Jackson Police Department and Washington County Sheriff's Office, were requested to respond to the scene.

Upon arrival of the first rescue personnel, Flight for Life was requested to the scene. The bicyclist, a 62-year-old Town of Jackson resident was transported to Froedtert West Bend by ambulance and then by LifeNet medical helicopter to Froedtert Wauwatosa for serious life-threatening injuries. The driver of the motor vehicle, a 28-year-old Town of Jackson resident, sustained minor injuries and was treated at the scene.

An initial investigation shows that the bicyclist turned south bound on Church Road from Highway 60 and entered the northbound lane of traffic. The northbound vehicle, which was slowing for the stop sign, was then struck by the bicyclist.

The crash remains under investigation by the Washington County Sheriff's Office Accident Reconstruction Team. Church Road was closed to traffic for approximately three hours.

Fatal Motorcycle Crash

On Friday, July 23, 2021 at 6:58 p.m., the Washington County Dispatch Center was notified of a motorcycle crash on State Highway 175 in the curve just south of Fork Road, in the Town of Addison. The caller reported that the operator of the motorcycle was in the ditch unconscious.

Deputies from the Washington County Sheriff's Office, along with members of the St. Lawrence Fire Department, responded to the scene. The operator, a 61-year-old male, Washington County resident was pronounced deceased on scene.

The initial investigation indicated that the motorcycle was traveling southbound on State Highway 175 south of Fork Road and failed to negotiate the curve. The motorcycle went off road right and struck a highway warning post, then came to rest in the ditch. The operator was

not wearing a helmet.

The crash remains under investigation by the Washington County Sheriff's Office Accident Reconstruction Team.

Barn Fire

On Thursday, July 22, at 2:55 p.m., the Washington County Sheriff's Office was notified of a barn fire at 6405 Yellowstone Trail in the Town of Addison. Washington County Sheriff's deputies and Allenton Fire Department personnel responded to the scene.

Washington County Dispatch Center received multiple calls of a barn fire located at the above address. The callers advised that the barn on the property was fully engulfed in flames. The barn was unoccupied and used as a storage barn on the property. Allenton Fire personnel arrived on scene within minutes and began fire suppression efforts. Ultimately, the fire was extinguished.

The homeowner told deputies she had a rodent problem in the barn. The owner stated she decided to place a "smoke bomb" type device in between the lower flashing on the west side of the barn to try to smoke the rodents out. The owner then covered the gap in the flashing with a blanket, so the smoke did not escape the walls of the barn. The owner said she did this at approximately 2 p.m. on July 22. The owner advised after doing this she went back inside her residence. The owner said she received a call from her neighbor just before 3 p.m. stating the barn was on fire.

The barn was approximately 40 feet by 20 feet in size. The barn did not have any electrical or gas supplied to it, and the fire was contained to the barn. The barn and contents were a total loss valued at \$20,000. There were minimal contents inside the

barn, including a small 2001 pop-up camper valued at \$2,500. The origin and cause of the fire was investigated by the Allenton Fire Department. The fire chief determined that the "smoke bomb" ignited the west wall of the barn, and the fire quickly spread due to the age of the building.

Yellowstone Trail was shut down for approximately two hours to accommodate emergency vehicles. The Allenton Fire Department was assisted by the following fire departments: West Bend, Slinger, Hartford, St. Lawrence, Kohlsville, Jackson, Theresa, Knowles, Iron Ridge and Neosho. Lifestar Ambulance assisted fire personnel on scene.

No fire or police personnel were injured.

House Fire

On Tuesday, July 20, at 3:56 p.m., the Washington County Sheriff's Office was notified of a house fire at 3615 Paradise Drive in the Town of West Bend. Washington County Sheriff's deputies, West Bend police officers and West Bend Fire Department personnel responded to the scene.

The residence is a single-family home. The tenant of the residence called 911 and advised there was a fire in the bedroom. The tenant stated she could hear loud high voltage electrical noises near the house. At the time of the fire, the tenant was the lone occupant of the home. She exited the residence with her two dogs and waited for emergency responders. West Bend Fire personnel arrived on scene within minutes and began fire suppression efforts and quickly extinguished the flames.

The tenant told deputies she smelled smoke and discovered it was coming from the bedroom closet.

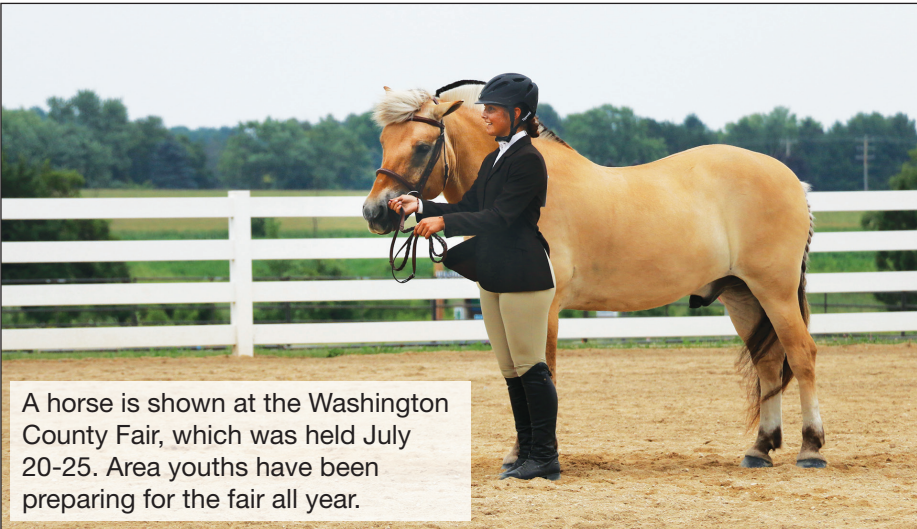

KEWASKUM'S DAYS GONE BY**5 Years Ago****August 4, 2016**

Kewaskum is home to more than 120 ash trees. The future of Kewaskum's ash trees is dismal. The Emerald Ash Borer, an invasive pest that kills ash trees, has been found in the Village of Kewaskum. It was identified and confirmed June 29. The EAB kills all untreated ash trees within a few years; even the young and healthy ash trees are killed within three to five years of infestation. The Village of Kewaskum has declared a moratorium on planting ash trees.

A Wisconsin legislative study committee is considering whether local governments and school boards should be allowed to post legal notices online rather than printing them in newspapers. The committee met in the State Capitol on July 26 and heard testimony from representatives of three local government associations as well as the Wisconsin Newspaper Association.

Max Stowers from Kettle Country Kids 4-H Club wrote an article about the experience with the Citizenship Washington Focus. The CWF is a trip dedicated to showing youth the importance of citizenship, what goes on in our government, all while learning about Washington, D.C. and meeting new people.

The ordinance on delinquent water bills that the Kewaskum Village Board approved July 18 has been changed to reflect current regulations set forth by the Wisconsin Service Public Commission. These included the 10 days the village was giving residents to pay after receiving a placard on their house for disconnection; it is now 10 business days rather than 10 calendar days. The cost for reconnection was changed from \$75 to \$35 if during office hours and \$45 outside office hours.

The Kewaskum Remembers Memorial Park, a non-profit project dedicated to building a 9/11 Memorial in the Town of Kewaskum, will be hosting a parade, memorial service and fundraiser on September 11. 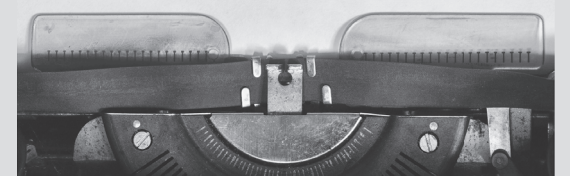

mediately heard numerous rifle rounds in rapid succession. A perimeter was established, and the Washington County Sheriff's SWAT team was called.

An armored rescue vehicle was utilized to safely evacuate the caller from his home while other tactical elements secured the area. It was determined that Herman had returned to his nearby home.

SWAT team negotiators were able to establish phone contact with Herman; eventually, he agreed to come out of his house, and he surrendered peacefully to authorities. He was taken into custody without incident at 10:47 p.m.

No one was injured as a result of this incident.

A search warrant was obtained and executed on the residence early Friday morning by Washington County Sheriff Investigators. Evidence, which included a home surveillance video, was located during the search. The video showed Herman had armed himself with a rifle and had fired around 30 rifle rounds simultaneous to officers arriving on the scene. The video also showed Herman threatening and challenging the neighbor to come outside and fight him while armed with the rifle.

Most of the casings were found near the front porch of his residence. Authorities do not know where the rounds were fired.

Herman resides at the house with his parents, who were not home at the time. A total of 11 firearms were seized from the house and various pieces of drug paraphernalia. Herman is a convicted felon and prohibited from possessing firearms because of those previous convictions.

The Kewaskum Police Department and the West Bend Police Department provided mutual aid assistance for the incident. In addition, the Boltonville and Kewaskum fire departments assisted in staging the emergency response.

The Washington County SWAT Team is composed of specially trained members from the Washington County Sheriff's Office, the Germantown Police Department and the Hartford Police Department. The team's mission is the preservation of life and property during critical incidents and high-risk operations.

The tenant opened the closet to investigate and immediately observed flames coming out of the electrical breaker box. The tenant tried to smother the fire with clothing, but the fire quickly spread to the clothes. The tenant then gathered her pets and exited the house and called 911.

The fire was contained to the east bedroom. The interior of the home sustained heat, smoke and water damage. There was minor damage to the exterior of the home, which is valued at \$200,000. The origin and cause of the fire was investigated by the West Bend Fire Department and the Washington County Sheriff's Office. The origin of the fire appears to be the east bedroom. The cause of the fire appears to be electrical; there was evidence of "arcing" inside the electrical/breaker box located in the closet of the bedroom.

Paradise Drive between S. 18th Avenue and Scenic Drive was shut down briefly for fire apparatus. The West Bend Fire Department was assisted by the following fire departments: Newburg, Kohlsville, Allenton, Kewaskum and Jackson. WE Energies assisted fire personnel on scene. The American Red Cross was called to assist the two displaced tenants and their pets.

No fire or police personnel were injured.

The library also has some miscellaneous office furniture to sell plus a few other items. Photos of these items will be on Facebook before the sale and will be priced to sell fast.

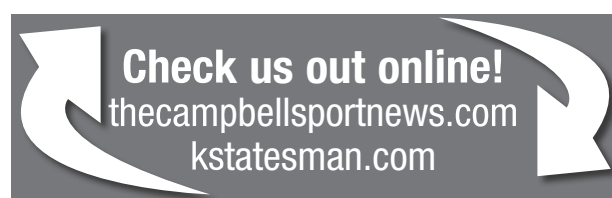

farm. “Temporary” eventually became “permanent,” and “fox” eventually changed to “mink.”

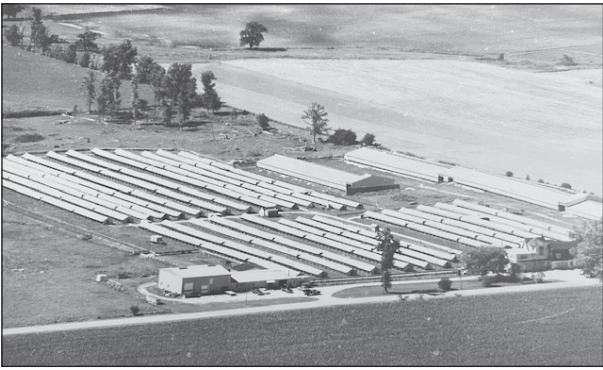
In his spare time, Andy played football with the Sheboygan Redwings, where he was an offensive lineman. He also assisted as a coach for the New Holstein High School team. This led to an introduction to Carolyn Schauf, who was a recent graduate from Stout Institute, and a home economics teacher at the school. The two were married on August 6, 1955, and spent over 63 years together until Carolyn’s death in May of 2019.

For most of their married life, Andy and Carol lived on the mink ranch in Marytown, where they raised seven children: JoAnn Hoelscher (Kevin), Andrea Bartel Riffle (Mike), Bill Bartel (Kathy), Dave Bartel, Tom Bartel, Gregg Bartel (Julie) and Mary Bartel (Tim Mueller).

During his career, Andy was very active in both his business and his community. He and other servicemen were instrumental in founding the Marytown Veteran’s Club, which supported youth programs in the community. He coached his sons in the Marytown team in the area “Little League.” When his youngest daughter became old enough to play, he helped start up the East Shore Girls Softball League, where he also coached.

When their children first began their education in the early 1960s, Andy and Carol looked to the local St. Mary’s parish school. By the late 1960s, it was becoming clear that rural Catholic parishes would struggle to maintain an independent program. Andy and Carol met with other community parents, as well as those from surrounding parishes.

Those meetings laid the foundation for the Consolidated Parochial Elementary Schools. Involving the parishes in the towns of Marytown,

Johnsburg, Saint Cloud and Mount Calvary, it was the first consolidation in the Milwaukee Archdiocese. In what was also a first, the majority of members on the CPES School Board were lay people, and Andy was the first board president.

From a business standpoint, Andy’s biggest involvements were with the Kettle Moraine Mink Ranchers Association, and the Great Lakes Mink Association. He served numerous terms on the boards of both associations, including various periods as president.

In 2007, Andy and Carol fulfilled their longtime goal of retiring to a house on the shores of Lake Winnebago, near the land where his parents had maintained a cottage. Andy became more involved in woodworking, particularly carving, and Carol enjoyed her outdoor gardens and indoor kitchen.

In the Fall of 2018, both Andy and Carol relocated to the Villa Loretto, remaining in the area and near much of their family. Andy continues to live there today and recently celebrated his 95th Birthday.

VILLAGE OF KEWASKUM ORDINANCE NO. 21-03 ORDINANCE TO AMEND SEC. 1-11 OF CHAPTER 1 OF THE MUNICIPAL CODE PENALTY PROVISIONS

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. That Sections 1-11 of the Municipal Code of the Village of Kewaskum, relating to Penalty Provisions, should be amended as follows:

Sec. 1-11. - Penalty provisions.

(a) *General penalty.* Except as otherwise provided, any person who shall violate any of the provisions of this Code or any rule or regulation adopted or issued in pursuance thereof, or any provision of any code adopted by reference in this Code, shall, upon conviction of such violation, be subject to a penalty, of not less than \$25.00 nor more than \$1,000.00.

(b) *Continued violations.* Each violation and each day a violation continues or occurs shall constitute a separate offense. Nothing in this Code shall preclude the village from maintaining any appropriate action to prevent or remove a violation of any

provision of this Code.

(c) *Execution against defendant's property.* Whenever any person fails to pay any forfeiture and costs of prosecution upon the order of any court for violation of any ordinance of the village, the court may, in lieu of ordering imprisonment of the defendant, or after the defendant has been released from custody, issue an execution against the property of the defendant for such forfeiture and costs.

(d) *Citation method of enforcement.*

(1) *Statutory authorization.* Pursuant to §66.0113, Wis. Stats., the village elects to use the citation method of enforcement of ordinances, including those for which a statutory counterpart exists.

(2) *Contents of citation.* The citation shall contain the information required in 66.0113 or 800.02, as applicable, which are adopted and incorporated by reference in this section.

(3) *Issuance of citations.* Any village law enforcement officer is authorized to issue citations for violations of those ordinances they are empowered to enforce.

(4) *Procedure.* §66.0113(3), Wis. Stats., relating to a violator's options and procedures on default, is adopted and incorporated by reference in this section.

(5) *Nonexclusivity.*

a. *Other ordinance.* Adoption of this subsection does not preclude the village board from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or other matter.

b. *Other remedies.* The issuance of a citation under this section shall not preclude the village board or any authorized officer from proceeding under any other ordinance or law or by any other enforcement method to enforce any ordinance, regulation or order.

(e) *Forfeiture bonds for municipal citations.* The chief of police is authorized to establish bond amounts for violations of this Code, for which municipal citations are issued, which a schedule of cash deposits is set forth in Section (g) below. The forfeitures shall be not less than \$5.00 nor more than \$1,000.00, plus costs and assessments. The establishment of these bond amounts shall be done administratively by the chief of police and when established shall constitute approval by the village board and shall not require any further action by the village board. Deposits shall be made in

cash, money order or certified check to the Mid Moraine Municipal Court which shall provide a receipt therefor. In addition to the deposit amount listed, the deposit shall include the costs, fees and surcharges imposed under Ch. 814, Wis. Stats.

(f) *Juveniles.*

(1) *Definitions.* The following words, terms and phrases, when used in this subsection, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Juvenile means a person who is 12 years of age or older, but less than 17 years of age.

(2) *Penalty.* Any juvenile who violates any provision of this Code or any rule or regulation adopted or issued pursuant hereto or any provision of any code adopted herein by reference, upon conviction of such violation, shall be subject to imposition of any of the dispositions set forth in §§ 938.343 and 938.344, Wis. Stats., in accordance with the provisions of those sections. Any juvenile who violates a condition of a dispositional order under §§ 938.343 or 938.344, Wis. Stats., upon adjudication of such violation, shall be subject to imposition of any of the sanctions set forth in § 938.355(6)(d), Wis. Stats., in accordance with the provisions of that section.

(g) *Schedule of Cash Deposits.* A Schedule of Cash Deposits is on file with the Village Police Chief.

Section 2. Severability. The several sections of this Ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the Ordinance. The remainder of the Ordinance shall remain in full force and effect. Any other Ordinances whose terms are in conflict with the provisions of this Ordinance are hereby repealed as to those terms that conflict.

Section 3. This Ordinance shall take effect immediately upon passage and publication as provided by law.

VILLAGE OF KEWASKUM ORDINANCE NO. 21-04 ORDINANCE TO AMEND SEC. 26-1 OF CHAPTER 26 OF THE MUNICIPAL CODE MUNICIPAL COURT AND MUNICIPAL JUDGE

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1. That Section 26-1 of the Municipal Code of the Village of Kewaskum, relating to Municipal Court and Municipal Judge, should be amended as follows:

Sec. 26-1. - Municipal court and municipal judge.

(b) *Municipal judge.* The municipal court shall be under the jurisdiction of and presided over by a municipal judge, who shall be an attorney licensed to practice law in the state and who resides in any of the member municipalities as defined in the agreement. The municipal judge shall be elected at large in the spring election for a term of four years commencing on May 1 of the year of his or her election. The governing bodies of the member municipalities shall provide for a primary election if more than two candidates file nomination papers for the position of municipal judge.

Section 2. Severability. The several sections of this Ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the Ordinance. The remainder of the Ordinance shall remain in full force and effect. Any other Ordinances whose terms are in conflict with the provisions of this Ordinance are hereby repealed as to those terms that conflict.

Section 3. This Ordinance shall take effect immediately upon passage and publication as provided by law.
