Walking trails open at Reigle Family Park

About 1.5 miles of walking trails at Reigle Family Park in Kewaskum are now open to the public.

"We are excited to officially have the entire park open to the public," said Amy Uhlig, a volunteer on the park's development committee.

The trails meander through the park's five-acre prairie, go around the perimeter of a two-acre fishing pond and connect nine soccer fields to the rest of the park.

Scattered along the trails are benches, thanks to the generous donations from the Kewaskum

Area Chamber of Commerce, Kewaskum Dairy Queen, New Fane Sportsman's Club, Wayne Crusaders 4-H Club and the family of Joanne Staehler.

Larry Bunkelman, with the assistance of his wife, Jan Bunkelman, donated his time to assemble all of the benches at his home. He and Dan Fischer, a volunteer on the park's development committee, then installed the benches throughout the park.

As required by state law, the DNR will renew the baiting and feeding bans in Fond du Lac and Winnebago counties.

Dear Reader,

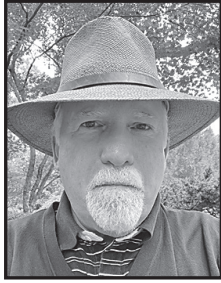
How's your marriage? Are you and your spouse doing well? Terrific! But this column is not for you; it's for the people who are struggling.

Grant program available for farmers, food processors and distributors

Creating a safe environment in response to the COVID-19 pandemic often means additional expenses for farmers, farmers markets, food processors and distributors.

A new U.S. Department of Agriculture program may be able to help. The Pandemic Response and Safety Grants program provides funding to help small scale specialty crop producers and processors, other select producers, meat and other processors, distributors and farmers market recover some of the costs incurred, including for measures to protect workers.

Expenses between Jan. 27, 2020, and Dec. 31, 2021, in following categories—workplace safety, market pivots, retrofitting facilities, transportation, worker housing and medical—are eligible. The minimum funding request amount is

\$1,500. The maximum funding request amount is \$20,000. Funding requests may range from \$1,500 to \$20,000. Examples of eligible expenses include expanding a pack shed to provide for social distancing for employees, the purchasing of Personal Protective Equipment (PPE) for farm employees, additional transportation costs for adjusted delivery or distribution routes, the installation of hand washing stations or other PPE measures at farmers markets, and additional utility expenses for expanded worker housing that met social distanced guidelines.

Visit usda-prs.grantsolutions.gov to apply. The deadline is Nov. 22. The application is two pages and simple to fill out. Applicants will need to apply for a DUNS number if they do not already have one, which takes five business days to return. For more information or assistance with the application process, email usda.ams.prs@grantsolutions.gov or call 301-238-5550.

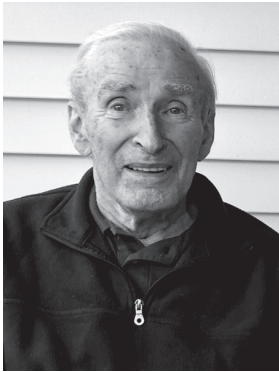

A local landowner reported the deer, an adult doe, to the department in early October. The deer showed outward signs of disease and possible injury by car collision. This is the first wild deer detection in Fond du Lac County.

To help slow the spread of CWD, the DNR enacts baiting and feeding bans in counties where deer have tested positive for CWD as required by state law. Bait piles can encourage deer to congregate unnaturally around a shared food source where sick deer can spread CWD through direct contact with healthy deer or by leaving behind infectious prions in their saliva and urine.

Baiting and feeding were already banned in Fond du Lac County and Winnebago counties due to CWD detections in adjoining counties within 10 miles of the county line. This most recent detection will extend the ban for three years in Fond du Lac County and for two years in Winnebago County.

The DNR asks deer hunters within Fond du Lac and Winnebago Counties to assist with efforts to identify where CWD occurs. Those harvesting deer within 10 miles of the most recent positive are especially encouraged to have their harvested adult deer tested for CWD. Collecting CWD samples is essential for assessing where and to what extent CWD occurs in deer across the state.

As ever, successful CWD management depends in part on citizen involvement in the decision-making process through local County Deer Advisory Councils (CDAC). The DNR and the Fond du Lac CDAC will hold a public meeting on the status of CWD and a response plan for sampling wild deer in Fond du Lac County. The meeting will take place Tuesday, Nov. 16, at 6 p.m. at the Radisson Hotel and Conference Center (Meeting Room B) located at 625 W Rolling Meadows Drive in Fond du Lac.

All community seniors are invited to attend.

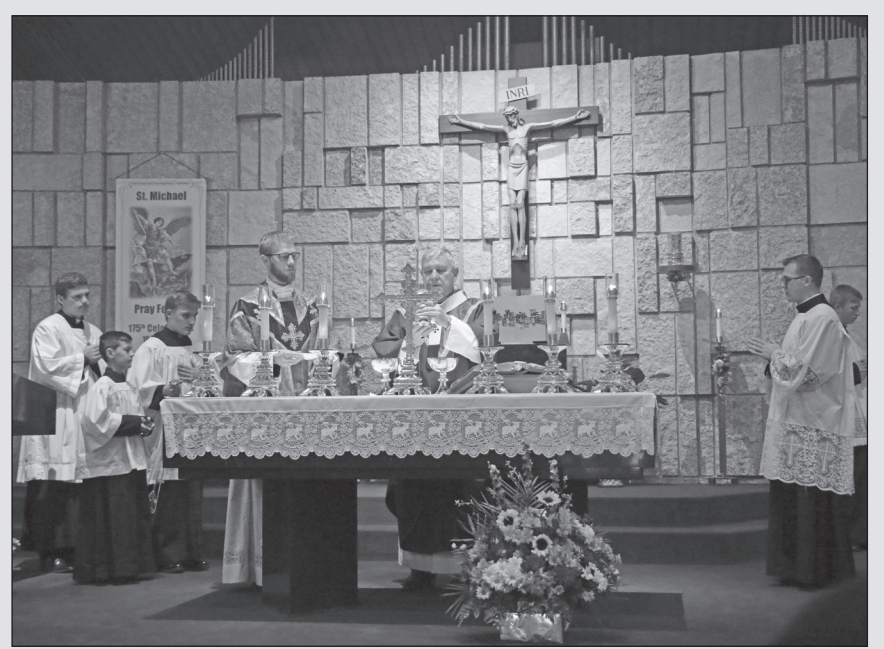

Like the rest of the park, the trails were created through donations and the work of volunteers. Kewaskum High School student Colin Duren worked to create the ¼-mile nature trail around the pond as an Eagle Scout project. Others who donated hours of their time to create the trails include: Dan Fischer, Amy Uhlig, John Duren, Gary Seefeldt, Bill Dei, Anne Trautner and Jim Wulff of the Kewaskum Kiwanis Club.

Last year, Mueller Excavating carved out the trails throughout the park, and Mark Schairer of Mark Schairer Excavating headed up the work this year to finish the trails. This summer, approximately 10 dump trucks spent a couple of days hauling in about 2,000 tons of stone. Truckers and excavators who spent time on the trails are: Mark Enright, Matt Schairer, Mike Thill, Erik Coleman, J. Stuetgen Trucking, Tim Westphal, Ron Leinen, William Ploszay, Jeremy Wagner, Dan Hefter, Jeremy Gordon and CCM Trucking.

The project could not have been completed without the help of different youth groups, including the Kewaskum High School football team, volunteer workers who participated in the Love Begins Here youth mission trip at Holy Trinity and members of Boy Scout Troop 744.

"It really is amazing how the entire community has come together to build this park. It has become something that can be enjoyed by everyone in the area," Fischer said.

Located at 690 Edgewood Road in Kewaskum, Reigle Family Park was created in 2017 when the family of James D. Reigle donated 31.5 acres to the Village of Kewaskum to provide needed space for athletic fields in the area. Since then, volunteers have worked to develop the park. The land was cleared and graded, and nine soccer

fields of varying sizes were created at the park. Playground equipment was donated and installed, and the park now has the largest single piece of playground equipment of any village park in Kewaskum.

Last year, hundreds of children began playing soccer at the park.

Work is not yet completed at the park. The KYSO plans to begin work in the spring on a concession stand on the south side of the park. The proposed building will be 52 feet by 26 feet, with a covered picnic area extending out from the building. The concession stand will include ADA-compliant restrooms and storage space. Future plans also include adding a pavilion and a stage.

"It is incredible how far we have come, but we still need additional funds and help to complete the park. I hope more people will step forward because this is a legacy that we can give to the next generation," Uhlig said.

Roadwork continues in Village of Campbellsport

The Wisconsin Department of Transportation continues work on the road reconstruction project that is underway on State Road 67 in the Village of Campbellsport.

A total of 2.24 miles of road is being reconstructed on State Road 67, from Baumann Street to Triple S Road for a cost of \$9.04 million. The project was scheduled to run from March 15, 2021, to late November 2021.

The project includes reconstructing WIS 67 to install new base aggregate, pavement, curb and gutter, sidewalk, storm sewer, urban shoulders, parking lanes and utilities (water and sanitary sewer). The bridge over Milwaukee River will receive a concrete deck overlay and structural repairs.

Crews worked on asphalt paving from Fond du Lac Ave. and east of Elm Street from Oct. 25 to Oct. 29. Asphalt paving is scheduled to continue from Nov. 1 to Nov. 5.

State Road 67 is closed to through traffic while the project is underway. Local access to businesses and properties in the work zone will be maintained using side roads. Through traffic is directed to use detours on Interstate 41, State Road 28 and Stathe Road 45.

and family time. He has served as village president since April 2015.

The Kewaskum Village Board accepted the resignation during the regular board meeting on Monday, Nov. 1. The board then discussed appointing a trustee at the Nov. 15 meeting to fill the president position, a move that Scheunemann supports.

“First and foremost, I think anybody on this board is qualified and would make a good village president,” Scheunemann said at Monday’s meeting. “The board can do what it wants, but I would urge that we appoint somebody from the board to fill out this term.”

Whoever is appointed village president will serve in the position for the remainder of Scheunemann’s term, which ends in April 2023. The plan is to fill the vacated trustee position in the upcoming April election.

The following is Scheunemann’s resignation letter:

Dear Village Constituents:

As of today, Oct. 26, 2021, I sit as a director or officer on six different non-profit/charitable organizations, including serving as Village President. Also, I have several business locations operating at present in very challenging supply chain and labor circumstances. These other organizations will need more of my time and attention in the future. After a long amount of prayer and consideration on how to best focus my community service and family time, I must submit my resignation as Kewaskum Village President, effective 1/1/2022, in favor of a successor that can dedicate the necessary future time and attention to the position.

I appreciate the honor serving as your Village President the past seven years. It is with great appreciation and celebration I want to talk about some of the great community blessings that happened since I took office in 2015, thanks to the generous and civic-minded constituents we have in the Village of Kewaskum (in no particular order of importance):

1.) Blessing #1: Reigle Family Park. KYSO and KAA were looking for more park space in early

2015. There was a plan for these organizations to buy a piece of land outside of the Village to make a park. This is where we can thank the Kewaskum Statesman for printing the proposed plan. James Reigle, founder of Regal Ware, longtime Kiwanis member, saw the article. Several KYSO, KAA lead-

ers, former Village Administrator Heiser, and myself, met with James Reigle about the possibility of the Reigle family donating the 30+ acres for a park. I had the privilege of knowing James Reigle since 1995 since joining Kiwanis at the age of 23. We worked together for over 20 years to build the community through youth and family investments through Kiwanis. It took the decades of “trust” we had working together in the community to make this generous donation happen. This is why community service outside of government is so very important. Several community organizations, many constituents, and volunteers spent countless hours developing this Family Park through a large private sector civic effort. Reigle Family Park officially opened this year. It is certainly a jewel of the community that will be enjoyed by generations to come.

2.) Blessing #2: 9/11 Memorial & Education Center. One of the many early community conversations about this memorial in 2011 happened at a Kewaskum Kiwanis meeting. The discussion involved obtaining a piece of steel from the World Trade Center as a memorial for the local young woman we lost on that awful day, Andrea Haberman. At the time, the idea was just to display the piece of steel. A few years later, and after much effort, the Village of Kewaskum received the piece of steel. By 2015-2016, a full blown 9/11 memorial was in the works and planning. Again, this was pulled together and funded by several community groups, countless volunteer hours, and a large private sector civic effort! Although, it was not always an easy process, we found the right piece of Village land for this memorial to reside on. There is a lot to be thankful for here, but my personal highlight, and personal joy, was testifying before the Wisconsin State Assembly in designating Hwy 28 as the 9/11 Memorial Highway through the Village of Kewaskum.

3.) Blessing #3: Bold Steps to fixing Tax Incremental District #2 “TID District”. Even before

being elected Village President I led the effort to declare this district “distressed”, allowing more time for the Village to recover debt on the district. At that time, even keeping the district in place until 2035 was not going to recover all the debt. My very first act as Village President in 2015 was to sign refinancing documents to save close to \$500,000 in interest on the TIF district. I brought forward, and thanks to Village Board, we instituted a very controversial “Tax Utility District”

designed to tax the TIF shortfall to property owners in the district that refused to develop and contribute much needed tax increment to balance the district. Even though we never, officially, levied \$1 in tax money through this Utility District, it was enough to get the squatting “Big Bank” out of the District (that was pretending to foreclose on the private party, but really doing nothing). This immediately, freed the land up for residential and commercial development that added millions of dollars in increment to help stabilize the TID District the past 7 years. Developers, anxious to avoid the potential Utility District Tax, came to a Village Board with an agreed upon development plan to develop the TID! This added millions of dollars in development in the TID every year.

The Village Board also, more recently, agreed to develop a new “Donor TID #3” inside existing TID#2 to further get an extra \$3.5 million in residential development along Prospect Street, and also allowed the Village to acquire the 13-acre commercial parcel for no money from the developer. We have some commercial parties interested in that 13-acres at this time, and the Village having that piece of land is a valuable lever for future commercial development. We are now projected to retire the TID Districts, paid in full in 2033, perhaps in 2032, if everything continues to go well. The primary TID bonds will be paid 100% in full in 2028, a short 6 years away. Between 2028 and 2033, the Village will recover any deficits in increment lent to the district from 100% of the tax flows of the District with bonds paid off. (I will indicate the top priority for the next Village President will be fostering this 13-acre commercial development piece home for the taxpayers.) We have made bold decisions together as a community to fix this district and it will continue to require some bold decisions to get one of the last pieces of this puzzle developed for the remaining 13 acres of Village owned commercial space.

I certainly have to thank all the Village Department Heads who constantly carry out their jobs with little acknowledgement or “thank you” for a job well done. Thank you to the citizens for allowing me to share a few of the joys and thank you for the blessing of allowing me to preside over the “Golden Age of the Village of Kewaskum”, a complete credit to what the great citizens of this Village have accomplished together!

The initial resolution authorizing general obligation bonds in an amount not to exceed \$28,420,000 states the following: Be it resolved by the School Board of the Kewaskum Area School District, Fond du Lac, Sheboygan, and Washington Counties, Wisconsin, that there shall be issued pursuant to Chapter 67, Wisconsin Statutes, general obligation bonds in an amount not to exceed \$28,420,000 for the public purpose of paying the cost of site improvements, new construction, renovation and modernization of Kewaskum Middle School and Kewaskum High School and acquiring furnishings, fixtures, and equipment related to the same. The unofficial results were 4,654 to 2,989.

In Honor of the Kermis

“Years ago I remember the saying was: ‘There’s only two kinds a people in this world. Those from Ashford, and those that wish they were from Ashford.’” Ray Thelen (1931-2017) said it jokingly, but his hometown pride was unmistakable. This article is in honor of St. Martin’s past and their elders so proud of the “The Kermis,” which was so widely attended—even by those who wished they were from Ashford.

Defining ‘The Kermis’

St. Martin’s Church was established in Ashford Township in 1847, and was named in honor of St. Martin of Tours, France. Like all Roman Catholic Saints, St. Martin has his feast day. His falls on November 11th, the day he was buried in 397. Somewhere along the line in the second half of the 1800s, somebody in Ashford decided to throw a dance and party for the feast day. This celebration was around November 11th above “the hall,” the existing bar that still stands on Highway 67 in Ashford.

This celebration was also a meal, as there are recorded stories of food being served at these events. Although apparently no annual kermis was alike, it appears many kermises of the early 1900s consistently included two nights.

Records indicate that the party was often on the weeknights, likely to keep true to honoring the feast day of the 11th. Given that most of the

attendees were farming, a ‘weekend’ festival wouldn’t have made a bit of difference. Their cows still needed to be milked twice daily all seven days of the week. Accordingly, the dances were in the evening going into the twilight after the nightly milking.

It also seems that the kermis, in some eras, was not intended to be a church-affiliated event. Therefore, a celebration to honor the feast day of a Roman Catholic Saint was used by a local saloon to celebrate with the neighbors. We are left to debate if St.

Martin’s of Tours, who some consider the patron saint against alcoholism, would have endorsed it.

The word kermis has been spelled half a dozen ways over the past hundred years. It was spelled “kirmess” in November editions of the Campbellsport News in 1911, 1919, and 1926; “kirmes” in 1928, 1937 and 1966, and “kirmis” in 1942. Today it is spelled “kermis” and sounds like a variant of Kermit the Frog. However, those over 80 have a tendency to pronounce it “CARE-mis.”

However you want to spell it, the crowd was large. “Approximately

500 persons were served at the kirmess supper held at the Frank Fell Hall in Ashford last Thursday night. The supper was delicious and brought forth great praise from all who attended. A dancing party was held in the hall following the supper,” (Nov.18, 1926). There was no other numbers in that report, so it may be a mistake. But if it was true, what was it like having 500 persons eat at one location in Ashford? If 500 was a mistake, two years later: “Over 200 tickets were sold at the Kirmes Dance here Monday night,” (Nov.15.1928).

Kewaskum School District approves budget

The Kewaskum School District Board of Education approved the 2021-2022 budget on Monday, Oct. 25.

The \$28,665,976 budget is an increase of 0.56 percent over last year's budget of \$28,506,883. Student enrollment in the district on the third Friday in September was up 36 students from last year, with this year's count at 1,787, compared to last year's third Friday in September count of 1,751.

The budget included revisions from the preliminary budget based on decrease in student membership, a decrease in the parochial voucher tax and an increase in grants the district received.

Two of the major grants in the budget included a \$51,069 mental health grant to train teachers and counselors on how to best meet the increased mental health needs of students and a \$180,262 COPS grant to upgrade the district's emergency radio equipment and the schools' public announcement systems.

The board also approved keeping the school district levy at \$11,299,763, the same as it was the previous year. By keeping the levy flat, the tax burden related to the school district will not increase. The board was able to allocate extra funds to either prepay the district's debt or lower potential tax increases in the future because of the district's fiscal responsibility and use of levy management strategies, according to a press release from the district.

"I'm excited to see the board take a very proactive approach to using the levy to prepare for the future. Many districts are utilizing levy management as a way to either lower the district's debt and save future interest payments or to relieve future tax increases that may come in the state's next biennial budget," said Dr. Mark Bazata, district administrator of the Kewaskum School District.

This year's budget includes the use of federal COVID-19 relief funding (ESSER).

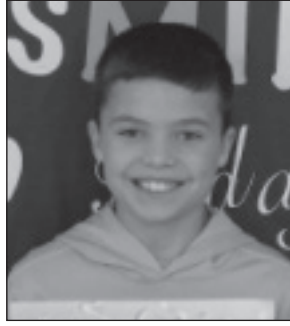
"Because the State of Wisconsin will not be increasing revenue limits, which determines districts' budgets, for the next two years, districts have been forced to use the one-time ESSER funds to pay for rising costs. Unfortunately, these funds do not address the long-term financial challenges of districts across the state," Bazata said.

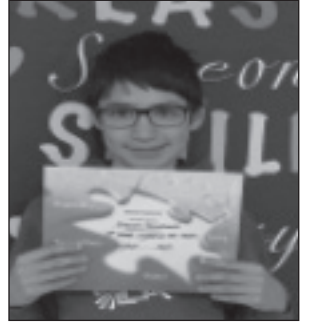

Where the profits ended up remains in question.

This year on the morning of November 14, you can get your chicken dumpling soup and chili, or homemade dessert. All of this exists to sustain the church's structure for posterity, including the finishing of the new roof. The transition from a dance hall event to a soup and chili special has many evolutions in between. The "Ashford Kermis" became a more delineated annual parish fundraiser in recent years, and the focus below is a tribute to the old days prior to 1950 when "the hall" in Ashford was packed to the gills.

Kermis Origins

Joan Meyer spent many hours at the library searching through old Campbellsport News from Novembers' past in an effort to learn more about the history of the kermis. Perhaps her most significant find was the 1942 (Nov. 5) edition, where

the front page had a small story of three paragraphs with a headline: "Ashford Kermis For Over 60 years."

The News reported in the first sentence: "Ashford Kermis, an event that has been going on for over sixty years, will again be celebrated the usual evenings, Wednesday and Thursday, November 11 and 12, at Schill's Hall." This is important, for it suggests the kermis might go back to 1882, and that the "60" in the headline was not a numerical error.

The source for the Campbellsport News? "Joe Serwe has been selling tickets for this event for the past 52 years, and he knows the Ashford Kermis was held before then. During this whole time, it has been held in the same hall." This Joe Serwe is apparently tied to another Joe Serwe, who presently lives in Ashford Township. Joe's dad is Alois (Al) J. Serwe (1930-2016): "a 4th generation and lifelong member of St. Martin Parish," according to his obituary.

Al's father was Mathias Serwe (1900-1950), whose father is the Joseph Serwe (1863-1942) cited in the 1942 article. Coincidentally, old Joe must have passed shortly after the article. If Joe sold tickets for the event for 52 years, it takes his service for the festivities back to 1890.

The 1942 article cements the location of the Ashford Kermis and is central to those seniors who retain the memory of the greatest party in the area. Many with roots from St. Martin's Parish over the age of 80 will vouch that the kermis was the party of the year. Old Joe Serwe's comments published in 1942 serve as evidence that the kermis was consistently held at the tavern in Ashford and also an established tradition by World War II.

A Neighborhood Celebration

Serwe's apparent certainty that the event was going on seems to plot the start of the kermis potentially as far back as 1882, when Chester Arthur

was our 21st president (1881-1885). We can say for certain the tradition has been going on since the Gilded Age, a historical era known for its excess wealth, forgettable presidents, growing industrialization, and burgeoning cities.

Ironically, the story of the Ashford kermis is the opposite in thought and just as important. The theme was small town, rural Wisconsinites coming together as the harvest was complete, and the weather was to turn cold for the winter. Many joked in interviews for this topic that the weather was never really great for the kermis. Nothing like a celebration when it's cloudy, all the flowers are dead, the fields are brown, and noses start to run.

As these farmers were proud to be done with the major crops, they were probably still wondering if they had more firewood to pile for winter. Of all the stresses of 1890s living, it was

the kermis that could remind them of the best of times. Beer, dancing, and conversation with neighbors and old friends were all motivational factors for making the trip to Ashford. An additional perk was the range of participants, which extended from South Eden, Campbellsport, and St. Kilian. Those are all vouched by articles, but the kermis attendee-zone probably included Lomira and Eden. And that is not even including the families who had moved away or loved ones who had married and settled out of town who came back for the annual festivities.

Ashford Pride on the Porch

Another perspective that stands out for the kermis is the collective memory of Jack and Rita (Koch) Babler. This summer we sat on their porch, and they recalled Ashford in its prime. Rita lived out in the country northeast of Ashford, but Jack grew up right in town with his dad running the cheese factory. They graduated from St. Martin's grade school, married in the 1950s, lived in Waupun, and then came back to the township they admire. Jack reminisced about the businesses in town, including the cheese factory ran by his father. When it came to the kermis, he fondly recalls the vehicles in Ashford lining all the way up and down what today is

Highway 67. There was overflow parking at St. Martin's Church, as well as the lawn of his house.

Jack's family, however, was not from Ashford; but Rita's roots are entrenched in stories of Old Ashford Township. Rita recalled: "The kermis [she pronounced it care-mis] was going on for years and years. I could remember my grandparents, Jake and Elizabeth Stoffel, talking about going with horse and buggy to the kermis dance." "Yes," Rita affirmed, she was told directly from her grandparents, and it would have been held at the tavern still open today.

Rita's mom Mary was firstborn in her family in 1912: "She was baptized Mary Elizabeth but a lot of people called her Marie." There's a feeling that Jake (1884-1955) and Elizabeth Stoffel (1891-1968) may have rode that buggy even before their children came in the 1910s. If that's the case, the story of Grandpa and Grandma Stoffel riding into Ashford occurs late in the first decade of the 1900s, when the Raffenstein's owned the tavern and hosted the kermis. This leads to another question: who babysat the children when parents left for the kermis? Some farmers had grandparents in the house, but many, even the old, wouldn't miss an opportunity to come to Ashford on November 11th.

Raffenstein's owned the tavern in Ashford that presently still stands. This postcard is marked June 9, 1910, in Campbellsport and was mailed to "Schleisingerville, Wis." (Slinger). To understand the kermis, one has to understand what the old town looked like. Ashford in the mid-1900s was an impressive hamlet within the township with the same name, this strip on today's 67 between Campbellsport and Lomira had most of what was needed to live. This included the Janous Blacksmith Shop and Brath's General Store. For context, Audrey (Thelen) Ruplinger said it's important to point out there was more than just the existing tavern pictured above. When she married her Leander in 1956, "The Fleischmans—John & Paula were still in that lower tavern...There were two taverns in Ashford. One on the lower end which is still going, and then the upper one burnt down." The fire is in reference to the tavern on the St. Martin's side of the road closer to the church, which was lost in the 1980s. In the 1930s it was owned by John Erikson; the one that still stands was owned by the Raffensteins in the 1910s, Fells in the 1920s and Schill's into the 1930s. 18:26 with Logan finishing in 97th place, a step ahead of Skyler in 98th.

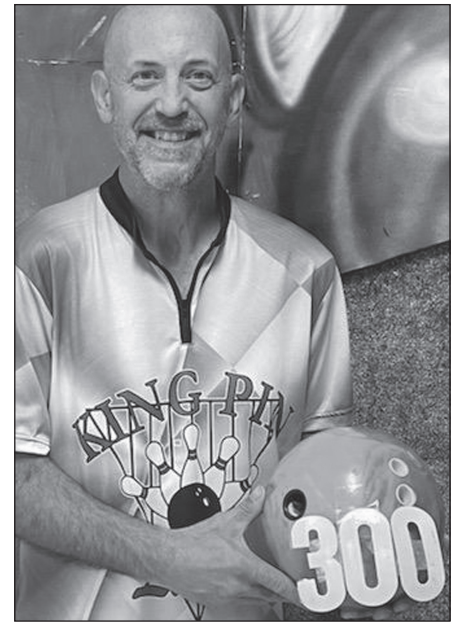
Matt Schrank bowls 34th perfect 300 game

First Deer

Hello friends,
Last fall, Michelle Chiaro, who is an ICU nurse and a mother of four, took part in her first bear hunt.

This spring, I was sitting with Michelle when she harvested her first turkey, which was a dandy and is currently at the taxidermist, where she is having a full body mount done on it.

This summer, Warren Bartels, who reads this column in The Price County Review, gave Michelle a Horton "Summit 150" crossbow. Michelle has been practicing with her bow ever since, and this fall she began bow hunting for whitetail deer, and to date we have sat in the woods 16 times together, and that is what this week's column is about.

In reality, this story began with Michelle running bear baits with me for three summers before she got a tag and deciding that she liked bear hunting, or should I say hunting all together.

Eighteen months ago, I was given permission to put a food plot on my neighbors' land behind my house and began the huge job of clearing land with a chainsaw and a rototiller. I put trail cameras on the plot, and there were some big bucks working it with regularity and lots of does.

Last fall, I could not get an antlerless tag for the

zone my plot is in, and there was one buck that was a pure sumo working the plot all summer that I hoped to put an arrow in. Here is another interesting fact. I go on some really cool bow hunting trips; if I fill my tag in my plot on

Sept 20, those trips do not happen. So as crazy as this sounds, the two years that I have had my food plot, I have been a spectator.

So, on opening weekend of bow hunting, Michelle took off work and we sat in a ground blind on the food plot, and I had even planted European wheat in the spring to hide the blind. She had a doe tag as well as her buck tag, and long story short, after six hunts in a row morning/night, we decided that we like sitting in a tree over on the ground.

On almost every hunt we saw deer, and what was very interesting was that for the most part the deer that we saw could care a less about the food plot as they were eating acorns. Michelle and I had our stands placed about 60 yards apart, and to be perfectly honest, hers was the one that was going to get the action.

Our morning and evening hunts always started out in the dark or ended in the dark. For me, it was like watching a movie as we generally had one or two deer experiences a hunt, and I could have easily taken a six-pointer on one of the hunts, but had plans and wanted Michelle to have the action.

I mentioned earlier that we started hunting in portable tree stands. I always make sure Michelle makes it up the tree and then I climb part way up,

hand her crossbow to her, and then climb down and go to my tree. When our hunt is over, I climb back up her tree and get her bow.

What I am getting at is that it is pretty cool to watch a gal who is pushing 50 go 16 feet up climbing sticks make the maneuver on to a stand and do it effortlessly. I have helped introduce a couple of dozen people to hunting from a tree, and my number one teaching rule is both hands and both feet count, if something goes wrong, you still have three to count on.

So last Tuesday night I am watching the movie, which is Michelle bow hunting and the forest in general. A large doe was, as usual, feeding on acorns, but this time it was heading Michelle's way.

I mentioned earlier she practices a lot with Warrens bow and she can hit both shooting free hand and from a rest in a tree stand. When the doe was about 20 yards away, Michelle let a bolt fly, and that is how she was introduced to and got her first deer, which was a very large adult doe.

It is very cool to meet someone, whether they are 10 or 49, who wants to hunt, but does not have a clue how to hunt, and teach them how to hunt.

Next is my turn, I am headed to the Chippewa River near Durand, where I will travel by canoe, sleep in a tent and spend my days in a tree. No cares on the size of the rack, just want to make some meat and a memory.

Live like there is no tomorrow! Sunset.

Another question for the horses was where they were left parked for that night in the 1910s. There had to be a livery stable(s) for the horses stationed. Since cars entered the scene steadily by the 1920s, the oldest living today claim horses as a common mode of transportation had faded by their childhood.

"We had horses on the farm, but that was for work horses," Rita said, pointing out that by her childhood in the 1930s and 1940s, nobody took horses to the kermis. However, when horses were needed, the common path from the Stoffel (now Joe Koch) farm ran a direction south on hills and fields to what today is the vicinity of Willow Lane, the road continuing north of where the Katzenberg ends. From there, a hard right turn will take you west into Ashford. This was the path taken likely by Jake & Elizabeth Stoffel for the kermis around 1910.

Rita was asked how far the kermis went back in history, and she was not sure. Her memories are particularly valuable as she provides a link to her grandparents, and therefore a connection to a kermis memory that probably goes back 110 years. There are more stories farther back on this tradition. Help us find them.
