The sidewalks of Main Street were packed from the bridge up until the corner, as the massive procession took more than an hour dazzling

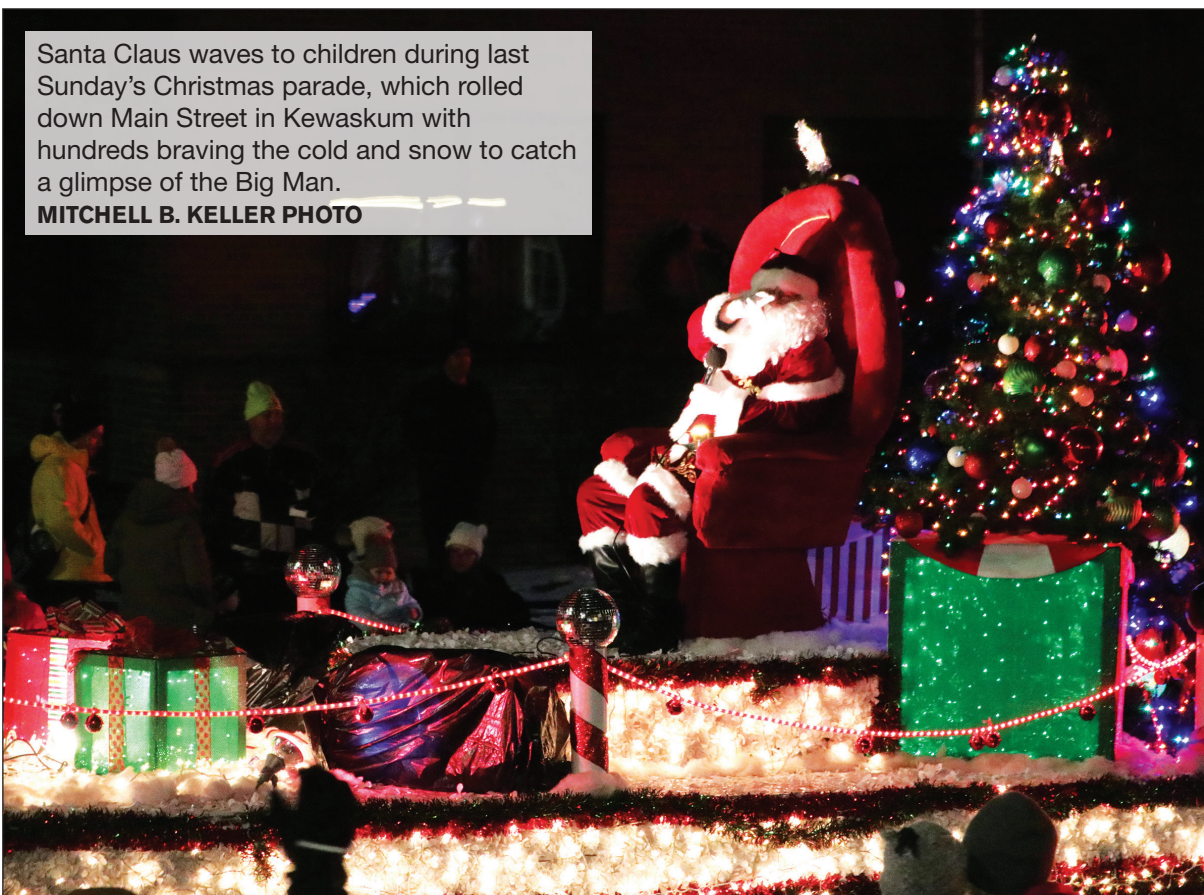
hundreds of spirited onlookers.

County Executive Schoemann's Statement Regarding the Nationwide Injunction out of Louisiana Preventing CMS from Enforcing a Vaccine Mandate for Healthcare Workers

I was thrilled to hear the news regarding the nationwide injunction out of Louisiana, preventing the Centers for Medicare and Medicaid Services (CMS) from enforcing a vaccine mandate for healthcare workers. We have heard from dozens of healthcare workers throughout Washington County, including here on our Samaritan campus, terrified of the prospect of choosing between their conscience and their profession. With this injunction, as well as the more narrow injunction in Missouri, I am certain there will be successful litigation that will go a long way to ensure that we don't put our healthcare workers in an unnecessary ethical dilemma, and that we don't jeopardize healthcare funding for our poor and elderly in exchange for political wins with ill-conceived mandates.

I continue to strongly encourage people to get the vaccine that's best for them as their conscious and personal health allows, and I also strongly support those who object to the vaccine for the same reasons.

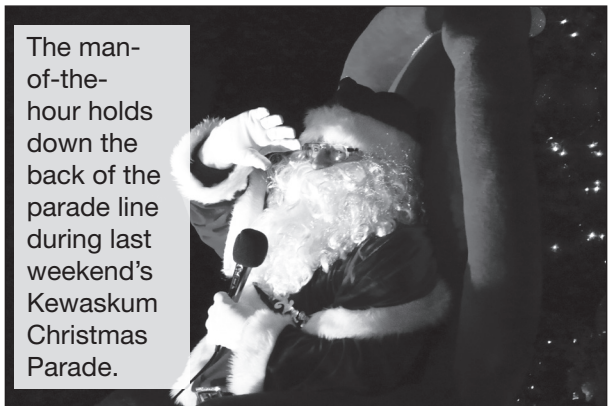

Virginia Lou Kettling



Virginia (Reuthe) Kettling, 89, of Cedarburg, was reunited in Heaven with her beloved husband, George, on November 22, 2021. She peacefully passed from her home at Lasata Care Center with two of her daughters by her side.

Ginne (as she was best known) was born in August of 1932 in Toledo, OH, the youngest of eight

children.

Ginne was a strong, dynamic, and accomplished woman, who touched many lives around the world through, not only her career, but also her thoughtfulness. Ginne's hard work and dedication were rewarded in so many ways, and she was extremely proud of all of her achievements.

Ginne graduated from Capital University in Columbus, OH, in 1955 with a Bachelor of Science in Nursing and received her Masters of Arts in Guidance and Counseling from Ohio State University in 1962. Originally, Ginne had plans to become a missionary, but God had other plans for her.

She married the love of her life, George, in June of 1962. They shared 51 incredible years together, creating a loving and caring family of their own four children, as well as many "extended family" members they gathered along the way. Ginne's career grew from RN to Dean of Students at the University of Cincinnati, nursing administrator as well as VP of Nursing at both Christ and Bethesda Hospitals in Cincinnati, OH, Mt Sinai Medical Center in Milwaukee, and United Samaritans Hospital in Danville, IL. When she and George moved to Cedarburg, Ginne continued her career as a parish nurse for Luther Manor as well as Advent Lutheran Church. Ginne finally retired in 2007, but continued her caregiving for George. For both of them, their favorite place was simply with each other.

In 2017, Ginne received the Albert Nelson Marquis Lifetime Achievement Award for achieving career longevity and demonstrating unwavering excellence in her chosen field of Nursing.

For the past 13 years, Ginne's home was the Lasata Senior Living Campus, where she continued to shine her light on the world, through volunteering and just loving others for who they were. Living her life independently as a caregiver herself, it was hard for Ginne to accept others taking care of her. She certainly lived her faith, being true to her many friendships, and showing compassion for those in need. Throughout her most recent challenging days, Ginne did her best to take one day at a time, and always took the time to thank those who cared for her.

Ginne will be remembered as a thoughtful, generous, kind soul who stood up for what was right, rooted for the underdog, and had quite a sense of humor. She always looked for rainbows, as they were a comfort that George was near and that God heard her prayers. She and George shared a soft spot in their hearts for all animals, especially cats, and they adopted several during their life together. In her later years, Ginne loved to play cards and especially loved doing jigsaw puzzles. She also delighted in hearing about her grandkids and in simply watching "her birds" outside her window.

Ginne was preceded in death by her parents, her three sisters and four brothers.

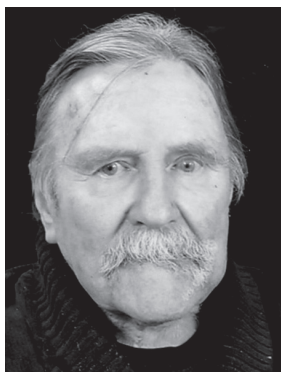

Locally owned Regal War Inc., producers of aluminum and stainless steel cookware, will close its popular outlet store. The closure comes after the company sold its factory here on Second Street. Regal Ware offices on Reigle Drive were not part of the deal. The \$3 million sale became official on November 21. Roadster LLC owner and president Chris Coakley said he sees a lot of potential in the community for growth. Coakley owns 14 buildings with 2.7 million in combined square feet. He already has leases with three tenants in the former Regal Ware factory.

The Kewaskum Board of Education approved naming the high school's football field and track a complex. That complex will be named after a former principal and coach. Perhaps one of the best things about living in the country is interaction with the animals out here. Not that mine is very much, other than breaking up a few dry bread crusts for the neighbor's barn cats.

But many different kinds of critters show up on this less than an acre wedge of land. Of course, squirrels, chipmunks and gophers. Most city folks see those in their backyards. Then

there are opossum, rabbits, woodchucks, weasels and raccoons. Once a young fox, maybe orphaned when its mother was killed or caught in a trap, foraged on windfall apples.

Deer scramble through the underbrush and saplings on the sides of Marblehead's version of Dundee Mountain; a slag heap of unusable rock and gravel. Before the tree line which angles diagonally towards the road just north of town was thinned out, the foliage provided ground-cover for pheasants. Often roosters would lay in the warm sun on the asphalt.

Wild turkeys can be seen in ditches or fields bordering back roads, such rustic lanes as Kelley and Lost Arrow, for example. For those who fill feeders, birds range from English sparrows, black crested nuthatches to cardinals, wrens, blue buntings and woodpeckers. A rare treat is

the flashy plumage of gold finches, probably one of the most skittish of the entire flock.

This abundance of wildlife not only enhances daily routine. It also endows special meaning to every living creature. You don't have to be a Zen Buddhist to appreciate that every life is sacred. A gift from God.

Unfortunately, not everyone holds the same view as proven by the traffic which roars past – often hitting highway speed before the increase noted by signs down the road apiece.

Could be they just take nature for granted. Even if they hail from these parts. And that's the biggest loss of all.

ensures safe driving conditions for all of us in winter,” State Patrol Superintendent Anthony Burrell said. “Drivers should stay off the roads as much as possible when snow hasn’t been cleared yet and keep a safe distance when traveling near a plow.”

There were nearly 3,400 crashes involving snowplows in the past 10 years (2010-2020). Four people died and 533 were hurt in those incidents, many which could have been prevented with careful driving.

Many crashes between snowplows and other vehicles happen when a plow is rear-ended, often by a driver traveling too fast for conditions.

State law requires drivers to stay at least 200 feet behind a plow clearing ice or snow or laying salt or sand on a highway with a speed limit more than 35 miles per hour. Drivers should stay at least 75 feet back from a plow on a road with a slower speed limit.

The State Patrol also encourages the following winter driving tips:

- Snow means slow. Allow extra travel time, following distance, and reduce your speed during winter conditions.
- Road conditions in front of a plow will likely be worse, but if you must pass, be careful. Plows often create a cloud of snow that can obscure vision.
- Drivers who get stranded during a winter storm become hazards that interfere with snow removal ef-

ports. If possible, stay off the roads during severe winter weather and wait until conditions improve.

• If you must travel, check 511 for conditions or incidents along your route. Have a fully charged phone and an emergency kit in your vehicle.

• Buckle up and put your phone down

while driving. Every trip, every time.

These careful driving practices can help keep every driver and highway worker safe throughout the long winter season in Wisconsin.

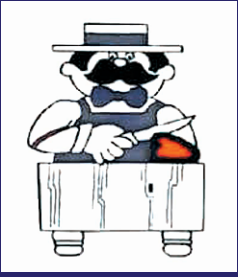
