Kewaskum Students Raise \$260 for Albrecht Free Clinic

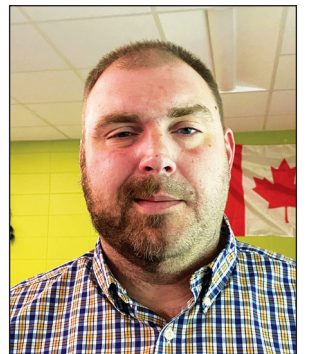
This November, the Kewaskum High School student council sponsored a NO SHAVE November for four of the staff members at KHS.

The Whole Picture on Voucher School Funding

In recent weeks, residents of Wisconsin were exposed to the annual round of news stories discussing the adoption of school district budgets in their communities. While the information contained in these stories helps to inform citizens of the decisions their elected school board members have made, the stories are more often than not the narrative school district administrators present. Not surprisingly, these narratives set out to justify and explain any proposed tax increase.

School districts are primarily funded through the state equalization aid formula and local property taxes. Equalization aid is based on enrollment and property wealth, calculated on a per student basis. After accounting for state aid, school districts are allowed to levy property taxes up to the amount of their revenue limit, which is also set by state law. School districts with higher property values per student rely more heavily on property taxes, while districts with less property value per student receive a larger share of support through state equalization aid.

A common scapegoat for the decision to increase property taxes is to offset the loss of state aid from students who left their resident school district to enroll in a private voucher school. State aid is, for the most part, given on the basis of enrollment. Funding mechanisms to smooth finances exist for districts who lose students. A similar financial impact exists for school choice between public schools, also known as open enrollment. Common sense says that when a student leaves a school for another school, public or private, the money for educating of that student goes with the student. While

it is unsurprising a school district views education policy primarily through its own budget, as parents and taxpayers we should look at the whole system. I believe children are best served when state support follows the child, not the address of the child's parents.

While emphasis is often put on the state aid offset and the taxpayer "costs" associated with students who leave public schools for private voucher schools, there is rarely any mention of the net taxpayer savings. The average voucher value across the statewide school choice programs for 2020-21 was roughly \$8,500. By comparison, the average revenue limit per student for school districts for the 2020-21 school year was \$10,942.

According to the non-partisan Legislative Fiscal Bureau, Wisconsin's school choice programs represent a net savings to taxpayers assuming about three-quarters of voucher students would otherwise attend public school in the absence of a voucher. Evaluations of school choice programs throughout the country have found that roughly 90 percent of students who don't receive a voucher in a voucher lottery end up attending public school. Therefore, it is reasonable to extrapolate that each student enrolled in a private voucher school represents approximately \$2,500 in net savings to Wisconsin taxpayers.

School choice in Wisconsin is a viable alternative to public education. In many cases performance of choice students exceeds public school students of comparable socioeconomic statuses, and it represents a bargain for taxpayers. If presented with a narrative about the school financing impacts of school choice, it is important we remember there is often more to the story.

Campbellsport Village Prepares for Spring Election

The Village of Campbellsport is preparing for the 2022 spring elections, and has provided the following information in advance of the April vote:

Incumbent Village of Campbellsport Trustee Mark Reseburg announced last week that he will not be seeking re-election in 2022. Reseburg cited that, due to the hours of his new employment, he is unable to make meetings and have the time to devote to the position. Reseburg' filing of non-candidacy creates an open two-year trustee term in the April election.

In addition to Reseburg, Trustee Dan Boldt resigned his position in August. This leaves an open one-year trustee term on the April ballot.

Village of Campbellsport Trustee seats expiring in April also include Gene Wenzlaff and Marianne

Jarmuz; both are planning to run for re-election.

Village residents interested in running for a Village of Campbellsport Trustee position in the spring election could begin circulating nomination papers on Wednesday, Dec. 1.

Nomination papers can be obtained from the village clerk or on the Wisconsin Election Commission website.

All candidates will need to complete a “CF-1 Campaign Registration Statement”, “EL-162 Declaration of Candidacy” and “EL-169” nomination papers for non-partisan office with 20 fully completed signatures. All signatures must be from village residents.

All forms need to be turned in to the municipal clerk on or before 5 p.m. on Tuesday, Jan. 4, 2022.

Incumbents who choose not to run for re-election must submit a declaration of non-candidacy to the municipal clerk no later than 5 p.m. on Friday, Dec. 24.

If any other incumbent files non-candidacy paperwork after that date, an extension for candidacy paperwork will be granted.

The general election will be Tuesday, April 5, 2022.

If a primary election is necessary, it will be held on Tuesday, Feb. 15, 2022.

The new term for village trustees begins on Tuesday, April 19, 2022.

opened back in August of 2004, and she never looked back.

"Being a director of a small public library had been my dream job for as long as I could remember," said Wagner. "I used to sit on the floor of the Hartford Public Library and watch the librarians work when I was little."

Last month, the Village of Campbellsport approved Wagner's retirement at their monthly board meeting.

"Leaving my post at the library was really the last thing I wanted to do, but it was time," Wagner said.

For 14 years, Wagner has been struggling with trigeminal neuralgia, a progressive neurological disorder that affects the trigeminal nerves of the face. Because of worsening pain and other symptoms of her condition, Wagner made the tough decision to retire.

"Unfortunately, none of the medical options that are currently available are controlling my symptoms at a level that allows me to function at a normal pace," Wagner said. "My team of doctors is adamant that my best medical plan right now is to let my body rest as much as possible."

Being told to rest is hard for someone like Wagner who loved her job.

Creating relationships with patrons, volunteers and co-workers, as well as daily problem solving were the highlights of her career.

"There were many times people came into the library with raw emotions because they needed help with a sensitive problem or because they were going through a very difficult situation," said Wagner "Finding the best way to help these people was not always the easiest, but my favorite memories are of them leaving saying they felt better, or they were closer to solving their problem."

Shifting her focus from the library, Wagner is now trying to find ways to stay feeling her best.

"I have already started reading some of books that the library users told me were great reads that I didn't have time to read while I was working," Wagner said. "I am still enamored with books. Every book holds the possibility of bringing joy and

enlightenment to so many people."

Wagner hopes to enjoy more time outdoors hiking and canoeing with her husband and dog and spending more time with her children and grandchildren in retirement. She also wants to learn new skills like snowshoeing and photography.

As Wagner moves on to a new chapter in her life, she would like to say goodbye to those that were part of the one coming to an end.

"The Campbellsport Public Library is one of my true loves," Wagner said. "My retirement feels more like a bad breakup to me. The library is always on my mind. It has been a privilege to get to know and to serve the warmhearted people of Campbellsport and the surrounding area. I miss all of you, terribly."

KEWASKUM'S DAYS GONE BY**5 Years Ago
December 22, 2016**

For many years, a Christmas tree stood on the top of Keller Hill and shone brightly above the Village of Kewaskum. The longstanding tradition of having that beacon of Christmas joy overlooking Kewaskum ended some 25 years ago. The tradition was resurrected this year, when the Grogan family erected a large cross at the top of the hill, which is located just east of Stark Street and north of Glacial Lane. They draped strings of clear lights down from the cross in the shape of a Christmas tree.

Many Kewaskum students are familiar with Butchie Hafemann because they know that he works in the building and maintenance department of Kewaskum School District. They are not all aware, though, that he also builds and maintains a Christmas wonderland at his Campbellsport home. It is decorated with thousands of lights and hundreds of plastic figurines. **15 Years Ago
December 21, 2006**

What has been thought of as the impossible dream for some Kewaskum High School students is inching forward. Officials stated Monday that work on removing asbestos tile would begin Friday. The project is expected to take about a week to complete so by the time the students return to school on January 2, the work will be done. Plans that had been presented to the board of education members in October are on track. The plans call to remodel Rose Hall by cutting the area in half. The most southerly portion will be a media center for the high school. The northerly portion will be an auditorium that will utilize the boarded up stage that is now home to art classes.

The board of directors of the Kewaskum Youth Scholarships, Incorporated announced that the organization will award 28 scholarships totaling \$85,200 to Kewaskum High School Class of 2007 members. In 1986, the first year of the award, only one \$500 scholarship was available.

The Kewaskum Area Chamber of Commerce donated \$2,000 to the Village of Kewaskum to help pay for the village's annual fireworks display on July 3. The chamber also donated 24 folding tables to the village for use at the Municipal Building Annex.

Principals Christine Horbas and Thomas Fischer are working on developing a block schedule for the Kewaskum School District, much like the system Campbellsport already has in place. High school students currently attend classes that are 45 minutes in duration. It is an eight-period day with four-minute passing time to move from one classroom to another. A committee driven by teachers with administrators, parents and students researched eight or nine different schedule styles. Fischer explained that a block schedule should reduce student class-load to four 90-minute classes. There will be fewer but longer passing periods lasting between seven to 10 minutes. Study halls would be eliminated. There is not a timeline for the board to take action.

Michael Tuyls, 12, Town of Farmington, attended the Crossroads of America National Poultry Meeting in Indianapolis recently. He placed first in the nation in Profiles in Poultry - senior division and fifth in the nation in Showmanship - intermediate division.

Kewaskum's wrestling team placed 10th in the 25-team Marty Loy Classic, which has several strong programs from around the state participating. Eric Ogi, Eric Turowski, and P.J. Krueger each placed second in his weight class.

Corey Darmody of Kewaskum, a junior on the UW-Platteville's football team, was recently selected to the first unit of the Wisconsin Intercollegiate Athletic Conference's all-conference football team. The offensive center received the Battle of the Trenches Award, which goes to the top lineman.

Receiving honorable mention in the WIAC all-league balloting was Tony Fitts, who graduated from Kewaskum High School's football program. He was in the defensive backfield all four years of

his career at UW-Stout. This year, he had 42 tackles (24 solo), and a team-high nine pass breakups.

I would like to share a press release from The Center for East Asian Studies (CEAS) at the University of Wisconsin—Madison.

“CEAS is pleased to announce the winners of the ‘East Asia in Wisconsin Library Program’ competition. Grants have been awarded to public libraries throughout Wisconsin, enriching their collections with new titles that will enable patrons to deepen their understanding of East Asia (which includes China, Japan and Korea). Over \$24,000 in funding will be distributed to 29 libraries, representing 12 of the state’s 14 library systems.

“This is the second year of the competition, which generated a wide variety of programming in 2020.

“We were so delighted with last year’s response that we decided to continue this program,” said Laurie Dennis, assistant director for CEAS. “The 2021 proposals once again reflect the creativity of Wisconsin librarians, who plan to use their funding to bolster existing film, manga, audio and other types of collections, and also to set up community activities and conversations about everything from Wisconsin’s evolving Tibetan community to the Japanese influence on Frank Lloyd Wright. This grant is a way for our center to help library patrons across the state have access to the latest in current events, reference materials, children’s books, literature and film about East Asia.”

“CEAS once again partnered with the Wisconsin Department of Public Instruction, the Wisconsin Library Association, and the Cooperative Children’s Book Center to plan and promote the program. Applicants were encouraged to use a list comprised of hundreds of materials curated by UW–Madison faculty with titles about China, Tibet, Hong Kong, Taiwan, North Korea, South Korea and Japan.

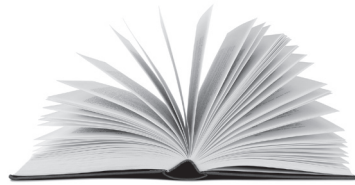
“The East Asia in Wisconsin Library Program is partially funded by a Title VI grant from the US Department of Education. The Center for East Asian Studies (CEAS) is the focal point connecting East Asia to the University of Wisconsin–Madison. One of the UW–Madison’s eight federally funded National Resource Centers, CEAS is dedicated to all aspects of research, education and outreach related to China, Japan, and Korea.”

Kewaskum Public Library is one of the lucky recipients of this grant. What does this mean for the library, its patrons and the community? We will be using the money in several ways. First, we will enrich our print collection with books for children and adults that have been recommended by CEAS. I will work on supplementing our collection with material from the seven countries mentioned in the press release.

Secondly, library programs in the first part of 2022 will be focused on East Asian culture. Some of these programs include Lunar New Year celebrations for kids and teens, a Chinese calligraphy class taught by teachers from the North American Chinese School, a program on Japanese Haiku and a kite making workshop for families.

Lastly, we will be circulating kits which will be classified as “Library of Things.” Look for these in January, many with an East Asian influence.

I am thrilled that the library is one of the recipients of this important grant and cannot wait to share with our community.

The Indians made it very difficult for Ripon to get off any quality shots in the first half, as Kewaskum forced 18 Ripon turnovers and held each of the Tiger's five starters scoreless in the first half.

Kewaskum held a 33-6 advantage - led by 23-combined points from Dogs and Christenson - going into the break.

Kewaskum pulled back the full-court pressure in the second half, and the Indians did not shoot the ball as well as they did in the first.

The highlight of the stanza for the Indians was a slashing basket from Annie Christenson, wherein she eclipsed the career 500-point milestone.

Immediately following the score, Kewaskum head coach

Russell Thull called a full timeout to let her teammates celebrate her accomplishment in front of the home fans.

After the final buzzer rang, Kewaskum won its fifth straight by 20 points, 53-33.

Dogs finished with 21 points and Christenson with 18 points.

Muellenbach Looks to Join Elite Company

Campbellsport High School senior Drake Muellenbach kicked off his final season of wrestling with a bang. Muellenbach gained a forfeit win over Mayville last Thursday and followed that up with a first-place finish in the Gerald "Sarge" Marking Scramble tournament Saturday at CHS. The six victories put Drake at 83 career wins and just 17 shy of joining the 100-Win Club.

Another club Muellenbach is looking at joining is becoming a four-time state qualifier. Only five Campbellsport wrestlers have ever accomplished the feat (Ricky Huspen - a state champ and four-time state place finisher; John Dexter - who won three state titles and placed all four years; Travis Ebert - who won two state titles and placed three times; Justin Schmidt - who won three state titles and placed all four years; and Ryan Costello - who won a state title and placed three times. Costello is also the career wins leader at CHS with 163 victories.

Drake placed fifth at the WIAA State Tournament last year in a shortened COVID season where he won 18 of 21 matches. Muellenbach won 28 matches as a freshman and 31 as a sophomore qualifying for state but not placing. Drake will be wrestling at 120 or 126 lbs. this season for the Cougars.

This past fall Muellenbach helped the CHS football team to a Flyway Conference championship before falling in the third round of the playoffs to eventual state runner-up Mayville. Drake was a second-team All-Conference selection at his outside linebacker position. He played football his freshmen and sophomore year but didn't go out for football his junior year.

Drake is the son of Jeremy and Ashley Muellenbach and has a sister Leah who is a sophomore at CHS. Drake's father was a stand-out football player and wrestler for the Cougars. Drake loves to hunt in his free time, mainly ducks and geese. He has also had steady jobs in high school doing milking for the Koffman and Theisen farms. He is currently working for Adam Petersen at Petersen Custom Concrete. Drake plans to continue doing concrete work after he graduates.

WIAA Task Force Condcuts 2021-22 Conference Realignment Review

The Conference Realignment Task Force assembled and reviewed applications from eight schools in the first meeting of the 2021-22 realignment review process earlier this month at the executive office.

The schools requesting relief from their current conference included Monroe, Delavan-Darien, Kingdom Prep Lutheran, Watertown Luther Prep, Ripon, Berlin, Assumption and St. Mary Catholic.

Some of the decisions would impact News/Statesman-coverage teams' conferences.

The Conference Realignment Task Force did not advance plans submitted by Ripon, Berlin, Assumption and St. Mary Catholic. These schools may appeal the decision to the Task Force at the regular meeting on Jan. 13.

The Ripon and Berlin plans to move those schools from the East Central Conference to the South Central Conference was voted down 1-14. The rationale for the action taken by the Task Force was the absence of feedback included in the proposal from a large group of impacted schools. Additional feedback from conferences and schools impacted by the plan is encouraged.

All schools affected by the realignment solutions the Conference Realignment Task Force modified may provide written feedback or appear virtually at the Task Force meeting Wednesday, Jan. 5, 2022, at 9 a.m. Requests to appear to provide additional information must be emailed to Executive Director Stephanie Hauser at shauser@wiaawi.org by noon on Monday, Jan. 3, 2022.

Each school appearing virtually at the Jan. 3 meeting will be provided a maximum of three minutes to present new information to the Task Force. Schools in the same conference are asked

to designate one spokesperson who will represent all schools. The time afforded to this spokesperson will be extended to five minutes.

The Conference Realignment Task Force will reconvene in person Thursday, Jan. 13 at 10 a.m. Member schools that had their realignment application not advanced may elect to appeal this decision no later than noon Monday, Jan. 10, 2022. Requests to appeal must be submitted in writing to Hauser at shauser@wiaawi.org. A school may appeal by having a representative appear at the WIAA office or appear virtually. Each school will be provided a maximum of five minutes to present new information to the Task Force.

Any schools impacted by a proposed realignment solution may provide written feedback or appear in person or virtually Thursday, Jan. 13. Additional information and requests to appear must be emailed to Hauser at shauser@wiaawi.org by noon Monday, Jan. 10. Each school appearing virtually will be provided a maximum of three minutes to present new information to the Task Force. Schools in the same conference are asked to designate one spokesperson who will represent all schools. The time afforded to this spokesperson will be expanded to five minutes.

The Task Force will finalize and submit proposals for the March 8, 2022, Board of Control meeting following the Jan. 13 Conference Realignment Task Force meeting.

On Saturday, the wrestling team hosted the 11-team Gerald 'Sarge' Marking Scramble. The team took third place, finishing a half-point behind second-place New Berlin West/Eisenhower and 11 points behind first-place Waunakee.

The Cougars crowned four individual champions, one runner-up and three third-place finishers.

At 106 pounds, sophomore Karsten Krueger finished in first place by dominating the weight class, going 4-0 with four first-period pins. Krueger was in a five-man round-robin bracket. It was his first varsity championship of his young career.

At 113 pounds, sophomore Chris Meyer was in a six-man round-robin bracket, and he earned his first varsity championship by going 4-1 on the day. After losing by decision his first match, 10-4, Meyer racked up four straight wins by pin.

Campbellsport started out the day going against Aquinas who is ranked eighth in the state in WIAA Division 3. The Cougars lost 49-24, while winning five matches. Drake Muellenbach and Joseph Volz pinned their opponents, while Ostin Blanchard won 7-4, Sam Koth won 6-5 and Chris Meyer won by forfeit.

Aquinas would go on to take second place, losing in the championship by just three points.

The loss put Campbellsport in the 12-team consolation bracket where the Cougars fell to Whitnall/Greendale, 40-35.
