Tim Michels Launches Gubernatorial Campaign

Tim Michels, co-owner of Michels Corporation in Brownsville, announced his candidacy for State of Wisconsin Governor at a campaign announcement rally at Michels Corp in the village on Monday, April 25.

The 1980 Lomira High School grad will join a crowded Republican field of candidates including former Lt. Gov. Rebecca Kleefisch, business owner Kevin Nicholson and State Rep. Timothy Ramthun

Michels, 59, last ran for office in 2004 against

then-incumbent Senator Russ Feingold. He lost that election as well as a 1998 State Senate election. This will be Michels' third attempt at statelevel office or higher.

Michels cited his lack of faith in current Democratic Governor Tony Evers as his main inspiration for running in the 2022 election.

A U.S. Army veteran, Michels has vowed that he will not accept donation from political action committees (PACs), lobbyists or more than \$500 from any individual.

On a near perfect one, like today (80-degrees and lotsa sunshine) a fella gets a hankering. No matter what chores beckon, a person just can't resist the tug. That comes when he drops

My father use to prowl the local current, or lack thereof in the millpond. Come summer when the water level dropped, he'd flycast off the top of the dam. Occasionally, worked the stream below. Or in the less choppy flow off Stinky Point, where boats weren't always churning up the waves. Most of the time, we stayed loser to home. Winding up down at Lake Bernice. Dad picked a spot where the boats launched, then baited cane poles for us and we went to the bridge farther away. Guess he tired of us snarling all the lines on his flycast rigs. He had what all of us, including Mom lacked. Simply the true fisherman's gift of patience. Often boasted he could sit there and wait as long as the fish could. The whole night if that's what it took. Usually, after the only thing biting was mosquitoes, Mom cajoled him into leaving. When he had a good night, we left with a pail full of bullheads, once even a snapping turtle.

All in all, quite a catch of memories which has stayed with me these many years later.

Newspapers In Education

Our dedicated readers might recall an annual feature this newspaper participated in called Newspapers In Education (NIE).

The nationwide initiative took place every March, and it mostly involved our editorial staff presenting to local students about the importance of our industry. We also provided space in the paper for these same students to write letters to the editor, draw up their own banner ads and create crossword puzzles.

All in all, it is a lot of fun for everyone involved and it made for fantastic content.

As March has come and gone (leaving like a lion, no doubt), it pains me to say that our editorial staff did not explicitly partake in NIE this year.

This was the consequence of myriad challenges, all of which I am growing tired of writing (and I am sure some fatigue is felt by our readers, too). Ultimately, it just was not realistic to ask my newsroom (which has been levied unprecedented expectations, already) to undertake the responsibility. While I trust both Breanna Rice and Clarice Case would be capable at communicating the importance of newspapers to our area children, I believe I should allow them more time – they have only been with us a few months – to experience it first hand before imparting their wisdom.

That is not to say that we haven't been engaging

with the youth.

Last month, I stopped by a classroom at St. Matthew's Catholic School in Campbellsport, and we discussed the role of a newspaper in the village and what opportunities there are working in the news or communications. Those junior-high students were particularly eager to find out that my vocational journey has allowed me to meet folks like Bob Uecker and Toby Keith and has taken me to places as far away as Australia (though this particular class was not keen on a trip "Down Under" because of the spiders, and, take it from me, they certainly have reason to be anxious).

That same day, I participated in a career fair at Kewaskum High School. Especially in this context and setting, I am always impressed by the drive and maturity of teens. Too often, young people are criticized for being "disconnected" or "impatient" though I hardly ever get that impression when speaking to them. I am hopeful some of those KHS juniors who spoke with me that day will look us up for summer work or future internships!

I bring these instances up, because, while our staff did not officially participate in the annual Newspaper In Education program, our newspaper is always *in* local education.

While we have had to shuffle around a bit since 2020, one thing we have increased in all of our coverage areas is our communication with educators

New Policy for Letters-to-the-Editor

This newspaper's publishing company, Multi Media Channels (MMC), has made the following changes to its policy regarding Letters to the Editor (LTE) and political campaign letters:

"All letters submitted as an endorsement for a political candidate, referendum or political, will be charged \$40 per letter of up to 250 words in length. Longer political letters will be accepted but will be charged \$10 per additional 50 words. All political letters must be prepaid prior to printing. Letters to the Editor will not be accepted from candidates running for election or representatives of an organization endorsing their own referendum; those submissions will be referred to our advertising department to be run as advertisements."

This policy is effective immediately and was made in response to a rapidly changing environment. This newspaper values all opinions and has long provided its pages for free to candidates and supporters, however, a significant increase in letter writing from elected officials has caused our editorial leaders to reconsider this practice. As such, all political letters must first pay for advertising before being published.

This change was made across all of MMC's newspapers across the State of Wisconsin.



One Person Missing Following Capsized Canoe on Fox Lake

One female occupant was rescued, but male remains missing

DODGE COUNTY SHERIFF'S OFFICE

Shortly before 12:30 p.m. on Thursday, April 21, the Dodge County Sheriff's Office received a 911 call reporting a canoe had capsized and two people were in the water, yelling for help, near the north shore of Fox Lake.

First arriving deputies were able to determine at least one person was above the water, but a second victim could not be seen.

An adult female, of rural Fox Lake, was recovered from the water and transported to an area hospital for treatment.

An active search [remained underway as of this publication's print time] for an adult male occupant of the canoe. The male is believed to be a resident of rural Fox Lake.

Conditions on the lake were not suitable for canoe or kayak use due to high winds. Neither occupant was wearing a personal floatation device (PFD).

Assisting the Dodge County Sheriff's Office at the scene [on April 21] were the Fox Lake Police Department, Wis. Department of Natural Resources Conservation Wardens, Fox Lake Fire Department and EMS, Beaver Dam Fire Department and Paramedics and the Fond du Lac County Sheriff's Office Dive Team.

[On April 22], the Dodge County Sheriff's Office, Fond du Lac Sheriff's Office Dive Team, Beaver Dam Fire Department Dive Team, Campbellsport Fire Department, Waupun Fire Department, Campbellsport Fire Department, Hustisford Fire Department and the Department of Natural Resources conducted an extensive search of Fox Lake until sunset on Thursday evening. Unfortunately, the male subject was not located and is considered missing. The female subject was treated and released from the hospital Thursday evening.

Search operations continued, however, due to impending weather, and the safety of divers, a full-scale search was not possible [on April 22].

[On April 23], The Dodge County Sheriff's Office, Fond du Lac County Sheriff's Office Dive Team, Columbia County Sheriff's Office Dive Team, Marathon County Sheriff's Office Dive Team, Fox Lake Fire Department, Beaver Dam Fire Department, Hustisford Fire Department and the Wis. Department of Natural Resources conducted another extensive search for the missing male subject.

At about 4:30 p.m., search operations were called off by the dive and boat teams due to high wind conditions on the lake. The conditions made dive operations difficult and dangerous to diving personnel.

Searches will continue in the coming days, but the extent of the searches, and the times and dates of the searches, will not be shared with the public. This is a result of wind weather conditions forecast over the next several days, which make it difficult to predict what search techniques may be feasible without putting divers at risk.

No further information will be available, and we will update the public as more information becomes available.

It kind of looked like he was going to vanish, so I told Conner I was going to try to call him in.


I gave it a try with my dad's Quaker Boy "Little One Sider" box call, and that's all she wrote.

Washington County Drive-thru Prescription Drug Take Back Day on Saturday

The Washington Ozaukee Public Department, Ozaukee Health County Sheriff's Office, Sirona Recovery, Concordia University Wisconsin School of Pharmacy and Washington County Sheriff's Office, in cooperation with the Wisconsin Department of Justice (DOJ) and the Drug Enforcement Administration (DEA), will participate in National Prescription Drug Take Back Day on Saturday, April 30 at the Ozaukee Transit Center in Port Washington, Concordia University in Mequon and the Washington County Highway Department in West Bend (900 Lang St.) from 10 a.m.-2 p.m.

This effort will continue to bring focus to the issue of prescription painkiller abuse in Wisconsin. Drug Take Back Day provides a safe, convenient, and responsible means of disposal, while also educating the community about the potential abuse and consequences of improper storage and disposal of these medi-



cations. Unused or expired medicine should never be flushed or poured down the drain. Water reclamation facilities are not designed to remove all of them and trace amounts of pharmaceuticals are showing up in rivers and lakes around the world.

Guidelines

All waste pharmaceuticals must be generated by a household - no businesses are allowed.

Bring: Prescription (controlled and non-controlled) and over-thecounter medications, ointments, non-aerosol patches, inhalers, sprays, creams, vape cartridges and devices (with batteries removed), vials and pet medications.

Do Not Bring: Illegal drugs, needles/sharps, mercury thermometers, aerosol cans, bio-hazardous materials (anything containing a bodily fluid or blood), flares, personal care products (shampoo, soaps, lotions, sunscreens, etc.), household hazardous waste (paint, pesticides, chemicals, oil, or gas), acids, or any vape devices containing batteries of any

· Liquids will be accepted during this initiative. However, liquids, creams and sprays must be in their original packaging. Liquids without the original packaging will not be accepted.

· Illicit substances such as mariiuana or methamphetamine are not a part of this initiative and should not be placed in collection containers.

Ozaukee and Washington Counties continue to offer permanent drop boxes for year-round prescription medication disposal. Drop boxes are available during regular office hours at police departments around the counties. To find a location near you, visit http://doseofrealitywi.gov/ find-a-take-back-location/.


