West Bend Veteran Plans to Bike to D.C.

The journey will culminate with a special trek from Milwaukee's War Memorial to the 9/11 Memorial in Kewaskum

As the anniversary of one of our nation's most horrific days draws near, United States Marine Corps Veteran Tarra Gundrum of West Bend is planning a bike ride of 1,000 miles to Washington, D.C. to raise money for the Wisconsin 9/11 Memorial educational programs.

"The school-age students of today may not be aware of the tragic events that took place on September 11, 2001. It will take a community of family, teachers, church members and so many more, to ensure our youth learn from 9/11," said Gundrum. "I want to do my part, even in a small way, to help

give students' access to learning materials and the ability to visit this Wisconsin 9/11 Memorial in Kewaskum so they 'Never Forget!'"

The route was sketched out on a napkin, and Gundrum's plan went into full effect after connecting with Fuzz Martin, president of the Wisconsin 9/11 Memorial Board of Directors.

Gundrum will begin her 1,000-mile journey on Aug. 14 with a prayer send-off at Life Church in Germantown at 8:45 a.m., and she hopes to arrive in Washington, D.C. on Sept. 2. She will return to Wisconsin via Amtrak, at which point, on Sept. 3, she will ride with family, friends and community supporters from the Milwaukee

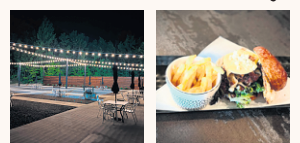

Dear Reader,

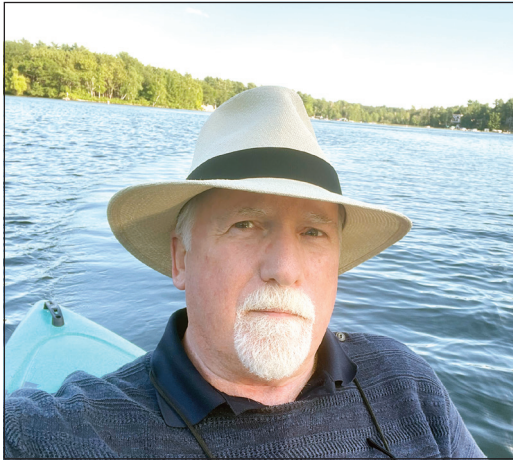

It's that time of year again. You don't have to cruise up Highway 41 north towards Oshkosh. Or even saunter past the Fond du Lac airport to note just about every inch of ground is covered.

That doesn't resonate with me the way it once did. Back in the day, it spelled early morning shifts at the pancake house. Rolling outta bed by 4:30 a.m. It also meant taking on extra provisions in the restaurant.

Hot Weather Garden Woes

Poor flowering and misshapen or a lack of fruit on tomatoes, peppers and squash may be due to the weather, not your gardening skills. Temperature extremes can interfere with flowering and fruit set on these and other vegetables in your garden.

We watch for and can't wait to taste that first red ripe tomato. It is certainly frustrating when we see flowers drop or the plant fails to form fruit. Tomatoes thrive in warm sunny conditions; but temperature extremes can prevent fruiting, cause misshapen fruit, or reduce the size of the harvest.

When daytime temperatures rise above 90 degrees Fahrenheit and night temperatures remain above 70°F blossom drop and poor fruit development may occur. Combine this with low humidity and the pollen is not viable. In hot and humid conditions, the pollen is too sticky and doesn't move from the male to the female part of the flower. Without pollination the flowers won't be fertilized, and fruit will not develop.

Cool weather can result in poor fruiting. Night temperatures below the optimum of 59° to 68°F will reduce the amount and viability of pollen that the plant produces. Less viable pollen means fewer fruit will form. Cooler temperatures below 55°F can result in misshapen fruit and catfacing. Fortunately, the malformed fruit is still tasty and safe to eat.

Temperature extremes also impact pepper productivity. When temperatures climb to 95°F or higher the pollen is sterile and flowers may drop. Small fruit may also fall from the plant during such hot spells. Pepper plants also experience poor fruit set when night temperatures drop below 60°F or rise above 75°F.

Tomatoes and peppers aren't the only vegetables impacted by temperature extremes. Eggplants, a close relative to tomatoes and peppers, do not set fruit until night temperatures are above 55°F. Beans stop flowering or the flowers die when temperatures rise above 85°F.

Flowering in squash and cucumber plants is also influenced by temperature and other environmental factors. These plants produce separate male and female flowers. The male flowers usually appear first and it is not until both the male and female flowers are present that pollination, fertilization and fruit production can occur.

Research found cool temperatures, bright sunlight, and shorter days encourage female flower production

while male flowers are more prolific during warmer temperatures, less sunlight and close spacing. Flowering on squash and cucumbers is also impacted by nitrogen fertilization. Too much can prevent female flower formation while insufficient amounts can reduce the number of male flowers.

The simplest solution is to wait for optimum temperatures and the proper humidity levels to return. Once this happens, the plants will begin producing fruit.

If poor productivity related to the weather is a yearly problem, consider planting more heat tolerant varieties, adjust planting times and look for more suitable growing locations.

When the harvest is delayed, extend the season with the help of row covers. These fabrics allow sunlight, air, and water through while trapping heat around the plants. Just loosely cover plants and anchor the edges with stones, boards, or landscape staples when frost is in the forecast. You can leave the fabric in place for the remainder of the year. Just lift it to harvest and secure the fabric when done.

If this summer's weather leaves you disappointed with the harvest, remember there is always next year.

Waukesha and Washington County Executives and Sheriffs Address Surging Fentanyl Crisis

Washington County Executive Josh Schoemann and Sheriff Martin Schulteis joined Waukesha County Executive Paul Farrow and Waukesha County Sheriff Eric Severson today to address the surging fentanyl crisis in our community.

Our country is in the midst of a drug epidemic fueled by fentanyl, a deadly substance which is now the leading cause of death for Americans aged 18-45. It affects all genders and races in both rural and urban areas. From 2018-2020, the latest data available, the count of opioid-related deaths in Washington County was 16 in 2015 and rose to

25 in 2020.

This year to date, according to the Medical Examiner's Office, that number has already reached 23. Sheriff Martin Schulteis said, "87% of all our fatal overdose deaths this year involve fentanyl. This is a staggering statistic our county can't ignore."

"We need to devote resources to educate and protect the public," said Schoemann. "Our proposed Washington County Anti-Crime Plan referendum will put deputies in schools, add detectives to the Drug Task Force, and partner social

worker-deputy teams to co-respond to mental health and substance use related calls. This plan gives the residents of Washington County the option to choose a proactive approach to combat the fentanyl crisis we are facing."

In addition, the Washington County Health and Human Services Department (HHS) provides other programs and services to connect residents with substance use resources they need. Last month, the county launched a local campaign,

Campbellsport Students Visit Belize

On July 8, four Campbellsport students, Mykala Fabry, Ella Goebel, Mercedes Herrmann and Hunter Sabish, and one parent, Jill Goebel, traveled with Campbellsport teacher-librarian Michelle Rockelman for their long-awaited EF student trip to Belize.

On the first morning in Belize, they climbed the Xunantunich Ruins, an archaeological site that features Ancient Maya temples. Archaeologists were onsite excavating pottery and other artifacts.

The day continued with Mayan cooking and pottery demonstrations. In the afternoon, the travelers went canoeing and swimming.

The next day, students were taught about the process of making a local popular hot sauce. Then the group donned their life jackets and helmets

and cave tubed through the St. Herman's Blue Hole National Park, studying cave stalagmites and stalactites. On the way to their hotel on the Caribbean Sea, the group stopped at a Garifuna museum.

The Campbellsport tour group included two other schools, one from Indiana and another from Minnesota.

The next day started by listening to an internationally known singer and fellow traveler Gorinka,

as she performed the country's anthem. Travelers visited a chocolate farm and learned about cacao trees and the process of creating chocolate. This exposure taught students about the many challenges of sustainable agriculture in Belize.

On Wednesday, July 13, the group confronted the waters of the Caribbean Sea in the nearby Cayes, exploring the first and second largest living reef in the world. While snorkeling, they saw

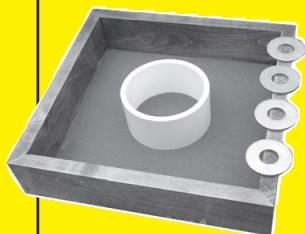

a number of fish including starfish, stingrays and angel fish. Afterward, they were taught traditional drumming and dancing by Garifunas. The rest of the day included dinner at a beachside restaurant, shopping and swimming.

The final full day in Belize started at Green Acres, a Valencia orange organic farm. The group toured the location, learned about organic farming, planted a tree to return to in five years and enjoyed freshly squeezed Valencia orange juice. To celebrate the trip, the group traveled to the jungle to enjoy a zip-lining adventure through the Belize canopy that encompassed six stations, the final one over a river.

The pre-covid version of this trip started as a 2020 tour of New Zealand and Australia. However, this updated version of traveling to Belize contained an incredible amount of activity, beauty, experiences, learning and friendship.

Future student and/or adult trips are in the process of being planned.

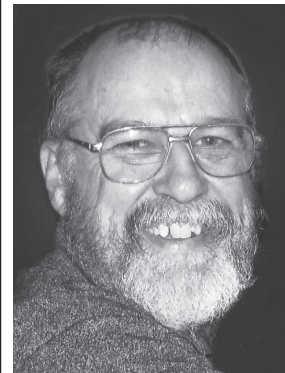

| KEWASKUM'S DAYS GONE BY |**5 Years Ago
August 10, 2017**

Eight years ago, Tim Rohrer was working as a police officer for the City of Hartford. He came home one morning after working third shift and slept for almost 36 hours straight. He slept only a few minutes here and there for the next 10 days. After various tests, including blood work, the doctor decided Tim needed an MRI as nothing had been found with the other tests. Tim had a brain tumor. For the next several months, there were more tests. The tumor wasn't growing so the neurosurgeon told Tim not to worry about it. After six years, Tim sought the opinion of a doctor at Mayo Clinic. On February 9, 2016, Tim underwent surgery. With his wife, a teacher at Farmington Elementary School, with him, Tim had therapy and learned how to move his right arm and hand. Although it was difficult, Tim recently went on to finish a fundraiser walk to raise money for brain cancer research.

Change the Ending (ChangeTheEnd.com) to direct those struggling with mental health and substance use to resources available via a simple online series of questions.

Finding proactive approaches to help people access services and potentially avoid involvement in the criminal justice system can help in their recovery.

Other programs overseen by HHS to address the fentanyl crisis are:

- Washington County HHS has funded a Peer Support Specialist in its Outpatient Clinic in partnership with Sirona Recovery as well as hired an additional full-time Substance Use Disorder Case Manager.

- Washington County HHS and the Washington County Sheriff have partnered since 2018 on providing Medication Assisted Treatment (MAT) to inmates prior to release from jail to reduce overdoes fatalities and support recovery.

- Washington County HHS operates a Medication Assisted Treatment Clinic in its Outpatient Clinical Services Program focused on servicing uninsured and underinsured individuals. In 2020,

a provider was brought on that can administer Suboxone and Sublocade.

- In 2022, the Washington County Heroin Taskforce transitioned into the Substance Abuse Coalition so their work can have a broader impact on substance use disorder and the prevalence of fentanyl in many drugs.

- Washington County HHS has increased its funding for treatment services for the uninsured and underinsured by nearly \$500,000 per year.

- Since 2017, the Washington Ozaukee Health Department and Elevate Inc. have developed a robust Naloxone program where they have distributed 432 boxes of Narcan and trained 426 community members on administration.

- The Washington/Waukesha County Substance Use Prevention Initiative works to prevent and reduce the incidence of youth alcohol and drug use, with a focus on the misuse of opioids and/or heroin.

- Washington County and its community partners have developed a comprehensive criminal justice partnership to implement diversion programming and Drug Treatment Court to support individuals’ ability to access treatment and recovery.

Salmonella Infections Linked to Shelled Peas Sold at Farmers Markets and Farm Stands

The Wisconsin Department of Health Services (DHS), in collaboration with the Department of Agriculture, Trade and Consumer Protection (DATCP) and local health departments, is working to investigate cases of Salmonella infection associated with shelled peas sold at Wisconsin farmers markets. The investigation shows that at least six people were infected with the same strain of Salmonella bacteria after purchasing shelled peas produced by Green Barn Farm Market of Ripon, Wisconsin.

The peas were sold at Green Barn Farm Market farm stands and farmers markets in Ripon, Green Bay, Madison, and Fond du Lac, as well as Green Valley Acres Farm and Company farm stand in Neenah. Shelled peas are loose, no longer in their pod.

Anyone who purchased shelled (loose) peas from Green Barn Farm Market or Green Valley Acres Farm since July 1, is advised to not eat them and to throw them away, even if the peas have been frozen. If you ate any shelled (loose) peas purchased from Green Barn Farm Market or Green Valley Acres Farm since July 1, and are experiencing symptoms of salmonellosis, contact a doctor right away. Let them know you may have been in contact with Salmonella. Signs and symptoms of Salmonella infection include diarrhea, abdominal pain, fever, and vomiting that lasts for several days.

DHS Expands Eligibility for Monkeypox Vaccination

The Wisconsin Department of Health Services (DHS) has expanded eligibility for the monkeypox vaccine. To date, DHS has been allocated 1,486 doses of the JYNNEOS vaccine from the federal government, which is enough vaccine for 743 people to complete the two-dose series. As of July 28, DHS has identified 14 cases of orthopoxvirus, presumed to be monkeypox, in Wisconsin.

“Due to a limited vaccine supply, DHS is currently following the federal government’s recommendation to prioritize the JYNNEOS vaccine for individuals at the highest risk of infection,” said DHS Secretary-designee Karen Timberlake. “At the same time, we encourage all Wisconsinites to be aware of the

signs and symptoms of monkeypox and take precautions to prevent the spread.”

In Wisconsin, vaccination is now recommended for people who had known exposure to someone with monkeypox and people with certain risk factors who are more likely to be exposed to the virus. This includes:

- People who know that a sexual partner in the past 14 days was diagnosed with monkeypox.
 - People who attended an event or venue where there was known monkeypox exposure.
 - Gay, bisexual, trans, and any other men who have sex with men, who have had multiple sexual partners in the past 14 days.
- DHS encourages anyone who had

a known monkeypox exposure to talk with their health care provider to learn if they are eligible to receive a vaccine. If you do not have a regular source of health care, confidential support finding health care and community resources near you is available by dialing 211 or 877-947-2211, or texting your ZIP code to 898-211. Online resources are available at 211Wisconsin.org. As vaccine becomes more available, DHS will keep the monkeypox vaccination webpage updated with the latest information on eligibility and where to get the vaccine.

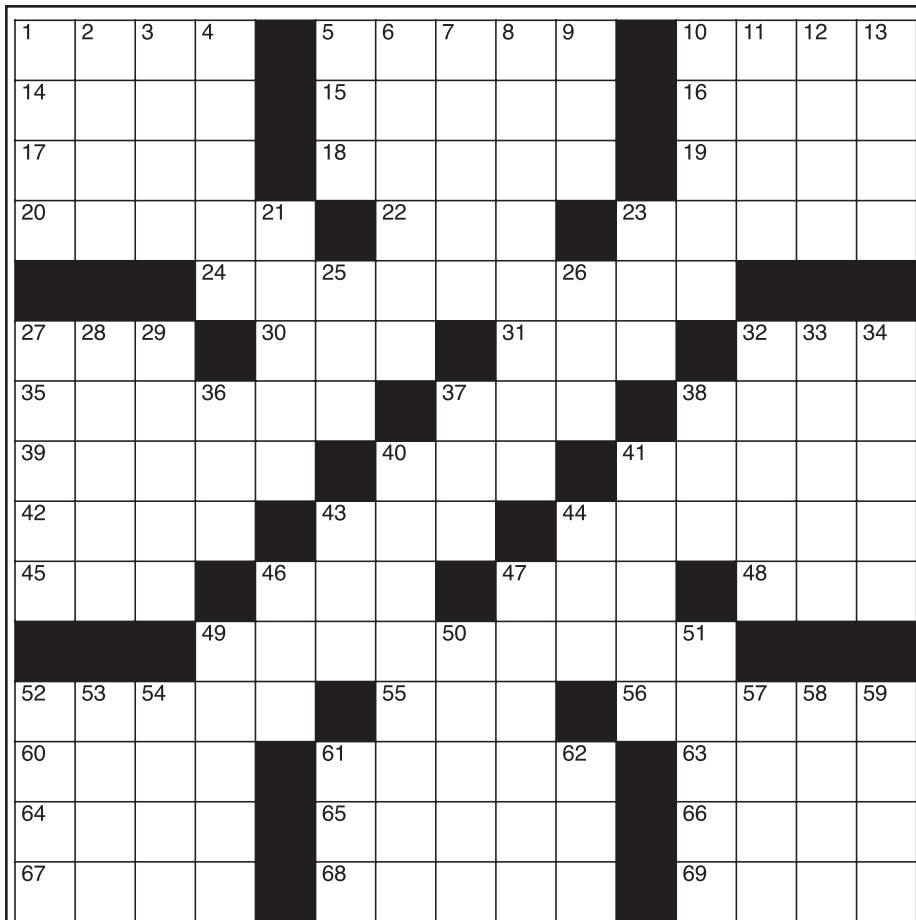
It is important to remember that the virus that causes monkeypox does not spread easily from person to person, and the overall risk to the public remains low. People who have recently been infected due to the current outbreak have reported having close, sustained physical or intimate contact with other people who have monkeypox. While most cases nationwide have occurred among gay, bisexual, trans, and other men who have sex with men, anyone can develop monkeypox infection if they have close contact with someone

who is sick.

To prevent the spread of monkeypox, DHS encourages all Wisconsinites to:

- Know the symptoms and risk factors of monkeypox. Anyone with a rash that looks like monkeypox should talk to a health care provider about whether they need to get tested, even if they don’t think they had contact with someone who has monkeypox.
- Avoid skin-to-skin contact with people who are showing a rash or skin sores. Don’t touch the rash or scabs, and don’t kiss, hug, cuddle, have sex, or share items such as eating utensils or bedding with someone with monkeypox.
- In areas where monkeypox is spreading, participating in activities with close, personal, skin-to-skin contact may pose a higher risk of exposure.
- If you were recently exposed to the virus, contact a doctor or nurse to talk about whether you need a vaccine to prevent disease. Monitor your health for fever, chills, swollen

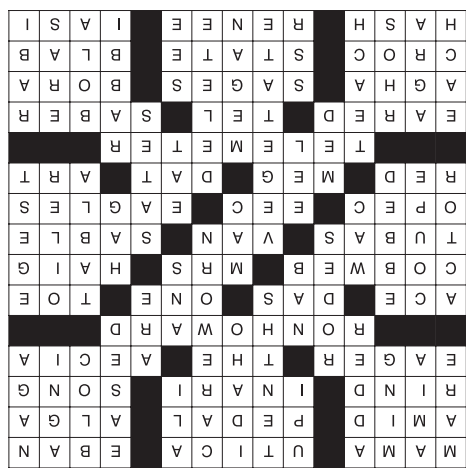

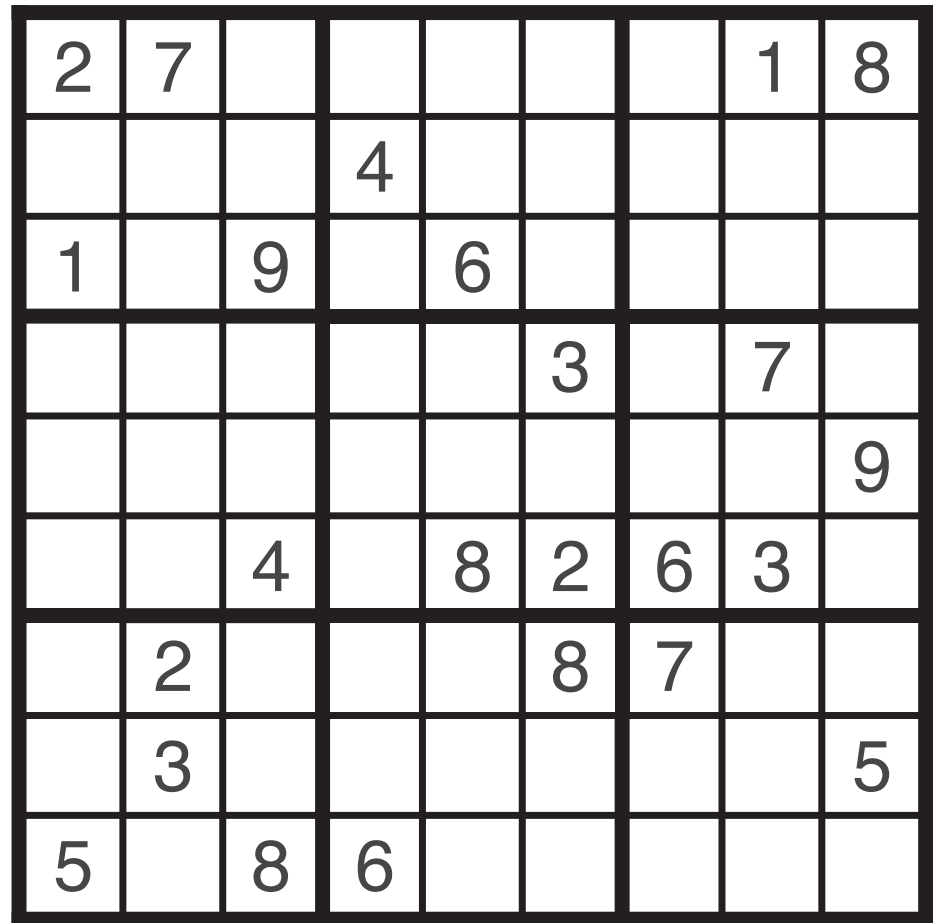

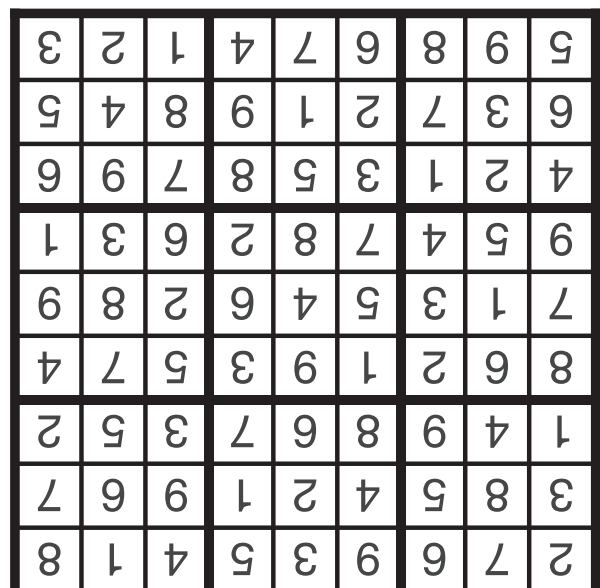

lymph nodes and a new, unexplained rash, and contact a healthcare provider if any of those occur. If you become ill, avoid contact with others until you receive health care.

• If you are sick with monkeypox, isolate at home until the rash has fully resolved, the scabs have fallen off, and a fresh layer of skin has formed.

DHS urges anyone to contact a healthcare provider immediately if they develop a new or unexplained rash. The JYNNEOS vaccine is currently only available by appointment at designated health care locations in Wisconsin. For free, confidential support finding health care and community resources near you, dial 211 or 877-947-2211, or text your ZIP code to 898-211. Find resources online at 211Wisconsin.org.

Horicon Man Charged in Crash that Killed Mother, Son and Unborn Baby

Steven Bruskiwicz, Jr., 31, of Horicon has been charged with two counts of homicide by negligent use of a motor vehicle, one count of homicide by negligent use of a motor vehicle of an unborn child and reckless driving causing great bodily harm following an initial appearance held in Dodge County courts last week Thursday. The charges stem from a June 28 crash in Richfield during which Bruskiwicz's vehicle struck a Mayville mother's car causing three fatalities.

According to a press release and investigation by the Washington County Sheriff's Office, Bruskiwicz was using his cell phone while driving his work van southbound on HWY 164 near Elmwood Road in the Village of Richfield in the early morning hours of June 28.

Bruskiwicz, allegedly, struck another southbound ve-

hicle in the rear. That vehicle, driven by Casey Schwartz, 30, of Mayville, careened into oncoming northbound traffic and was struck, again, by a third vehicle.

Schwartz, her unborn child and her one-year-old son were all killed in the crash. A 67-year-old Waukesha man – the driver of the northbound vehicle – suffered serious injuries.

The Washington County Sheriff's Office Crash Reconstruction Unit, assisted by the Wisconsin State Patrol, investigated the crash.

Bruskiwicz was placed on a \$5,000 cash bond. His next hearing scheduled is scheduled for Wednesday, Sept. 7.

If found guilty on the homicide charges, Bruskiwicz could face up to five years in prison and five years of extended supervision.

The weather simply could not have been more comfortable for this trip with highs in the mid-70s and lows in the low 50s; only one day of rain, which was tough but manageable.

Today was the rain day, and I would be with Trent.

The rain was so powerful that we had to get out of the boat and just stand in a burnt out forest for a good hour while it came down. Mikey caught what would be the big walleye for the week with the blue chrome Rippin' Rap and tonight we played UNO and some people stayed up until the sun greeted the eastern horizon.

The following day, Mike was my partner on this always incredible seven-day adventure and a good fish hit the Rippin' Rap that I was tossing and it turned out to be a 39.5-inch gator, which would be the big fish for the week in that category.

I started out this column writing about Michelle, and I will end it that way. I went home to an empty house and a broken heart for the first time since the mid-90s. I deal with it one day at a time by staying busy, positive and with a lot of help from friends, neighbors and family.

"Mix" Marx held the A's to 5 hits in bagging the victory, while the 'Kums poled 14 off of 3 Campbellsport twirlers.

Louis Bath led the Utensils' hit parade with 3 bingles in 3 trips. Clay Stautz secured 2 for himself, including a resounding triple.

Ketter was the only Athletic to get 2 hits.

Wondra started on the hill for the A's but was sent to the showers after 3 and 1/3 innings. He gave up 3 runs and 6 hits.

Shloemer came in to relieve him and had a storm time during the next 4 and 2/3 innings, allowing 5 more runs and 5 hits. Schmidt worked the last inning and was greeted with 2 more runs on a walk, triple and single.

The A's scored their one run in the ninth on 3 hits. Marx shut them out on only 2 singles up to that time.

Everybody on the Kewaskum squad got into the contest, even Manager Giles Wierman, who put himself into action for the first time this season. Giles played second base and in his only time at bat hit a terrific pop up to short.

Belles Split with Prison, St. Cloud

CAMPBELLSPORT NEWS
JULY 31, 1947

The following is an article from the July 31, 1947 edition of the Campbellsport News. The pieces are largely unedited and display the style and convention used "back in the day."

The Belles split even in the two games played over the weekend.

On Saturday they made their annual trip to the State Prison at Waupun and lost a well played game to the Prisoners by a score of 6 to 4.

On Sunday they returned to Kettle Moraine play and coasted to a 9 to 3 win over St. Cloud at St. Cloud.

Fritz Schramm Jr. was on the mound for the Belles in the game with the Prisoners and despite his inexperience pitched a good game, and showed plenty of promise for future Belles teams.

The Prisoners led 2 to 0 until the 7th inning when the Belles put on a four run rally to lead 4 to 2.

The Prisoners tied it up in their half of the eighth.

With two out and a man on base in the 9th, Poiwtek hit the ball over the wall in centerfield to settle the issue at 6 to 4.

In Sunday's game the Belles scored in the first inning on hits by Kemke, D. Hodge, and Jaeger. They promptly gave the run back to the Saints in their half of the inning when they committed two errors. In the Belles half of the second they put together three hits and aided by three St. Cloud errors, and a double steal scored 6 big runs to cinch the game.

In the fourth Don Hodge came through with a "Verbrick special" with Lemke on base to run the Belles total to nine for the afternoon.

The Saints picked up single runs in the 8th and 9th innings to bring their total to three as Chuck Schramm breezed through to an easy win.

Shultz Lake/40 Years Later

I am sure that many of you are aware that I have taken the last four weeks off due to the unexpected passing of my girlfriend, Michelle Chiaro.

The experience that you are about to read about was my first after her passing and, in some ways, it was very difficult for me and, in others, it was very helpful to be with family and friends, deep in the Canadian bush.

So today, I turned 61.

You can only get where we are by float plane and, 40 years ago - 1982 - we stayed here for the first time.

My friends Chris and Tammy Leblanc, along with others, own and manage Chimo Lodge and Outposts, and they purchased it five years ago from Pete and Elizabeth Hagedorn. The Leblanc's have endured a major forest fire, two years of Covid-19, another forest fire and the passing of their partner and lead bushmen Daniel Wesolowski in this period of time.

In closing on this subject, I was camp manager for this operation in the late 80s, and a bushman for much of the 90s, and this is where I started writing this column.

Today, I would be in at the tiller of our boat and my brother Mike (he was here in '82) and lifelong buddy

homework done; just a reminder: You cannot bring nightcrawlers into Canada, anymore.

The fishing - what can I say - due to two years with no one on these waters due to covid, the walleye were bigger and easier to catch, but we did not slam as many hogs as I thought we would.

The new lure for this group, which would end up being a trip-changer, was the Rapala, Rappin' Rap in blue chrome. I am aware that this is not a new lure, but it was a change for our

Schuett, Arenz, Boden Stand Tall as Plymouth Badger State Open Wheel Masters

It was a Wisconsin open wheel race fans' paradise as the Bumper to Bumper Interstate Racing Association 410 Sprint Car Series, Plymouth Dirt Track Racing-Akright Auto Midwest Sprint Car Association 360 Sprint Cars and Badger Midgets converged on The Plymouth Dirt Track at the Sheboygan County Fairgrounds in Plymouth for the Badger State Open Wheel special three-division racing program Saturday, July 30.

Kyle Schuett of Philo, Ill. notched his first career IRA 410 Sprint Car Series A-main victory in flag-to-flag fashion in the 30-lap main event.

Defending PDTR 360 Sprint Car champion and current points leader Travis Arenz of Sheboygan executed a late-race pass to secure his sixth 25-lap PDTR 360 Sprint Car A-main triumph of the 2022 campaign.

Zach Boden of Cambridge made it two-for-two on the season at The Plymouth Dirt Track as he notched his second Badger Midget A-main victory of the season in the 25-lap main event.

Kyle Schuett, who started on the pole, outpowered two-time IRA champion Scotty Neitzel of Beaver Dam, who started second, to take the lead on the opening lap of the 30-lap IRA A-main.

By lap 5, Schuett rode the cushion to build up a full straightaway cushion over IRA rookie Tyler Tischendorf, who started third. Schuett caught the back of the 22-car field on lap six before the red flag appeared on lap 7 when two-time IRA champion and current points leader Jake Blackhurst of Hanna City, Ill. flipped in turn two.

Following the restart, Neitzel ducked low to power past Tischendorf to take over the runner-up spot exiting turn four on lap 8. Two laps later, Jordan Goldesberry, who started fourth, followed Neitzel into third in the running order.

Schuett began to encounter lapped traffic on lap 13, which allowed Neitzel to close in on lap 18. As the leaders continued to weave their way through heavy lapped traffic, eighth starter Danny Schlafer of Sussex moved in to slip past Neitzel in turn four on lap 28.

On the final lap, Schlafer dove low to briefly pull alongside the high

groove hugging Schuett. However, Schuett used the momentum of the outside line to power away from Schlafer down the backstretch and through the final two turns en route to his initial IRA A-main triumph.

Schlafer had to settle for second, Neitzel placed third, Goldesberry took fourth and 2016 IRA champion Jeremy Schultz of Beaver Dam rounded out the top five, after starting seventh.

Polesitter Lance Fassbender of Burnett took the lead on the opening lap of the PDTR-MSA 360 Sprint Car A-main as outside front row starter Bill Taylor of Boltonville slipped into second.

Fassbender, who captured the 2008 PDTR 360 Sprint Car championship, held tight to the low groove with Taylor following closely in his tire tracks through the opening laps of the race. On lap 8, Travis Arenz, who started eighth, worked his way into fourth before using a high move to seize third on lap 10.

As the leader encountered lapped traffic, Arenz capitalized by bolting past Taylor into second in turn one on lap 18. Meanwhile, Fassbender was finding the going challenging at the front of the field as he tried in vain to work around a lapped car, which allowed the stalking Arenz to

pounce.

When Fassbender drifted high, Arenz dove low to seize the top spot entering turn one on lap 20. Arenz then pulled away to notch his sixth PDTR 360 Sprint Car A-main victory of the 2022 season in nine attempts, 16th career PDTR 360 Sprint Car main event win and 28th career Midwest Sprint Car Association A-main triumph in the caution-free race.

Fassbender finished second, Taylor was third, Robbie Pribnow of Lomira, who started fourth, steered the No. 47 car normally driven by Blake Wondra to fourth and ninth starter Tim Haddy of Waupun placed fifth.

The initial start of the 25-lap Badger Midgets A-main was aborted when Jordan Nelson of Colgate flipped in turn two.

2016 PDTR Micro Sprint champion Zach Boden, who lined up fifth on the original start, used a huge run along the low groove to seize the lead in turn four on the opening lap as Daltyn England of Springfield, Ill., who started second, settled into second.

On lap 3, seventh starter Jack Routson of Waterman, Ill. worked his way underneath England to move into second and quickly set his

sights on Boden. Routson was closing in on the lead when a caution flag was displayed on lap 9 after Trey Weishoff of Sun Prairie stopped along the backstretch.

When the race resumed, Routson was hustling his car to keep pace with Boden at the front of the field when he jumped the cushion and spun in turn two on lap 13 to bring out the third yellow/red flag of the race.

After another yellow flag on the restart for an incident involving Dave Collins of Lake Mills and Cody Weisensel of Sun Prairie in turn two on lap 13, Boden again pulled away while 16th starter Jake Neuman worked the high line to move into third on lap 16 and second on lap 17.

On lap 23, the red flag was displayed when Charles Rufi of New Glarus flipped in turn two to set up a green-white-checked flag finish. Boden held strong on the restart to hold off the hard-charging Neuman on the way to his second main event victory of the 2022 season at The Plymouth Dirt Track and his third career Badger Midgets A-main win.

Neuman was second, England placed third, sixth starter Kyle Stark of Marshall took fourth and Kevin Douglas of Madison, who started ninth, wound up fifth.

Jordan Goldesberry was the IRA 410 Sprint Car fast qualifier with a lap of 11.750 seconds.

In his first start of the 2022 season, Jason Johnson of Campbellsport was the fastest PDTR-MSA 360 Sprint Car overall qualifier with a lap of 12.366 seconds.

Jake Neuman earned the Badger Midgets fast qualifier award with a lap of 13.749 seconds.

Tony Wondra of Campbellsport won the 12-lap 360 Sprint Car B-main.

Jake Neuman won the 10-lap Badger Midgets B-Main.

The ninth full PDTR program of the 2022 campaign, which was sponsored by Jensen Sales and Service, drew a total field of 76 cars, including 22 IRA 410 Sprint Cars, 27 PDTR-MSA 360 Sprint Cars and 27 Badger Midgets.

The next PDTR racing program on Saturday, Aug. 6 will feature the inaugural Plymouth Racing Wall of Fame Class of 2022 induction with 10 drivers, four track workers and
