K.H.S. Students Lead Tech Class for Senior Citizens

Read all about the program as told by one of Kewaskum High School's own, Emily Miller

On September 28, 2022, Charity Humphreys and I got the opportunity to sit in on a "technology basics" class with elderly men and women learning to use technology. We got to meet with them and talk about what they were learning and why they signed up. Not only did we get introduced to many new faces, but we got to talk to the leaders of the class, as well.

Two students from Kewaskum High School – Katelyn Scannell and Mia Vetter – started this program to teach senior citizens how to use their phones and computers. They were also joined by Addyson DeRuyter who assisted on Tuesdays.

Scannell and DeRuyter played

golf together for Kewaskum High School (KHS), and Vetter knew Scannell from volunteering at Kettle Moraine Gardens last year (their sophomore year).

It was during this opportunity that Scannell and Vetter found they loved working with senior citizens.

"I love the relationship I have with my grandparents, and I wanted to help people feel the same way," said Scannell.

She talked to this author about how some older people don't have the same social skills or opportunities as others, and she wanted to help them achieve this.

Vetter agreed, and wanted to find a way to stay connected with the elderly.

The pair reached out to Mr. Kevin Pratt, who is the KHS ACP

(Academic Career Planning) Coordinator. He was in contact with Tammy Anderson from the Aging & Disability Resource Center of Washington County, who was looking to have some of her "socially isolated" adults work with some of the students at KHS.

They came up with a plan to teach willing senior citizens how to use basic technology and answer any questions they might have about texting, using Facebook, etc.

About one dozen elderly people from Kewaskum – and as far away as Slinger and West Bend – signed up to learn how to use their devices. After three classes, so far, they have learned how to delete apps and messages, set up their voicemail, send voice

Days of Wine and Roses

Dear Reader,

Recently I watched a movie called "Bottle Shock," which tells the story of a small, family-owned, struggling vineyard called Chateau Montelena in the Napa Valley, California. It gives an accounting of how the world of wine was turned on its head in Paris during an international blind tasting in 1976.

The tasting competition was called "The Judgment of Paris," a name that plays a story from ancient Greek mythology in which a mortal human named Paris had to decide on the beauty of the three most beautiful goddesses of Olympus: Aphrodite, Hera, or Athena. Chateau Montelena entered two of its wines in the competition. Shockingly, both wines won.

To understand the enormity of this event, you have to realize that American wines were considered inferior, barely worth drinking. The wine world was turned upside down when an American Chardonnay and Cabernet won first place in blind tastings by the world's greatest experts in wine evaluation. A paradigm shift occurred as many people realized a stunning truth: American wines are worth trying.

Recently I tried Montelena's Chardonnay and Cabernet wines. They were quite good. To use the, shall we say, unique language of wine tasting, the Montelena Chardonnay was "enchanted, like bright gold in a glass; it tickles the palate and, its young age notwithstanding, delivers an overall length that is impressive." Doesn't that sound funny? But that's how those wine experts talk. And Montelena Cabernet provides "colorful layers of notes and taste that continued to reshape and charm after pouring."

So in these days of occasional order and frequent chaos, pause some evening and conduct a tasting on your own or with a few friends. Chateau Montelena delivers by the case from the Napa Valley.

messages and other practical skills.

I spoke with LaVerne (an incredibly kind and hilarious woman, who made sure to emphasize that her name was spelled with a capital 'V') who participated in the program.

She said she joined the class to learn the basics of using a phone and computer. When asked why she wanted to learn, she laughed wholeheartedly and said a family member got the technology for her as a gift.

Her progress so far?

"I learned how to 'Cancel'. No, 'Delete.'" she said, exhibiting that she was learning the terms for the keyboard.

When asked if she's had fun the past few weeks

since the class started, she said:

"Yes, I enjoyed it very much."

Linda, 73, also spoke with me, and she said she had just gotten her first cell phone. She also mentioned that she had previously owned a Tracfone. She joined the class to learn how to use her phone for general purposes.

She learned about QR codes, which are often printed on receipts. She was also excited to learn that "GIFs" are like "animated emojis."

"I like the fact that this class doesn't add stress," she said.

She talked about learning acronyms, too.

"LOL, meaning 'lots of love,'" she said.

I told her it could also mean "laugh out loud", which she wrote down in her notebook. She was thrilled to explain how she could, now, keep in touch with her sister who lives in Minnesota, who is a more regular "texter."

Dan was also learning new skills at the program. He was transferring from "IOS6" to "IOS13."

"IOS" stands for "iPhone Operating System" and is the software used by iPhone producer Apple. Similar to "Android OS", but for iPhones.

IOS6 was released in September 2012, while IOS13 was released in 2019.

In this process, Dan wanted to know the basics of using a phone and update his knowledge. While interviewing him, I showed him how to add a contact to a group message. It was a great example of something that can seem simple to one person, but for another, the concept was still foreign.

Overall, the process was really fun, as KHS students got to help neighbors understand technol-

Family Promise Expansion Breaks Ground

The West Bend-based organization, which serves the county's homeless population, will expand at Karl's Place on Water Street and sell its Elm Street facility

Family Promise of Washington County (FPWC), which operates two adult homeless shelters – Karl's Place on E. Water Street – and a family shelter – The Promise Center on Elm Street – in the City of West Bend, expanded their footprint and services at Karl's Place last week during a groundbreaking ceremony on Friday, Oct. 28.

The group will operate entirely out of this new expanded facility to create more accessible and coordinated services for the homeless in Washington County. FPWC plans to sell their Elm St. location and operate all programming for families and individuals, including emergency shelter, transitional housing, rapid rehousing and homeless prevention programs at Karl's Place, making it a true hub for all shelter and housing resources.

Washington County applied for a State of Wisconsin Community Development Block Grant – Coronavirus Funding (CDBG-CV) on behalf of FPWC. Only a non-entitled unit of general local government can apply for the CDBG-CV Grant funding.

Lori Prescott, executive director of FPWC said, "Family Promise of Washington County has responded to our community's need for over 11 years to shelter the homeless. We are dedicated to serving our community and the increased homeless persons that have gone underserved. We look forward to concentrating on our services for all families and individuals in our updated hub for homelessness here in Washington County."

FPWC Board President David Ertmer said, "This expansion project is a wonderful opportunity for Family Promise of Washington County to efficiently and more effectively carry out its mission to serve the homeless by having all our resources in one location. A special thank you to all who have made this opportunity a reality."

The planned expansion includes nine emergency shelter bedrooms with two community shelter

The Philippines and the Kermis

Taken aback is an understatement to describe a veteran's response about the Ashford Kermis. I was sitting on my porch, and on the other end of the line was Jim Reilly in Shullsburg, located in the southwest corner of the state. He set the stage of the post war occupation of the Philippines. Then explained the worst time in his service was missing the most significant annual event of southeastern Fond du Lac County.

Service in the Philippines

First let it be said, Jim's answers to questions come in precise fashion. Periods within direct quotes below illustrate Jim's pauses which were brief and reflective, and emphasize the details in his story at hand.

Jim is the first person to tell you that when it comes to his military service, he did not serve during a hot war and he passes credit for wartime service to his brothers.

"I personally did not get fired at," he said when asked to describe his service in the 1940s.

However, his time in the Philippines after the end of World War II was not safe. "It was called the 'mopping up forces,' and I was in the Army Air Corps, and the Army was there going out and rounding up Japanese." The war was over since August of 1945, but some Japanese who didn't know the war was over remained in the Philippines and made it a precarious situation. "I don't want to make it something that it wasn't, but at the

same time, 'Was there some danger there?' Of course there was."

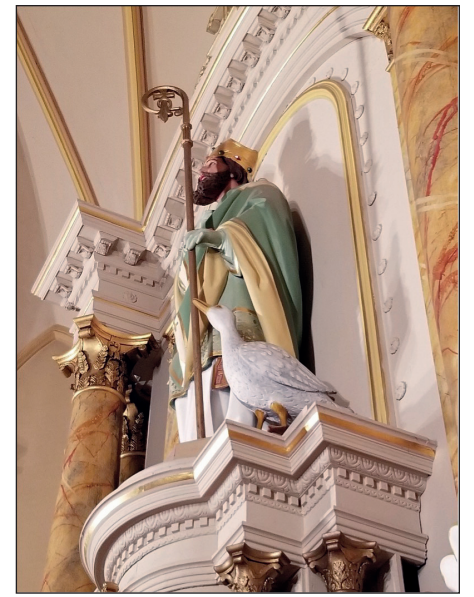
"I stayed there 23 months. Just a month lack of two years. I got out of there in 1948." He did get to see General Douglas MacArthur. He remembered there were five steps going into headquarters there at Clark Field, a base in the Philippines, and it was there Gen. MacArthur was going up the steps and the young Reilly was close enough to touch him. "I did not meet him. I did not shake hands with

him. But I was the one beside there as he was going up the steps."

Old Ashford

In the interview from 2018, Jim had fond recollections of Ashford within Ashford Township. He is the last of his siblings alive, as he is one of 17 children born in South Eden to William and Katherine (Kit) Baumhardt Reilly. Most of his childhood memories extended north of the hamlet of Ashford, South Eden, and over to the present day intersection of Hwys F and K, where his older brother Leo farmed. The near generation separating Leo (b. 1910) and Jim (b. 1928) made Leo somewhat of a fatherly figure to the young Jim.

Some of those memories within the small hamlet of Ashford included the talk of the tavern, which in the late 1930s included debate over whose vehicle could get up the Katzenburg, the large hill between Ashford and St. Kilian. The hill became its own landmark. "It was much discussed at the bars – John Erickson's bar in Ashford. I patronized it, and my dad did too. I'd sit in there and wait for him." It was a very good bar, Jimmy said, and recalls Erickson had the ability to entertain patrons – "They'd let us throw bean bags around while we were waiting for my brother or my dad, which ever it happened to be." In that memory Jim was nine or 10, and clarified that he wasn't drinking but went to the tavern. This is important because children in the tavern back then often had a nice experience. It was a good time as pa's car was across the road

getting fixed by Schill's. To kill time, "my dad would spend his time over at Erickson's at the bar." There were later memories too – "Then when I got to be older, I did go in there for a beer or two." He also went to the other bar, which became Fleischman's by the late 1950s. The tavern Fleischman's owned is still open; Erickson's Bar burnt down decades later.

Tradition and Anticipation

The discussion on the old Fleischman's tavern transitioned into questions on the Ashford Kermis, a November celebration in Ashford

honoring the feast day of St. Martin's – whose Catholic Church centered around the locals in the 1900s. Did Jim ever go to the Kermis? His answer was immediate and detailed: "Ashford Kermis was the first dance I ever went to." This celebration was on both floors of the tavern still standing.

What made the celebration so great was the sense of coming of age for many when it was the first time a young adult could attend. "I think it was the cutting of everybody's first start or to be able to go out and do something. It was in our family." Could he bring a date? "No. No. No. I probably went when I was about 14." Even if he couldn't have a date, that was way better than staying home.

Not only was it a fun dance, the entire festivities around 1940 was quite extended: "Well, it was a holy day, and it went on for two days." This is true, contradictory and funny at the same time. St. Martin's feast day is on November 11. However, Ashford developed the tradition of making a great time longer, and the party extended into two evenings. Not only are the parties better in Ashford, their holy days last longer.

The fun times made it all that more difficult when Jimmy was excluded: "I was overseas, and it'd be the 10th and 11th of November. I'd say, 'I can't [handle this]...I don't like this, I gotta miss the Ashford Kermis.' 'Course, nobody knew what I was talking about.'" So it was almost like missing Christmas? "It was," Jimmy responded, paused, and reaffirmed: "It was."

South Eden Rowdies

I had heard a story from one source who claimed somebody got thrown out of a window at the bar where the Kermis celebration was held. Jim offered his two cents – "It was a Johnson and Reilly, and nobody got thrown out of the window. They threw a great big chair out the window." He could not recall for certain if it was a joke or a fight, but it did serve as evidence to the wild side that came in from South Eden down to Ashford that night. "But I never heard of anybody ever getting thrown out."

He said the only detailed story that he could tell about the Ashford Kermis was one that involved "my brother John, and one of the Johnsons or a Murphy." After the Kermis celebration, "the band equipment was sitting downstairs at the bar. And the band, or the orchestra was upstairs. They had their instruments, and there were was a couple of the guys that told them they had put them in the car, and they put them in the wrong car and they [band members] didn't know it until the next day." Jim laughed, saying the South Eden guys admitted they did it. "They didn't do it on purpose; then again the story got out that they did do it on purpose."

The Top Kermis Memory

The Kermis memories of the 1900s ebb and flow, but there are some which stand out more than others. In the process of documenting Jim Reilly's recollections on Ashford, it reminds us of those who have crossed over. Here are some of the best when it comes to the Kermis:

Al Serwe discussing how Grandma Bodden sat on her porch with a gun to lay the law down in case somebody from the tavern got out of hand; Lizzy Weiland sharing how serious the weather situation was in 1940 when the Kermis was postponed because of an ice storm; Jack Babler talking about the cars down 67 and how his parent's lawn became overflow parking; then there is Ray Thelen reminding that one wouldn't believe how much the top floor of the tavern bowed when the dance occurred on the top floor. Thank God there wasn't OSHA in the 1950s.

However, it is the memory of Jim Reilly's in the Philippines which ties the Kermis altogether. "Oh that was terrible," Jim restated when rehashing what it was like to miss the celebration of the year back home when serving his country overseas. And it was worse for Jim's older brother, who was surviving intense fighting in the Pacific when it hit November 11. "And my brother Tom said he told the same story in New Guinea about telling the people about missing the Ashford Kermis. 'We're not suppose to miss that.'" The irony, therefore, is that the strongest memory of the old Ashford Kermis which best explains the significance of the event is the perspective of what it was like to miss it.

But you can make it on Sunday, Nov. 13, at the bottom of the church in St. Martin's, with another Kermis celebration of chili, chicken dumpling soup, and desserts. Be sure to reflect on those early times of the Kermis from those still here, and those gone but in our hearts dear.

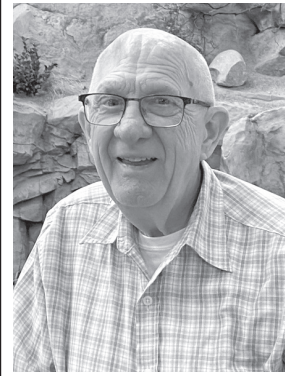

Of the 151 veterans from Wisconsin who went on the November 4 Stars and Stripes Honor Flight were Jerry Schneider and James Korth of Kewaskum. Schneider served from February 20, 1968, to February 19, 1971. Korth served from November 8, 1969, to December 10, 1971.

Kewaskum Village President Kevin Scheunemann said before the board meeting on Monday night that he was withdrawing the village board review of the library appointment as an agenda item. Scheunemann said his decision was made after considering the library director's support in the Kewaskum Statesmen and Trustee Dave Spenner's recent recommendation. Spenner had originally requested that Connie Zemlicka be removed from the library board. He now says it is in the village's best interest to proceed as it is.

The Kewaskum School Board approved the 2017-18 budget of \$42,759,422 when it met October 30. The combined tax levy of \$11,578,985 is a 3.94 percent increase in the tax levy. Campbellsport's board of education continued to discuss adding four-year-old kindergarten to the district. During the November 5 meeting, board members listened to more information about the idea. When I was in undergrad school, I took an introductory literature class. The instructor began the first day by asking the class to state their name and favorite author. I don't know if the majority thought it was an advanced class or wanted to impress the professor but many of the responses included authors such as Fitzgerald, Dostoevsky, Faulkner, and Updike. When it was my turn, I responded truthfully with Stephen King. The teacher mocked my choice and shamed me for not having reading habits that were as high-brow or as what he considered as literary as the other students' answers.

That professor's disdain for my favorite author had an impact on my life and reading habits for a long time. It did not change the type of books I liked to read, but I would sometimes hide my reading material from other's view. He was a literary snob and probably should not have been teaching literature to impressionable freshmen.

I forgot about that instructor for many years until I started my first librarian job. There was a new controversial book series just released and my colleagues were mystified over the hype surrounding something they felt had little to no literary value. I tried to join them in their contempt, going along with peer pressure but then remembered that professor and could not bring myself to mock the author and those that enjoyed their books. I did read the books in the series all the way through. I did not enjoy them but thought that I could be a good librarian and provide better reader's advisory if I knew what the public wanted to read.

We are seeing a reading craze again, the popularity and demand for this author's works are sky-high. Most of their books are in a genre that I personally do not read. I have discussed this hype with colleagues, patrons, and friends. We are trying to understand why these novels are so popular. I have read several of them and could not get into them. I think the reason they are so popular is because many of the readers can relate to what the author is saying. Or maybe it is just a pleasant escape for them. Regardless, these books can not stay on the shelves, and it is my job to supply material that is in demand.

I am happy to report that I am not a literary snob. I don't judge others for their reading choices and try to maintain a balanced collection in the library for all preferences. I no longer hide what I am reading from anyone and will suggest my favorite authors if asked. If someone tries to mock my preference, I just smile and say, not every book is for everyone. Oh, and the author that was my favorite many years ago has won multiple awards, has had his works, and writing style highly valued and is still one of my favorites.

A voter may select an individual to assist in casting their vote if the voter declares to the presiding official that they are unable to read, have difficulty reading, writing, or understanding English, or that due to disability are unable to cast their ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter. If a voter is unable to state their name and address, an assistant may also do so for the voter.

Where Optical Scan Voting is Used

The voter shall fill in the oval next to the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of their choice in the space provided for a write-in vote and fill in the oval next to the write-in line. On referendum questions, the voter shall fill in the oval next to "yes" if in favor of the question, or the voter shall fill in the oval next to "no" if opposed to the question.

When using an *electronic ballot marking device* to mark an optical scan ballot, the voter shall touch the screen or use the tactile pad to select the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall touch the screen next to "write-in" and type in the name of the person of their choice. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question, or the voter shall touch the screen at "no" if opposed to the question.

Spoiled Ballots

If a voter spoils an optical scan ballot, they shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

After Voting the Ballot

After an official optical scan ballot is marked, it may be inserted in a security sleeve so the marks do not show. The voter shall then insert the ballot in the voting device or deliver the ballot to an inspector for deposit. If a central count system is used, the voter shall insert the ballot in the ballot box or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

After an official **touch screen** ballot is cast, the voter shall leave the polling place promptly.

areas and the expansion of transitional housing units consisting of two 2-bedroom and two 3-bedroom units to accommodate families.

In 2022, Washington County sold 30,000 square feet of land to Family Promise. This is in addition to the 1 acre donated to Family promise in 2017. Washington County will receive up to \$2,000,000 to support the construction expansion and will be responsible for the overall assurance of the completion of the project and meeting the requirements of the CDBG-CV grant. Washington County will provide staff time for project oversight, bidding, finances, and grant administration support.

FPWC will pay for any costs of the construction beyond the amount awarded through the CDBG-CV grant and has a fundraising goal of \$850,000. Washington County will contract with Kunkel Engineering to support the oversight of this project for \$39,890, and FPWC will reimburse Washington County for these costs through dollars not associated with the CDBG-CV grant.

AN Outdoorsman's JOURNAL

First Deer

This is one of those weeks where I have five times more material than the space to write it.

This column is dedicated to my good friend Rod Bensley. He lives with his wife, Wendy Vick, near Burnett in Dodge County. Rod is probably the best habitat/land manager that I have ever met.

Rod has cancer, has majorly out-lived his diagnosis, is in tough shape and, for the hunt you are about to read about, opened his property up to a couple of kids for Wisconsin's Youth Deer Hunt.

**SATURDAY, OCT. 8
HIGH: 63. LOW: 30.**

I was mentoring and sitting in a portable tree stand next to 12-year-old Carsyn Thiede who is the daughter of Tyler and Patsy Thiede of Mayville.

Kieth Kneiser does a

lot of volunteer work on this property and was in a box stand with his 15-year-old granddaughter Kennedy Kneiser of Oostberg.

Tyler Thiede would be on a total go-for-it hunt on state land near the Horicon Marsh with his 10-year-old son Conner.

Carsyn and I were hunting in a forest that is a natural funnel between several food plots and corn fields.

A brief description of our upcoming hunts: almost non-stop deer or turkey activity and lots of laughter.

I did my best to teach Carsyn that this hunt was a learning experience and everything else was a bonus.

We had deer long before daylight within 10-yards of us and, over the next three hours, we had an unbelievable hunt with five buck experiences (including one that was bigger than anything that I

have ever harvested).

I said this hunt was a learning experience, and I meant it.

We used "cookie doe" cow manure for a cover scent and it worked perfectly, but getting a first-time hunter a shot without getting busted did not happen, and we simply did not care.

Just before 7 p.m., we did hear the bark of Kennedy Kneiser's 270 and, though she did not know it at the moment, it was lights out for her first deer, which was five-point buck.

We took a break af-

ter our hunt and found it 30-yards from where she had taken her shot.

Our good friend Rod is a hurting unit, but he was able to enjoy some time with Kennedy and her buck, which is what this weekend was all about.

On the evening hunt it was much slower for Carsyn and myself, but Conner and Tyler had a great hunt, and Conner made a 140-yard shot on an adult doe and now two of our kids had their first deer.

**SATURDAY, OCT. 9
HIGH: 56. LOW: 31.**

This morning, Carsyn and I had most of our experiences at a food plot that we could see, but it was too far for a shot.

After our hunt, we used my loppers and made a ground blind, and were we ever ex-

cited for our afternoon hunt.

As usual, the mood was happy when we got in our blind, and it was not long until three does entered the plot about 50-yards away.

Carsyn was well-composed but shaking like a leaf as she rested her TC 6.5 Creidmore in a

bolt action on a shooting stick which I braced. When she went to shoot, her gun would not fire.

The doe busted us and life was not as much fun, but we made it fun.

A half-hour later, the same type of experience happened and, again, her gun would not fire.
