# Campbellsport Wrestling Introduces First Girls' Program Starring Freshmen Duo

There is a new era starting for Campbellsport Cougars wrestling.

Freshmen Izabella Pickering and Emma Batzler are excited to be the first two female wrestlers to participate in Campbellsport High School's first girls wrestling program.

Pickering began wrestling in kindergarten because of her cousins who she would wrestle with when she was young.

And Batzler started in sixth grade thanks to Pickering.

She said, "It started as a joke between me and Bella (Izabella) because she needed a partner, so I told her I would try it just once but I ended up really liking it."

Campbellsport wrestling Coach Dan Heisdorf explained why this is the first year Campbellsport introduced a girls' program.

"We haven't really pushed for a girls' program, but girls' wrestling has really taken off

the last couple years, and it will continue to get bigger," he said. "This is the third year it has been recognized as a WIAA (Wisconsin Interscholastic Athletic Association) sport. It went from 452 girls the first year to

744 last year."

While Heisdorf is thrilled to field a pair of female wrestlers this season, he added that there was room for more to join the team.

"Once we knew for sure Emma and Bella were going to wrestle in high school, we started asking other girls who were not doing a winter sport if they would give it a try," explained Heisdorf. "There has been some interest, but no others have taken the step of trying it out. We are hoping the success Emma and Bella are having will give other girls the urge to give it a try."

Head Coach Alex Costello said, "My hopes for this first season of girls' wrestling are that they continue to have fun and grow numbers. I hope we can have our very first girls' state qualifier this year, as well"

Both girls agreed they believe the season has been going well

## **Boost Your Mood with Fragrant Indoor Plants**

There's no need to visit a spa for a bit of soothing aromatherapy. Grow fragrant plants indoors to improve your mood and promote a sense of relaxation.

Gardenias may be the first fragrant flowering plant that comes to mind. They can be challenging but are worth the effort. Grow them in moist acidic soil, in bright light, and surrounded by other plants or on a gravel tray to increase the humidity.

Jasmines are known for their sweet fragrant flowers. Arabian jasmine (Jasmine sambac) will flower indoors several times throughout the year if it receives sufficient light. Consider adding artificial lights to boost flowering. Grow this plant in a warm draft-free location and allow the soil to dry several inches below the surface before watering again.

Citrus are valued for their fruit, but they also produce fragrant flowers. Give them bright light and keep the soil slightly moist for the best results.

Stephanotis floribunda was frequently used in wedding bouquets. Grow it in a sunny window and watch for flowers to appear in spring on new growth. Complete all necessary pruning as soon as the plant stops flowering.

Plumeria are the fragrant flowers often used in Hawaiian leis. Provide bright light, moist well-drained soil, and fertilize throughout the summer to promote flowering. Allow the soil to go a bit drier during the winter. Don't panic if the plants go dormant and drop their leaves in winter. New leaves will appear as temperatures warm.

String of pearls (Curio rowleyanus) is a trailing succulent with leaves that resemble peas. Grow these in a brightly lit location that is a bit cooler in the winter. This along with slightly drier soil in winter can promote flowering. Its cinnamon fragrance is one you'll remember.

Another succulent that may reward you with flowers is hoya. Keep the soil a bit moister during the summer when the plant is actively growing. Allow the soil to dry slightly when the plant is resting during the winter. High humidity in spring and summer followed by cooler temperatures and drier soil in winter will encourage potbound plants to flower.

Watch for fragrant flowers to form on the long leafless stems.

Give the leaves of scented geranium (Pelargonium) a pet and enjoy the lemon, rose, apple, peppermint, or pine fragrance. Although grown for their scented foliage they also produce pretty but less showy flowers. Place the plants in areas where you brush past the leaves or can easily give them a pat to release and enjoy the fragrance.

Find a cool spot in your home away from drafts of hot and cold air for your lavender plant. Make sure the plant receives plenty of sunlight from a south-facing or similar window. Consider adding artificial lights to increase your success. Water thoroughly when the top inch of soil is dry to the touch. Pour off any excess water that collects in the saucer.

Visit your local independent garden center or reputable online plant retailers that are more likely to sell these in winter. Then clear out some space on a sunny windowsill or invest in a few plant lights and start growing some fragrant plants.

# **Health Department Offers Radon Test Kits** for Radon Action Month

During National Radon Action Month the Washington Ozaukee Public Health Department is encouraging citizens to test their homes for radon by offering free test kits to residents. We are asking residents to bring a non-perishable food item that has not expired to our department in exchange for a free short-term test kit. One discounted test kit per household. Without the donation of a non-perishable item a short-term test kit costs \$7 and a long-term test kit costs \$20. All items collected during outreach events will be donated to a local food bank. Please note that postage on the test kit is not included.

Radon is a naturally occurring odorless, colorless gas found in rock and soil. Radon is the second leading cause of lung cancer, claiming the lives of an estimated 20,000 Americans each year. In Wisconsin about one out of 10 homes contains high radon levels.

The radon test kit is easy to use and only takes a few minutes to set up. Once you open it, the kit stays in your home for two days. Then you will package it and mail it to the lab for analysis. The United States Environmental Protection Agency (EPA) and the U.S. Surgeon General strongly recommends all homes be tested for radon. Homes with radon levels of four picocuries per Liter (4 pCi/L) or higher should be remediated. If you choose to have a mitigation system installed, it is recommended that the system be installed by a certified mitigation professional.

Kits may be obtained at locations at the dates and hours listed below.

Certified Environmental Health staff will be handing out the kits and answering questions at the following times and locations:

• Friday, Jan. 12 and 19, from 9 a.m. to 1 p.m. at both Washington Ozaukee Public Health Departments - In West Bend at 333 E. Washington St., Suite 1100; and in Port Washington at 121 W. Main St., Room 246.

An additional date and location are being offered this year. Kits and information will be provided on Friday, Jan. 26, at the Village of Jackson Municipal Complex from 9 a.m.-1 p.m., located at N168W19851 Main St. in Jackson.

# D.N.R. Angler Recruitment Grants Available

#### -Apply by Feb. 15-

#### **WIS. DEPT. OF NATURAL RESOURCES**

The Wisconsin Department of Natural Resources (DNR) is encouraging individuals and organizations to submit grant applications to build the community of anglers through community and school-based fishing programs. This grant is supported by the federal Sport Fish Restoration fund, which is generated by an excise tax on fishing equipment and motorboat fuel. The deadline to apply is Feb. 15, 2024.

Past grant recipients have used this grant to support in-depth Angler Education and Learn to Fish programs at schools, nature centers, parks, community centers and camps. They have delivered fly-fishing classes for women and veterans, trainings for people who work with anglers who are disabled and built capacity for family and youth fishing programs in their neighborhoods and statewide.

#### **Grant Cycles, Priorities**

Grant cycles are for two years, and funding is

available to the recipient when a grant agreement is signed by all parties, approximately one year after the application is submitted. As a reimbursement grant, only expenses incurred after the grant agreement is signed will be covered. The amount of available funding totals \$30,000 with a cap of \$5,000 per grant. Applicants are required to provide 25% matching funds for their project, either in cash or in-kind.

Priority will be given to projects that concentrate on groups that have been underrepresented in the fishing community. Programs for other adults who never learned how to fish as youngsters will also be considered as well as youth programs that will go beyond one-day events.





(WDVA) to provide no-cost mental health services to Washington County veterans. The check was presented on December 6, by WDVA Secretary James Bond at the county's Behavioral Health clinic. The department's outpatient clinic currently services those in the community who have Medicaid or are under or uninsured.

Many veterans in the county do not have access to mental health services outside of the VA, which is in Milwaukee. Improving access to services for veterans is the first goal of this pilot project, which aims to serve 10-20 veterans in the first

Regardless of personal health insurance coverage, the grant will provide weekly-to-monthly therapy sessions, and medication management, as necessary. to interested veterans who are to serve the mental health needs struggling with any number of life stressors.

"Local access to mental health services is critical for our Veteran population in the fight against substance abuse and suicide," said Kurt Rusch, Washington County Veterans service great potential in our effort to meet Veterans where they are, and help them to transition back home successfully."

A second goal of this grant is for the department to obtain credentialing with the VA Community Care Network. This will allow the veterans who are linked with the counties outpatient clinic to continue services and expand access to many more veterans who may need support and services.

#### 15 Years Ago January 15, 2009

The school day will change again for Kewaskum students. #### 75 Years Ago January 14, 1949

Eight men from Washington County have enlisted in the U.S. Army at the West Bend Recruiting Station since January 1. One of them is Erwin J. Rose, 19, Kewaskum, who enlisted for two years on January 4.

Frank Heppe, postmaster, announced that postal receipts for the Kewaskum Post Office set an all-time record in 1948. The amount of money taken in through the sale of stamps amounted to \$53,460.67, as compared with \$13,500 in 1947, an increase of \$39,960.67 or better than 400 percent. Kewaskum will advance to a first-class office effective July 1 because post offices are required to become a first-class office if there are receipts of \$40.000 during the year.

Thieves forced their way into the Bauer feed store and Brittingham and Hixon Lumber Company office in Campbellsport during the night Wednesday and escaped with loot estimated at \$100. It's reported two young men were in a Kewaskum tavern and left, headed toward Campbellsport. # **Check It Out!**

Happy New Year to all. I have returned from my international travels and am ready for all the excitement that 2024 is set to bring. I hope you had a safe and pleasant holiday.

Two thousand twenty-three was an eventful year for us at the library. We welcomed many new opportunities in services, staff and materials. Here is a recap of last year at Kewaskum Public Library.

We started out the year with a new book club, Banned Books Club, and encouraged readers to celebrate their freedom to read. We also began an end-of-life series featuring decluttering, advanced directives, and funeral planning programs. A couple of new databases were added to our collection including Universal Class, a valuable resource which promotes our mission to support lifelong learning.

In early spring, we had a staff in-service day and had training in mental health from NAMI and dementia training from the ADRC which has made us a dementia-friendly library. Also, in early spring we introduced create at home check out craft kits for all ages. Every month there is a new kit for kids, teens and adults to keep for a week and create an amazing craft. Each kit includes instructions and most of the supplies needed.

Besides the create at home check out kits, the library welcomed another new feature that began in 2023 – Adventure Passes. These passes allow families to attend area attractions for free.

Venues are Schlitz Audubon, Fond Du Lac Children's Museum, Above and Beyond Children's Museum in Sheboygan and Kettle Moraine YMCA. Furthermore, with a generous donation from Kewaskum Public Library Foundation, Inc. we were able to offer county zoo passes. We hope to add to our adventure passes in 2024 and your generous donations will enable that.

Summer saw another amazing program to alleviate summer slide; "All Together Now – Bee a Summer Reader." We met with local beekeepers, saw a magician disappear inside a balloon, hula-hooped on the lawn and created not one, but two community quilts which are hanging in the library and will be on display in our new location this year. The summer program ended with nearly 280,000 minutes read by our participants. Great job Kewaskum!

September brought us Library Card Sign-up Month with a record amount of new card registrations. I think one of our most favorable achievements in September was going fine-free for kid and teen items checked out at our library and reducing some other fines for adult material.

Technology-wise, in 2023 we replaced computers for the public (and staff) as needed and began using RFID pads. You may have seen these in the library and essentially, RFID tags are machine-readable labels that allow materials to be checked out without a barcode scanner; bringing us one step closer to self-checks at our new location.

All in all, 2023 was a great year for Kewaskum Public Library. We checked out nearly 47,000 items physically and electronically, had 177 programs with 4,900 attendees and had more than 23,000 people walking through our doors. Looking forward to 2024!




mentoring, tutoring, and Peers for Peers. My sophomore year, I was the Kewaskum representative at the Wisconsin Leadership Seminar.






The last article explained in what fashion South Eden was used as a reference point. In this piece, South Eden will be defined by using credible sources such as the people who live or once lived within Eden Township's borders who can vouch for South Eden.

#### From the North

To define South Eden, let's first knock off areas in Eden Township which do not qualify. When defining something, sometimes it's best to start with figuring out "what it is not." I once ask Bob Meier, "What was South Eden?" Giving me an answer that as generic, somewhat correct, and not offensive, he answered, "Anything south of B." This (I think) was a joke, or a way to avoid a difficult question from a man raised in Empire. Either way, it was a start. So when looking at an Eden town map, this wipes off the northern third (Sections 1-12) as not even remotely qualifying.

This was seconded by Carol Murphy, Eden Town treasurer and preservationist of family, Eden, and surrounding area history. Carol said South Eden "didn't go as far as B." In fact, all those sourced on South Eden research concluded the lands touching Hwy B and to the north of the township should be excluded.

#### From the East

Then what is excluded out of South Eden on the east? When asked where South Eden was, Dick Guell said, "Probably from V, west." This was an interview at Anne Koenig's kitchen table, and both suggested where they were standing was not South Eden. Mr. Guell, town chairman, aptly noted V as a good slice through the township separating South Eden's vicinity. And this is seconded by others, including Marvin Heimermann (1934-2023), who attended Lafayette School west of V around 1940. Marvin then lived on V, but on the east side south of F.

Carol Murphy also said South Eden "Probably goes up to V," and that anything east of Hwy V is not considered. Looking at Hwy V as a diagonal line through Eden Township, this essentially excludes half the township running down from Marblehead en route to Campbellsport through the township (which ends at Sunset Drive).

Using V as a divider, this excludes most of the Section 16, 22, 27 and 35. I say "most" because those sections have slivers of land west of V that could qualify as South Eden. However, full sections excluded from South Eden — beyond the ones mentioned north of B, are Sections 13-15, 23-26, and 36. In committing to V as a divider, routes out of South Eden's range include Meadow Road and Middle Road.

#### From the West and Leo Reilly

When asked about the topic of South Eden, nobody said Byron Township has any stake in South Eden. Most agreed that K serves a stout barrier as South Eden's western borders. This is easy, because K forms the Byron/Eden town line.

One clearly defined western portion of South Eden was Hilltop Drive. Ann (Lloyd) Grahl grew up in South Eden, and attended Burroughs School where Hilltop and Campbell Drive converge. Hilltop Drive runs parallel and east of K, and both hit Hwy F. Ann is proud of her roots in South Eden, and notes from her perspective that the area between the old Burroughs School to Ethan Allen School (where Hilltop Drive ends at F) was central to the definition of South Eden.

Even more west of Hilltop was Leo Reilly, whose farm again and again came up as a South Eden location. His original farm was on F and K but in

Eden Township. However, whether K and Campbell Drive's intersection at the bottom of Eden counted as South Eden was less obvious. However, Ann's perspective on Hilltop Drive north of Campbell is a credible definition within South Eden.

Please recognize it was easy agreeing on excluding what was north of B and excluding what was east of V when it came to defining South Eden. It is harder to conclude what is the southern most portion of South Eden. It was easier to say Leo Reilly's farm was as far west as you could go for South Eden. However, some sources indicated southern South Eden extended into Ashford Township, but hugging Campbell Drive (or what some used to refer to as Cty Y). It was much easier to regard what was too far west of South Eden than what was too far south.

Leo and Fern Reilly's farm was both as far west and as far north as South Eden went. Going back to the point that sometimes it is easier to define what is something by "what it is not," this is the case with Hundertmarks and South Eden. The Hundertmark Farm on K is not South Eden because it is between the old Leo Reilly Farm on F and Hwy B. And although it's technically the next farm on K to the north of Leo Reilly, Carol Murphy concludes it was Leo Reilly who was South Eden. But recognize too that Leo Reilly was Irish, and went to St. James, and his 17 siblings grew up on Timberlane Drive south of Scenic. It's interesting had Leo not settled on that farm by the 1940s if it would still be considered South Eden.

Carol said Leo Reilly qualifies because he's on F. Then Carol made a mental map down F from Leo Reilly's at midcentury, "And John Murphy would be, but he's on the other side of F [north side]. And Vince Ryan/Mary Ann Ryan." Carol was looking at the 1950s plat when she was explaining what South Eden was, and the numerous farms on F it included.

#### **Hollows and Hills - Narrow Definition**

Now, other features of South Eden were its hills. For example, one of the reasons Hundertmark's is out of South Eden is it is removed from the elevation and dips that define it. Recognize that the Hundertmark farmstead is on a downhill line to the F and K intersection, but the location and the slope is very different than land by Scenic and Timberlane Drive's intersection.


The importance of the topography in defining South Eden was seconded by Phil Majerus. So where is South Eden? "Well, South Eden was the Majerus farms in there and Ryans and Maurice Ryan and Isadore Flood." Phil's definition prioritized Timberlane Drive and Scenic Drive.

When asked for names just outside of South Eden, Phil said, "George Johnson would be out of there." George Johnson would be out of it? "Yea,

he wouldn't be in it." Other names came to Phil. "Norbert Pietz [1924-2006]. He would be out. He'd be out on the flat ground. Vincent Ryan was out." Phil was more firm that Pietz and Vincent Ryan were too flat. Understand Vincent Ryan (1931-2000) likely would claim to be in South Eden, but his land contrasts to Baumhardt's Hill on F, or the farm Jack and Irene Majerus worked on the corner of Timberlane and Scenic Drive.

When Phil was asked to verify if South Eden was defined by the hollows, he reaffirmed that South Eden is hills. "Yea. Go through the hollows. And the Vandergrinten farm is right down in the bottom of it, I always thought of it. And Harlans are on the edge of it." So what is the appropriate place for South Eden? "I think Jack's old place down on the bottom. Right where [Lou Anne] Daniels lives – the Vandergrinten Farm." This puts Phil's definition of the heart of South Eden on the corner of Timberlane and Scenic, as the Vandergrinten Farm and Harlan's (Tommy and Frannie) were kitty-corner on that intersection.

Phil was particularly respectful of the Harlan Brothers, and the fact that if they were still alive, they would be some of the best ones to interview on the history of the area.

#### **Broader Definition**

While Phil Majerus's definition of South Eden is narrower, Bob Flood's is broader. Could he define South Eden by old Eden standards in 1940? "Timberlane Road. And F. All the way down to what's now Campbell Road. South of that wasn't, but north of that was. The McCarty's were very farthest south you would get in South Eden."

To Bob, it basically followed the area for the Flood Oil route. This was validated by former Ashford chairman Joe Koch, whose old neighbors (the John and Katherine McCarty homestead) were north of him at the end of Rolling Drive. McCarty's used Flood Oil; Joe's family had a different fuel serviceman.

Still, Bob concluded even portions of Ashford Township were considered outlying areas of South Eden. But he was firm Campbell Drive (or what old plats called Y) really was a dividing line. So was the Johnson farm considered South Eden? "I don't know if we ever considered them South Eden." Bob's point was that many would consider that the base of the farm is on the south side of Campbell when it comes to the Johnsons. In con-



trast, Bob pointed out McCarty's "are on the north side."

Other associations to South Eden included extensions by the bottom of Eden township, but west of V. For example, Bob continued, "And then probably like Wheel Road, was as far southeast." This was getting into the vicinity of the old McNamara Farm. However, when you get to the old cheese factory, Bob said that was a little too far to the southeast of South Eden's definition. "Joe Bertrem's Cheese Factory we called it. Somewhere down there, they might be a little too far southeast."


Still, Bob brought it back to many key elements of his definition, that South Eden was north of Campbell Drive, and anything on TImberlane Drive north of Campbell Drive. Then St. James? "Oh yeah. It was definitely St. James." But V stopped it? "Yea. V stopped it."

Bob's definition might be expansive, but he did narrow the heart of it. "Tom Flood was definitely South Eden." So it includes Scenic Drive. And what about the Harlan Brothers? "Yeah. I'm thinking Harlans was in the middle of it. They were right dead center of South Eden.

#### South Eden Expanding

What is noteworthy in studying South Eden was the fact that it was an area that both stayed small as well as expanded. Most interviewed agreed the location's center was around Scenic and Timberland Drive's intersection.

Here are some examples of how South Eden borders broadened. Take for example a position such as Bob Flood's that South Eden was to the northern end of Timberlane Drive just off of its connection to V. For one, that point on Timberlane Drive between V to F could have been "Floodville" looking at 1800s plat maps. There were many Floods, but one was Isadore Flood, who farmed on the corner of F and Timberlane, but note in time his son Tom Flood Sr. would settle his farming life on the east end of Scenic Drive. Because the Floods are synonymous with South Eden, this is one of many examples of how the defined area

broadens. And there were many other Floods in the South Eden vicinity besides the ones mentioned in this article.

It's just like the Reilly 17 of Kit and William Reilly. They farmed south of that intersection of Scenic and Timberlane and are closer to the heart of South Eden. So when their son Leo Reilly settles by F and K, a key South Eden name moved the outer edges of the definition.

Carol Murphy aptly pointed out that South Eden is defined by St. James. But even that church moved. The first Catholic church was built on what today is referenced as "Murphy's Hill" west of the intersection of Scenic and Timberlane. However, by 1865 that first log church was no longer in use, and the base of the congregation moved to Highway F where St. James cemetery still remains.

In time, many people's roots were in South Eden, and their children may have stretched the borders. My conclusion is that Vincent Rvan is South Eden. not as much in geography, but certainly in character. He too had bloodlines of Harlans and Clarks that push closer to the defined center of South Eden. In addition, the Irish Catholic small farmer demographic makes Vincent qualify.

What was special about those from

South Eden is they never lost that admiration for South Eden. Any old timer will tell you the old cabin in Skunk Hollow is South Eden, but Herman Rehorst could not stay there as much as he'd like as he aged and is more known by elders as the man who lived with Emmy Knickel well east of V and south of F in the Town of Eden around 1950. This caused many neighbors on that side of Eden Township to be well aware of this South Eden tie, even if Herman no longer lived in Skunk Hollow. There was and is a respect for South Eden and its history on that side of the Township that partially is related to the stories of Herman. Likewise, folks like Harold Flood and Ray Ryan grew up in South Eden, but moved to Eagle Road. Although they did not die as South Eden residents, their respect for that location never left them. That respect for South Eden continued in Harold's two children, Mary (Dwyer) and Dave. In addition, Ray's daughter Joan (Wettstein) uses the term South Eden too.

Overall, there is something different about South Eden. Was it the stories of the old priest Fr. McFarland, or the story of Herman Rehorst's cabin? Maybe it was just how the Irish farmed. Somewhere in a conversation about the old days and the old St. James Church, Anne Koenig said it best. She was not from the area. When she settled by F with her husband Mark, she was still not in South Eden but it was very apparent her neighbors knew the stories of South Eden. One cannot understand it unless they heard it themselves nearly 70 years ago. When it came to old South Eden, she said, "It was almost like a legend."

She's right.

And that's why it's right to support South Eden's permanent place on the Fond du Lac County Map. The fixed location will insure these stories shared will remain in the future. I support South Eden being put on our maps out of respect to my ancestors and their faith, a faith not only in God but in their friends and fellow farmers.

so far. Pickering's personal highlight was placing fifth out of 16 girls at a recent tournament, and Batzler placed second at a tournament in Menasha.

"They were both pretty nervous their first matches, but they continue to improve," noted Heisdorf. "Both have set a goal to make it to state. They practice as hard as anyone else and Emma even does private lessons with her AWA (Askren Wrestling Academy) coach. They want to learn and ask questions and they aren't afraid to wrestle the boys. They have had a great start to the season.

"Bella is 11-4 and Emma is 10-4," he continued. "They have three more girls' tournaments coming up in January and then will wrestle in the Campbellsport sectional February 17 to try and earn a trip to state."

It should also be mentioned that Pickering is not only wrestling this winter but also playing basketball, as well.

She said, "I love both sports and I couldn't pick which one to do. Even though it's hard to balance both and academics, what I do is – when I have late practice for basketball – I will go to wrestling practice at 3:45 and then to basketball practice at 5:30."

Pickering also mentioned that she enjoys the physical aspect of wrestling while Batzler named a few more things she enjoys about the sport.

"I enjoy the pressure of big matches [and] the struggle at practice because it is a constant reminder that not everything is just handed to me, and I enjoy the team and community around me," she said.

As for how the team has adjusted to the addition of the two freshmen girls, Heisdorf said, "The team has been very accepting of the girls from day one and they help them out in practice and are willing to drill or wrestle live with them"

When asked if it matters to them if they wrestle a boy or a girl, Pickering and Batzler had similar opinions.

Batzler added, "Sometimes I truly believe I am a better wrestler and I just get out-muscled. That could happen with a girl, but I think it just happens more with wrestling the boys."

"It's so much fun," she encouraged. "In sixth grade, I convinced Emma to try wrestling and she loved it! So, for other girls, I would say if you are thinking about it, try it. It will only help you physically and mentally," she said.

As of right now, Costello said there are no girls currently interested in eighth grade, but there is interest in the sixth and seventh grades.
