Joshua Onwunili Qualifies for State Track and Field Championships after a Whirlwind Season

It was unknown whether Campbellsport High School senior Joshua Onwunili would have a chance to run at the Wisconsin Interscholastic Athletic Association (WIAA) 2024 State Track & Field Championships when the season began, but after a week of backlash aimed at the WIAA urging them to “Let Josh Run,” they overturned their decision, granting him a waiver and the opportunity to compete starting with Regionals on Monday, May 20.

At the Division 2 Kiel Regional, Onwunili placed first in the 100 meter dash with a time of 10.76 in the finals, 10.64 in the preliminaries, and first in the 200 meter dash with a time of 22.09. He also ran in the 4x100 meter relay team that placed third with a time of 44.90.

Onwunili was homeschooled his freshman year but participated in Campbellsport athletics (soccer and track) and continued to be homeschooled his sophomore and junior years while he was with his parents, who are doing missionary work in Ghana, Africa.

Campbellsport Track and Field Head Coach Derek Toshner recalls Onwunili was “definitely talented back then,” but also a bit more fragile. He kept getting injured in soccer and pulled his

hamstring in track that season. “He pulled his hamstring in a race at about 70 meters, walked across the finish line, and still took third. So, I knew he was pretty quick.”

He returned to Campbellsport for his senior year “so he could acclimate back into the U.S. culture before going to college here next year,” said Toshner.

As of March, he’d been accepted at UW-Oshkosh, but desires to attend UW-Milwaukee. As of May, he is still undecided and waiting to see how the track season pans out. His aim is to study finance.

Onwunili came back to the United States alone, taking residence with his aunt, while his parents stayed in Ghana. Despite his parents still owning a home in Eden, he was considered an ineligible transfer student by the WIAA.

As stated in the WIAA Transfer Rules and Waivers Quick Facts found on their website, “Students entering 11th and 12th grade as transfer students are restricted to non-varsity athletic activities for one calendar year (365 days beginning with first day of attendance at the new school).”

One of the provisions states, “The residence

On Memorial Day, there are two distinct categories of citizens which honor those who made the ultimate sacrifice for America's freedoms. The first and foremost is people with the actual experience of having lost someone during the throes of an armed conflict. These are the Gold Star Families. They've suffered the most as a direct result from having received official KIA (Killed in Action) notification from the military. All the parents, spouses, children, siblings and other relatives who bear up under this terrible tragedy. To them, our collective hearts and thoughts go out. Even if we can't begin to personally grasp the true depth of their sorrow. A person cannot unless it's happened to you. That is truly the highest price paid among the living.

Closely joined by active duty personnel who came home while members of their own unit,

perhaps individual squads, didn't. Is there any wonder about the reason behind the trauma and nightmares, the PTSD endured once they're back in the world? How does anyone ever get over their time spent in country, what was seen, felt, only survived? Beyond most of our unimpacted imaginations.

A fairly large portion of the population, whose own family comprise the ranks of veterans (who served during peacetime) dwells in a protected, sheltered world. Safe, distant from the din of battle.

Occasionally though, the point is driven forward quite sharply. Mom recalled once watching a flag-draped coffin being unloaded from a train on Main Street in the Village of Campbellsport. Possibly the repatriated remains of a WWII soldier or then current Korean War infantryman.

Skip ahead to 2024. How could anybody ever say these fallen heroes were "suckers and losers?" Many are blessed to be uninjured by the wounds of war – which may never totally heal. But we also remain resolved, *lest we forget*.

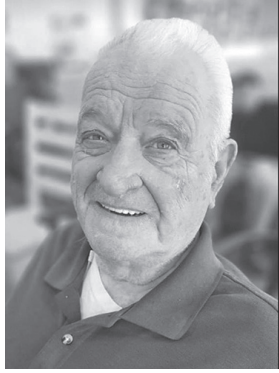
He lived true to himself up to the very end. When he wanted to go somewhere, he got there fast.

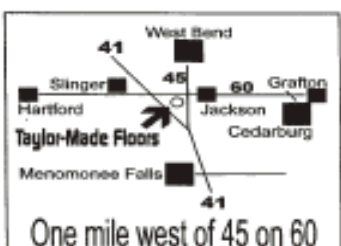

5 Years Ago

June 6, 2019

At about 9:30 a.m. on May 30, Kristy Vogt was sitting in her office at Westbury Bank in Kewaskum, when she smelled something hot. The branch manager and other employees searched inside the building but didn't find anything burning. Two employees walked outside and saw smoke coming from the roof. There weren't any customers inside at the time and the six employees existed safely. Kristy called 911. Kewaskum Fire Department received assistance from the fire departments of West Bend, Boltonville, Kohlsville, and Newburg. There were five brothers in the vehicle, and they were on their way to soccer practice. The cause of the accident is under investigation, but speed appears to be a contributing factor, according to Germantown Police Chief Peter Hoell. Mary Hetebreug, the aunt of the boys' mother, began a GoFundMe page to help the family with automobile replacement.

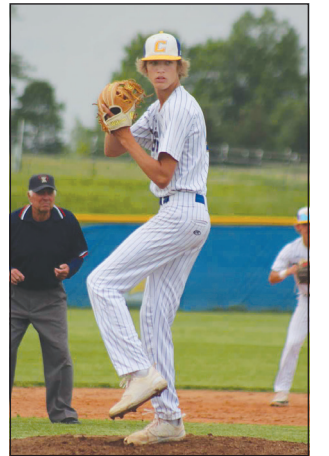

and transfer requirement may be waived, if requested in advance (of student participating at new school), by a member school on behalf of one of its students and upon presentation of documentation detailing extenuating circumstances. Such documentation must include communications from (a) parents, (b) person(s) with whom student is living within requesting school's attendance boundaries and (c) school officials within whose attendance boundaries parents reside. Depending upon the nature of extenuating circumstances, eligibility may be limited to nonvarsity competition."

Campbellsport submitted an initial appeal at the start of the school year which resulted in the first denial and Onwunili's inability to participate in other varsity-level sports.

A second appeal was made before the track season began, and despite his mother returning on Wednesday, May 15, Onwunili was denied again and prevented from competing at the varsity level, which included the conference meet at home on Friday, May 10, where the boys' team placed first in the Flyway Conference for the first time in 51 years.

In a meet which included college athletes and two Olympic trials qualifiers in mid-May, Onwunili ran a 10.30 in the 100 meter dash, which would top the current WIAA high school record of 10.33 set by Michael Bennett from Milwaukee Bradley Tech in 1998.

When Toshner had nearly given up, he created a post on Facebook in hopes it might reach some other athletes and coaches he is associated with, that's when the media got wind of what was happening in Campbellsport.

Upon learning another piece of legal evidence

would be required for the WIAA to grant the waiver, lawmakers got involved.

Among them was Wisconsin State Representative Ty Bodden (59th Assembly District) who collaborated with Rob Brooks (60th Assembly District) and Duey Stroebel (20th Senate District) in writing a letter to the WIAA encouraging them to reconsider their decision.

Part of the letter reads, "Josh Onwunili's story is not just one of athletic capabilities; it is a testament to resilience and determination. He has faced unique challenges, including significant relocations due to family circumstances, yet he has remained committed to pursuing his passion for running."

Assisted by local assemblymen, word got to Glenn Grothman, U.S. Representative, who helped get the attention of Washington D.C. and Scott Sternberg on Capitol Hill who all assisted in acquiring the legal evidence that was needed for the WIAA to overturn their decision and grant Onwunili the waiver on Friday, May 17.

With his performance at Regionals, Onwunili qualified for the Sectional in Freedom on Thursday, May 23, where he placed first again in the 200 and 100 meter dashes with a time of 21.60 and 10.76, respectively.

With the two first place finishes, Onwunili has qualified to compete in the 100 and 200 meter races at the state meet in La Crosse, occurring this weekend, Friday, May 31 & Saturday, June 1. Division 2 preliminaries begin at 3 p.m. on Friday with finals beginning at 10 a.m. on Saturday.

In regards to the events of the season, Campbellsport Athletic Director Thomas Griesemer said, "They [the WIAA] were following the membership rules, and in the end, the process worked out for Josh."

Not only is Toshner glad Onwunili was final-

ly granted the opportunity to compete as a varsity athlete, he also adds "I'm glad the crowd gets a chance to watch him because he is an amazing athlete," he added.

Earlier in the season, Toshner said, "I believe Josh can qualify for the USA U20 Junior Nationals. This will allow him to be seen by universities for potential scholarships."

Interestingly enough, Onwunili didn't fully realize how fast he was until after running the 100 meter dash at the track meet in Omro on Tuesday, April 30.

"I was kind of hoping to get something (time) that might be a little bit faster than the Campbellsport record," Onwunili remembers. "When I finished, Derek [Toshner] was like, 'Dude, do you know what you just ran?' He showed me the time and told me the time and I didn't believe him."

In an unusual circumstance, a starting gun was forgotten for the meet and the electronic timing system was used in its place along with a whistle. In what might have been Onwunili's last chance to run for the team on JV, he recorded an official time of 10.14. However, stopwatch times ranged from 9.9 to 10.02 to 10.06, the time Toshner clocked him at.

It was then that Onwunili realized his full potential.

"There's a possibility that he'll be the fastest kid in all of Wisconsin, but time will tell. It will definitely be fun to watch," Toshner concluded.

To all the people that supported Onwunili this season, he wanted to say thank you to everyone.

"It was a group effort. It wouldn't have been possible without every single person that helped along the way...It was crazy. I've never seen something like that," Onwunili said.

For those unable to attend the state meet, the NFHS Network will be streaming the event.

Coho at Port Washington

Hello friends,

I am currently in what could be termed as an overscheduled time in my life. Fortunately, what is on my schedule is all good, such as hobby farming, pond building, volunteering, a litter of pups and, in just a few days, my daughter Selina is coming home from Missoula, Montana, for a wedding. The crazy stuff will end or slow down after the 4th of July.

This week's column is about paddle trolling out of my canoe on Lake Michigan at Port Washington for coho salmon. This spring, the coho fishing has been incredible on Lake Michigan, and I thought it would be fun to see if I could catch one out of my canoe and live to tell about it.

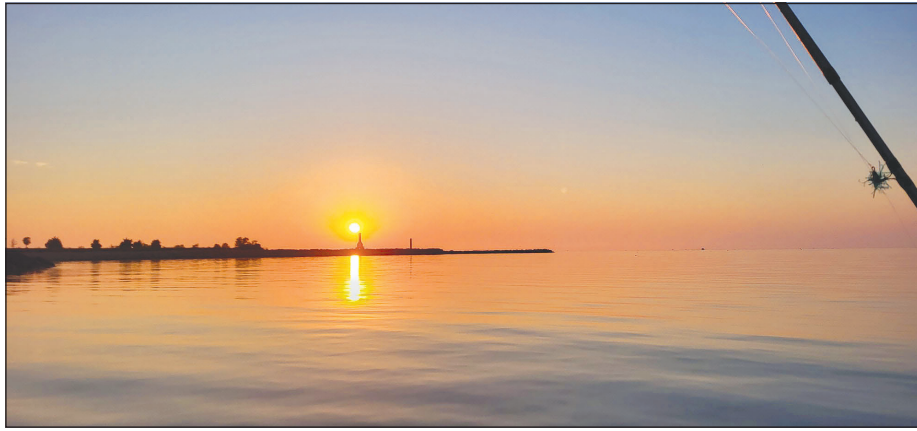
Friday, May 24

High 67, Low 47

One of the main challenges in paddle trolling for salmon and actually catching a salmon is to be able to paddle your canoe fast enough to make your lures work to attract a salmon. Speaking of canoe fishing for salmon, how come I have never seen another person fishing for salmon out of a canoe?

Anyways, here is the scoop, I put my canoe in at a beach in Port Washington and after rigging three poles, one with a spoon and two with a flasher/fly set up, I was headed out to sea. In reality, you have to be in at least 30 feet of water before you start to set lines, and it was interesting as I worked my way east and was passed by dozens of both charter boats and private boats that were headed out to at least 100 feet of water.

The wind was minimal, and I made a goal of paddling to 100 feet and that

is what I did, which took me about 90 minutes. I did not have a strike, did not see anyone else catch a fish and kept fishing until an hour after dark. Because I did not have a lodging plan, I slept in a Walmart parking lot in the GMC Hotel.

Saturday, May 25

High 89, Low 50

I was moving at 4:30 this morning, and as soon I got out of the truck after a pretty pathetic night's sleep, I decided that I needed some calories, so I chugged a nutrition drink, which I do often as it is quick, reliable calories. Very bad luck came my way

when I realized that my breakfast was curdled, and that was a very unpleasant experience.

Today was going to be a big mile day as I was going to go as deep as I could and hopefully catch a coho. I headed southeast as that is the direction the wind was from, and I figured it would push me back to Port Washington. Nothing was happening for me, and I paddled to where I could easily see the buildings in Milwaukee and at 184 feet of water, I figured I had better start working my way back.

I had been in the canoe for six

hours, and generally, I am on my knees. Seven hours into my journey, I was back to 50 feet of water and something hit a clown-colored crankbait that I was pulling. The coho jumped several times, and I was one happy camper when it made it to the net. I figured I had better work this area a bit longer and within minutes had another coho hit a flasher/fly. I was about to net it and the manufactured knot came out, and I watched my quarry swim away with the fly in its mouth.

After nine hours, I hit a very crowded beach and was one happy camper. My goal of catching a salmon out of my canoe had been met, and physically, the experience did not kick my butt.

It's also important to inspect your life jackets for wear and tear. Most inflatable jackets should be checked for leaks every six months, and the cartridge should be checked before each use. The jacket manufacturer's website should have instructions on how to check your life jacket status.

Follow the safety tips below and enjoy Wisconsin's great lakes and rivers with family and friends.

- Sign up to take an online boater education course.

- Always wear a properly fitted and fastened life jacket when you're on or near the water. A life jacket will keep you on top of the water if you walk off an unexpected drop-off, a wave or current overpower you or you fall out of a boat.

- Enjoy the waters sober and know your limits. Alcohol blurs a per-

son's judgment, reaction time and abilities.

- River shorelines and sandbars pose unseen dangers. Higher, fast-moving water can tax an individual's boating, paddling and swimming skills.

- Keep an eye on the weather and always tell someone where you are going.

Be ready for the unexpected, and always wear your life jacket. Learn more boating safety tips on the DNR's Boat Safety webpage.

Volunteer Rediscovered Rare Plant Not Seen in Wisconsin for Over 100 Years

The Wisconsin Department of Natural Resources (DNR) announced that a population of Maryland senna (*Senna marilandica*), a rare plant not seen in Wisconsin since 1911, was rediscovered in southwest Wisconsin.

George Riggan, a trained volunteer for the DNR's Rare Plant Monitoring Program, and Bridget Rathman, DNR Habitat Biologist, spotted the plant.

This discovery and others are featured in the Rare Plant Monitoring Program's 2023 Annual Report. Al-

most 15% of Wisconsin's 2,366 native plant species are considered rare, meaning they are listed as endangered, threatened or of special concern.

In 2023, more than 50 trained volunteers from around the state submitted 178 reports of rare plants, including 31 populations in areas of Wisconsin where they had not been documented before.

"I am continuously impressed by the botanical knowledge, enthusiasm and commitment to conservation that we see from our volunteers.

Their efforts play a significant role in helping us understand the state of rare plants in Wisconsin and inform how we might conserve them," said Jessica Ross, DNR Rare Plant Monitoring Program Coordinator.

Since 2013, the DNR's Rare Plant Monitoring Program has trained and sent volunteers to check on the health and size of rare native plant populations in nearly every county in the state. The volunteer program is Wisconsin's largest source of rare plant data. It is unique in the Midwest for its breadth of surveys

statewide.

Become A Rare Plant Monitor

Rare Plant Monitoring Program volunteers are trained in surveying techniques, including accurately estimating large plant populations, assessing habitat conditions and using GPS coordinates to locate and mark rare plant populations. Training is online and can be completed at any time. While formal plant identification training isn't required or included, successful volunteers often have

Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
