Campbellsport FFA Starts Summer Overseas

This summer, members of the Campbellsport FFA embarked on an educational journey to Ireland, where they explored the rich agricultural traditions and modern farming techniques. The trip was packed with diverse experiences, from historic sites to advanced farming operations, offering students a comprehensive understanding of Irish agriculture.

An All-Star Coach

Jason Piittmann of Kewaskum has been selected to coach in the 2024 All-Star Football Game on the weekend of July 20 at the University of Oshkosh.

The All-Star Football Game is a yearly summer fundraiser where high school players from all over the state are nominated to play in the event. Two-hundred-and-twenty players are chosen to participate along with eight coaches. According to the Children's Wisconsin website, the tradition has raised over \$5.3 million for the Children's Hospital Foundation so far.

"One of my best friends in coaching, Bill Jacklin of Slinger, is the head coach. I am beyond honored that Bill asked me to be on the staff for this year's game," said Piittmann, when asked about his feelings on being chosen to coach this year's game.

Piittmann has been a long time coach for the school district in both football and softball. He has been instructing football players since 2003. In 2018, Piittmann took a step back from the position but returned for last year's football season as the 2023 head coach.

"I had been missing coaching. I was planning on being on Steve's (Tennies) staff in some capacity. When Steve informed me that he was leaving, I felt that I needed to apply for the head coaching position. I wanted to offer my experience to the program and help the young men with hopes to have a successful season," stated Piittmann. "While we finished a win short of the playoffs, I hope that I was able to help the kids have a good season."

Piittmann stated that coaching has always been a big part of his life and his passion stems from the desire to create athletes but, more important-

ly, well rounded young adults.

"Coaching is teaching. One of the areas I strive to make important for the programs I coach is in teaching character development. I get the blessing of being able to teach young people about being good adults - citizens, employers, employees, and eventually spouses and parents," stated the football coach.

Piittmann explained that he feels coaching is what you see under the lights on a Friday night game but the majority of what he does is teaching. Although coaching is important, students can't be successful without being taught and learning things along the way.

Throughout his time at Kewaskum, Piittmann has and continues to make an impact on the community. He has been inducted into the Wisconsin Football Coaches Association (WFCA) hall of fame, carries more than 140 total wins, achieved eight conference titles and has a variety of other accomplishments.

"I had the opportunity to speak at the KHS commencement ceremony in 2024. As I told those graduates, the numbers, awards, banners, rings and so on are nice but the real reward from coaching and teaching is the relationships I've built with countless students, coaches, and teachers. In kind of a unique twist of fate, we have five men on our coaching staff who have played for me, and another who is a KHS alumnus," said Piittmann.

Coaching in the 2024 All-Star Game will be Piittmann's second time receiving this opportunity in Oshkosh. He had the experience in 2016 and stated that he is still in contact with the friends he made through the program previously.

"Football is a great game that allows young men of all types to work together to make themselves into a group that works together to be successful," concluded the coach.

National Newspaper Association Files Postal Complaints with Postal Regulatory Commission for more than 200 Newspapers

National Newspaper Association (NNA) delivered letters from more than 200 newspaper titles to the Postal Regulatory Commission (PRC), complaining about inadequate mail delivery and escalating postage rates, on July 1.

The comments were part of a review by the PRC of its postal rate regulations, which it is required by Congress to do periodically. The Commission last completed a rate review in 2021 at which time it gave the US Postal Service authority to raise postage rates beyond inflation levels. The result for community newspapers has been an increase by 35-50 percent in postage costs in the past four years.

The PRC announced earlier this year, following widespread complaints by mail users that it would initiate a new inquiry on its regulations. Its determination will set USPS's legal authority to in-

crease rates for at least five years.

NNA Chair John Galer, publisher of the *Journal-News*, Hillsboro, IL, asked NNA members and newspapers in state newspaper organizations to send him their thoughts on the impact of the past few years of postage increases.

Responses registered a state of alarm on the future of the industry, specific complaints about delivery failures, losses of subscribers and unresponsive local postal authorities when delivery was not properly executed. Galer included the letters in NNA's comments to the Commission. NNA is also working with mailing industry partners on more detailed comments on the mechanisms involved in the rate regulation, including one provision that allows USPS to increase rates more when mail volume declines, which many in the industry consider a reward for poor performance.

"NNA has met with the Commission recently to explain our situation," Galer said. "We needed the Commissioners to understand that this situation cannot continue. The PRC is inclined to blame the Postmaster General for using every inch of rate authority that the Commission extended. But it was the Commission that laid the table for this disaster. With proper rate regulation, we would not be in the situation we now find ourselves in. Now, we have to be concerned not only for the future of our own newspapers but for the plummeting of mail volumes that threatens the very basis of universal mail service. It was not unusual this year to see complaints not only about late newspaper delivery but also about checks in the mail arriving slowly or not at all. Even first-class mail has become unreliable in many areas."

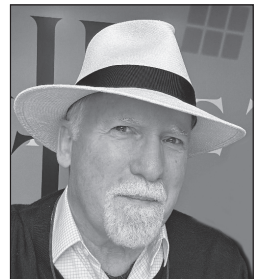

In an effort to make the Fond du Lac County Fair a sensory inclusive event, the Fond du Lac County Fair and SSM Health Treffert Studios are partnering to create a designated area on the fairgrounds to aid individuals and families who need a moment to regroup, as well as several sensory-friendly activities.

The sensory room will be located in the Expo Building with access by First Aid, and available July 18-21.

The sensory room is available for individuals with ASD and related disabilities including learning difficulties, developmental disabilities, or sensory impairments. It provides the ability to utilize the space to de-escalate in a safe environment. Individuals will be able to take a break in a quiet, air-conditioned space that includes a carpeted floor, calming lights, relaxing sounds, and interactive activities.

Patrons should check in at the Sensory Room when arriving at the Fair to gain a lanyard/wristband. The lanyard/wristband will be utilized to identify patrons with sensory issues to fair and carnival staff.

The Sensory Room in the Expo Building will be equipped with helpful tools such as weighted blankets, noise canceling headphones, and quiet activities to aid children and adults who need help processing the sights, smells, noises and crowds at the fair.

The sensory room can accommodate up to 12 guests. Individuals will be able to access the sensory room for that the room can remain available for anybody that needs to take a break and relax before continuing to enjoy their time at the fair.

Evelyn P. “Evie” Thiemer, 101, of Kewaskum, passed away on June 29, 2024, at The Fields in West Bend, with her family at her side.

Evie was born on April 12, 1923, in Milwaukee, the daughter of the late Rudolph and Emily (nee Hassinger) Kuehl. On February 10, 1945, she was united in marriage to Richard O. Thiemer at St.

5 Years Ago

July 18, 2019

Machinery started moving the earth in front of the Kewaskum Annex building on July 14 for the Wisconsin 9/11 Memorial. The excavation work is part of Phase One, which includes construction of the memorial's main rotunda and amphitheater. Work will also begin this year on Phase Four, which honors those who have served in the U.S. military. The memorial is being constructed through the donations and support of numerous individuals, organizations, and businesses from far and near. Mark Schairer Excavating, which is based in Kewaskum, is donating its services for the project. The company will do all the grading and excavating, including digging trenches and holes for the memorial's footings. Reigle Family Park will soon have a playground for area children to enjoy. With Kewaskum Elementary School purchasing a new and larger playground set this summer, the school's old playground equipment has found a new home at the village's newest park.

With the resignation of Jay Fisher from the Kewaskum School Board on July 9, there is an open seat on the board. The resignation occurred because he is moving out of the district. As outlined by state statute, the remaining members of the Kewaskum Board of Education will appoint someone to fill the existing vacancy on the board. Candidates must file a letter of interest in the district administrator's office by July 31.

Town of Farmington residents will have curbside garbage and recycling pickup starting in January. The Farmington Town Board voted on July 9 to approve Waste Management's proposal for curbside trash collection every week and recycling collection every other week at a cost of \$16.08 per unit per month.

At the Washington County Board of Supervisors meeting on July 10, supervisors voted 26-0 to approve the jurisdictional transfers of portions of County Trunk Highways DD and HH in the Town of Farmington and a transfer in the amount of \$640,000 from the General Fund to the Highway Department to fund the transactions. The Farmington Town Board voted 2-1 on June 11. At its July 9 meeting, the Farmington Town Board agreed that the funds received should go toward road maintenance.

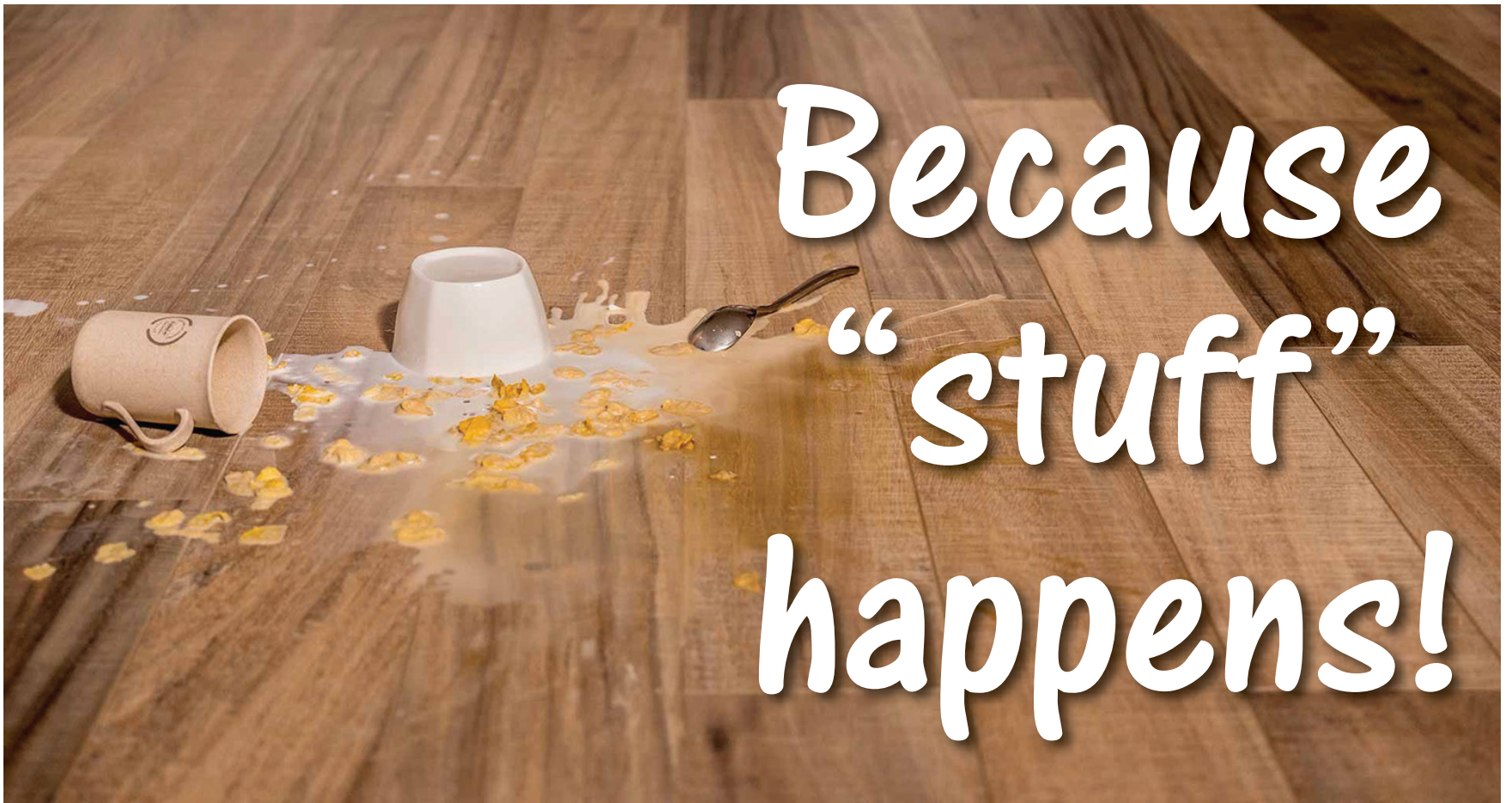

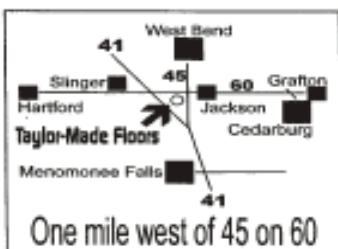

National Stud Farm. They learned about the breeding and care of Ireland's world-renowned racehorses. A visit to the Kilkenny Castle offered a glimpse into Ireland's medieval past, while a visit to an organic orchard demonstrated sustainable farming practices. Students learned about organic certification, pest management, and the importance of biodiversity in crop production.

The trip also included a visit to a robotic dairy farm. The students were fascinated by the technology and how it played into a small herd raised on pastures. At a vegetable and beef farm, the Campbellsport FFA members rolled up their sleeves and planted broccoli, gaining hands-on experience in crop production. They

also visited a strawberry farm, where they learned about berry cultivation and the challenges of growing fruit in Ireland's climate.

One of the trip's highlights was a visit to the Cliffs of Moher, where students took in the breathtaking views from the land and sea. Students were lucky enough to board a ferry and take a tour of the cliffs from the ocean. This natural wonder provided a scenic break from the farms.

The group also attended a sheepdog herding demonstration, witnessing the incredible skill and teamwork between shepherds and their dogs. This demonstration underscored the importance of animal husbandry and traditional farming techniques in Ireland.

Their educational journey continued with a visit to an

oyster farm, where students learned about aquaculture and the process of farming oysters. Students had the opportunity to try fresh oysters harvested right in front of them!

Throughout the trip, the Campbellsport FFA members gained valuable insights into the various aspects of Irish agriculture. By experiencing both historical and modern farming practices, they developed a greater appreciation for the innovations and traditions that shape agriculture.

This trip to Ireland was more than just an educational tour; it was an opportunity for the students to expand their horizons, connect with the global agricultural community, and bring back new knowledge and inspiration to their own agricultural practices in Wisconsin.

NOTICE OF REFERENDUM ELECTION

August 13, 2024

NOTICE IS HEREBY GIVEN, that at an election to be held in the several towns, villages, wards, and election districts of the State of Wisconsin, on Tuesday, August 13, 2024, the following questions will be submitted to a vote of the people pursuant to law:

2023 Assembly Joint Resolution 6
Enrolled Joint Resolution

To create section 35 of article IV of the constitution; **relating to:** the appropriation authority of the legislature and the allocation of moneys Wisconsin receives from the federal government (second consideration).

Whereas, the 2021 legislature in regular session considered a proposed amendment to the constitution in 2021 Senate Joint Resolution 84, which became 2021 Enrolled Joint Resolution 14, and agreed to it by a majority of the members elected to each of the two houses, which proposed amendment reads as follows:

SECTION 1. Section 35 of article IV of the constitution is created to read:

[Article IV] Section 35 (1) The legislature may not delegate its sole power to determine how moneys shall be appropriated. (2) The governor may not allocate any federal moneys the governor accepts on behalf of the state without the approval of the legislature by joint resolution or as provided by legislative rule.

SECTION 2. Numbering of new provision. If another constitutional amendment ratified by the people creates the number of any provision created in this joint resolution, the chief of the legislative reference bureau shall determine the sequencing and the numbering of the provisions whose numbers conflict.

Now, therefore, be it resolved by the assembly, the senate concurring, That the foregoing proposed amendment to the constitution is agreed to by the 2023 legislature; and, be it further

Resolved, That the foregoing proposed amendment to the constitution be submitted to a vote of the people at the election to be held on the second Tuesday of August 2024; and, be it further

Resolved, That the questions concerning ratification of the foregoing proposed amendment to the constitution be stated on the ballot as follows:

QUESTION 1: "Delegation of appropriation power. Shall section 35 (1) of article IV of the constitution be created to provide that the legislature may not delegate its sole power to determine how moneys shall be appropriated?"

QUESTION 2: "Allocation of federal moneys. Shall section 35 (2) of article IV of the constitution be created to prohibit the governor from allocating any federal moneys the governor accepts on behalf of the state without the approval of the legislature by joint resolution or as provided by legislative rule?"

EXPLANATORY STATEMENTS AS TO THE TWO QUESTIONS

Explanatory statement regarding Question 1:

The Wisconsin Constitution requires the legislature to appropriate funds from the state treasury only by passing a law, which requires a vote by both houses of the legislature. Wis. Const. art. VIII, § 2. Question 1 would add a new provision to say that the legislature cannot delegate this "sole" power to appropriate funds.

A "yes" vote on Question 1 would vote to create a new provision of the Wisconsin Constitution—Wis. Const. art. IV, § 35(1). That provision would prohibit the legislature from delegating its duty that it pass a law in order to appropriate money from the treasury under Wis. Const. art. VIII, § 2.

A "no" vote on Question 1 would vote not to add Wis. Const. art. IV, § 35(1) to the Wisconsin Constitution.

Explanatory statement regarding Question 2:

In times when Wisconsin receives undesignated federal funds from the U.S. government, the Wisconsin Constitution does not limit the ability of the governor to choose how the funds he accepts are divided among state and local agencies. Question 2 would add a new provision to the Constitution to prohibit the governor from choosing how to allocate such federal funds he accepts unless the legislature, through a joint resolution or some other process to be developed by the legislature, agrees with the governor's proposed allocation of those funds.

A "yes" vote on Question 2 would vote to create a second new provision of the Wisconsin Constitution—Wis. Const. art. IV, § 35(2), which would prohibit the governor from choosing how to allocate undesignated federal monies he accepts unless the legislature, by joint resolution or other process, agrees with the governor's proposed allocation of such funds.

A "no" vote on Question 2 would vote not to add Wis. Const. art. IV § 35(2) to the Wisconsin Constitution.

VOTING BY ABSENTEE BALLOT

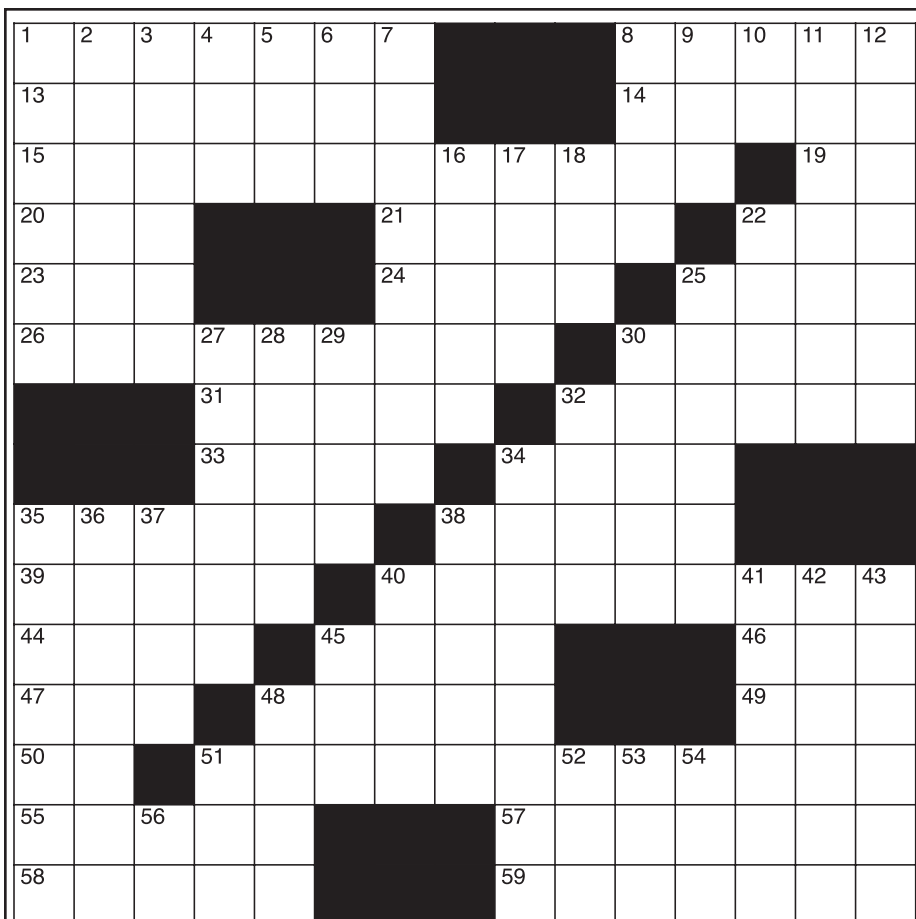

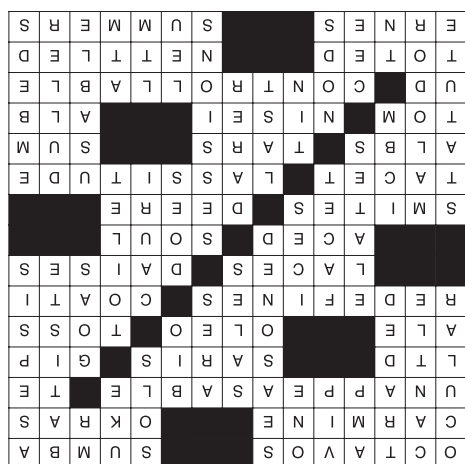

Timm won't be playing in the all-star game due to an ankle injury during the track season.

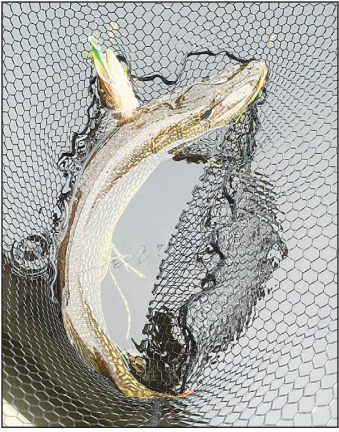

Hello friends,

Last week, and this one as well, I am writing to you about a seven-day, fly-in fishing trip to Shultz Lake in Ontario, Canada, where we fly out of Red Lake with Chimo Lodge and Outposts and have been for 42 years. We are a tight-knit group of guys and gals that share the same deer and duck camp, as well as our annual Shultz Lake adventure. For seven days, the only people we see are the ones in our group.

Wednesday, June 19

High 63, Low 50

Today would be a typical day of this seven-day adventure for myself, except there is no typical day when you fish hard for at least 12-hours a day and then stay up until at least 2 a.m. (but generally later). There are seven of us, and we trade partners each day so that we have a good chance of fishing with each person in the group.

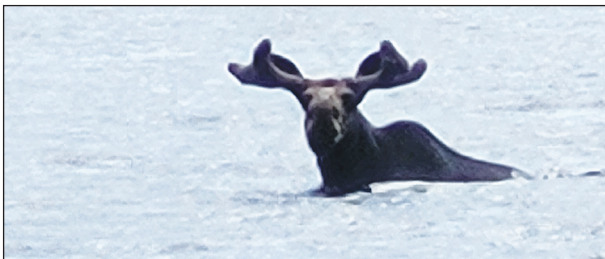
Today, Steve Mellone, who is from the Pewaukee area and new to the gang, would be my partner. My plan was to travel by boat for seven miles and

fish a challenge, the Reef Runner was on fire. Earlier in the week, my brother Mike had caught a 37-inch gator while bringing in a small northern pike. In other words, what happened was the big fish grabbed onto the little fish and would not let it go. Today, I honestly had the gator of the week do this same thing and fought it for 10 minutes in crazy winds and prayed it would not let go until it was caught, measured and released. As luck would have it, the gator let go of the smaller gator which was now "gatorburger" and the entire day, the Reef Runner, which I named The Demon, was insanely on fire.

I wrote last week that the weather was cold and windy and there was no tanning as it was long pants, sweatshirts and knee boots. One very popular activity for the gang is shore lunches. It may just be two guys in a boat filleting and feasting at some point in the day or the whole gang meeting up, relaxing, laughing and gorging. We ate fish all seven days, and life was good.

This year, by Friday, which was our last full day, I was exhausted by 6 p.m. I had been on the go in a powerful way since mid-March and it hit me hard. On the other hand, what we have here is seven men that all went to the same high school in Poynette with age differences of up to 42-years that are family and friends. We are at every wedding, graduation, funeral and, most importantly, fish and hunting camps and have been since my dad, the late Robert Walters, brought us together in the early 70s. If there is ever a disagreement, it does not get ugly and it is over about as soon as it starts. Dad's rule of no whiners, slackers or tight wads is non-negotiable, and we are pros at laughing together and just being ourselves.

P.S. The day we flew out, our good friend Pete Hagedorn, who is 86, was fishing by himself on Red Lake. Pete is the founder of Chimo and ran it and was a bush pilot until the age of 80. The day we left, Pete caught a 28-inch walleye while fishing by himself in a brand-new pontoon boat that he bought so he could take his 93-year-old wife Elizabeth fishing.

then portage our gear to another lake where there is a boat and motor. On the ride down, we had a beautiful bull moose swim very close to our boat before it noticed us and that absolutely made me think that I need to save some money and go on a moose hunt.

Yesterday, Steve was fishing with Jeff Moll and caught a 34-inch lake trout. We catch very few of them and after it appeared it would not survive, Steve decided to have it mounted. So far, Steve has the biggest gator "40 inches", has seen a bear, would see another today, saw the moose and today, we had a crazy day in the boat.

Each year, I try a new bait, and this year I went with a deep diving "up to 28 feet" blue chrome Reef Runner. I had purchased a three-pack and picked this color because I am very fond of the blue chrome Rippp'n' Rap which works either trolling or casting.

What happened today was that despite gail force winds, which made fighting and landing
