Digitizing Kewaskum Statesman Archives

Kewaskum Statesman archives are now available as word-searchable digital files. The archives date back to Oct. 5, 1895, when the first issue of the *Kewaskum Statesman* was printed.

The archives can be accessed on the Kewaskum Historical Society website, kewaskumhistorical-society.org, where each newspaper issue can be individually searched.

In addition, the archives are on *newspapers.com*, where a search can be done throughout the entire collection of newspapers with one click. While there is a fee to use *newspapers.com* at home, library patrons can access the *Kewaskum Statesman* archives on *newspapers.com* in the Kewaskum Public Library, free of charge.

"Kewaskum Public Library is very excited to add the resource of *newspapers.com* to our genealogy collection or local history collection. It's a free resource for any user to come in and view, download, print and share the *Kewaskum Statesman* from 1895 through the present," Kewaskum Public Library Director Lori Kreis said.

This service is made available to the Kewaskum Public Library through *newspapers.com* with support from Multi Media Channels and the Kewaskum Historical Society.

In addition to the new digitized collection, the Kewaskum Public Library has printed bound copies of the *Kewaskum Statesman* from 1980 to the present. Digitized copies of the *Kewaskum Statesman* from 2005 to 60 days ago are also available through the Wisconsin Newspaper Association, free of charge, on BadgerLink.

Until now, many of the newspapers published before 2005 were available only on microfilm or as printed copies. The existing copies from over 100 years ago had become very brittle, and many of the pages were crumbling and disintegrating.

About four years ago, volunteers for the Kewaskum Historical Society began working to preserve the newspapers by converting them into digital files. The first step was to contact the Wisconsin Historical Society, which has 66 microfilm reels of the *Kewaskum Statesman*. That microfilm was converted into TIFF (Tag Image File Format) files.

Then, using software that the Kewaskum Public Library has, the files were converted into digital files.

Important Announcement for Village of Kewaskum Voters: New Polling Location

As the Village of Kewaskum prepares for the upcoming Partisan Primary Election, residents are advised of a significant change in polling location. This year, voting will take place at the Kewaskum Fire Department, located at 1106 Fond du Lac Avenue.

What Voters Need to Know

Getting to the Polling Location: Due to ongoing construction on Fond du Lac Avenue, voters heading to the new polling location at the Kewaskum Fire Department, 1106 Fond du Lac Avenue, should be aware of some changes to routing. Vehicles can only travel southbound on Fond du Lac Avenue, so those approaching from the north will need to navigate an alternate route.

Parking: Voters should use the parking lot on the north side of the building. It is essential to park away from the entry to allow for clear access. Designated disability parking spots will be clearly labeled for individuals who require closer access to the building.

Entry Instructions: To enter the polling area, voters should use the west door on the north side of

the Kewaskum Fire Department. Following the signs will help in guiding voters to the correct entrance and ensure a streamlined experience on Election Day.

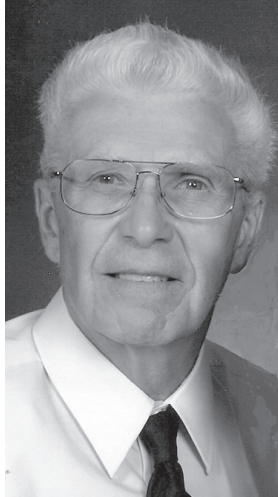

dancing with some polka every now and then, too.

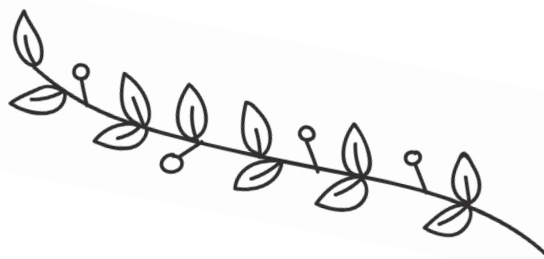

Smokey will be paying a visit to the Kettle Moraine State Forest - Northern Unit, Mauthe Lake Recreation Area, N1490 County Road G, Campbellsport, WI 53010, on Friday, August 9, 5-7 p.m.

Smokey's message of campfire safety is important whether you're camping in one of our state parks or forests or simply roasting hotdogs in your backyard – the same rules apply. Consider these safety tips when visiting a state campground and having a fire in one of our designated campfire rings.

- Keep fires small and manageable.

- Have plenty of water and tools handy to keep your fire in control.

- Only burn clean, dry wood (only use local firewood).

- Keep your tent and firewood a safe distance away from the campfire.

- Never leave fires unattended.

- Make sure fires are properly extinguished before leaving the site.

- Use a lot of water – drown, stir and repeat until embers are cold.

- Before your visit, check out the current fire danger on the WisBURN webpage (<https://apps.dnr.wi.gov/wisburn/#/>).

Just like extinguishing a candle in a home before leaving, it's important to ensure campfires are completely extinguished before leaving your site. Keep a bucket of water nearby along with tools like a rake or shovel, and use the drown-stir-drown-feel method. Burying warm or hot coals or using sand are unreliable methods and can easily rekindle a fire.

By following these steps, everyone can safely enjoy the cool nights by your cozy campfire. Remember, only you can prevent wildfires!

Spring Waterfowl Survey Shows Positive Results

The Wisconsin Department of Natural Resources (DNR) announced that data from the annual spring survey of breeding waterfowl is available. The survey indicated both stable population numbers and habitat conditions for migratory birds.

The information from this survey is part of the overall survey of breeding waterfowl in North America. It aids the DNR in making management decisions about waterfowl in Wisconsin, including hunting season structure and harvest limits.

The spring waterfowl breeding survey has been conducted every year since 1973, except for 2020. Survey results are best interpreted as trends over several years rather than year-to-year comparisons.

Surveyors estimated the state's breeding duck population to be 502,058 birds, a 3.7% decrease from the 2023 estimate but above the long-term average. The mallard breeding population estimate is 146,561 birds, 7.9% lower compared to 2023 and lower than the long-term average. The wood duck population estimate was 96,711 birds, similar to last year and above the long-term average. The Canada goose population estimate was 153,402 birds, similar to 2023 and significantly higher than the long-term average.

August 13, 2009

After parents in the Kewaskum School District took umbrage over the fact students' grades would no longer be affected by cheating and late work, the district stated Friday that the current grading procedures would remain in place. How long that policy will remain is unclear as the district will continue meeting with education consultants.

The reversal came after three listening sessions the night before where parents voiced their disgust in the idea. Approximately 50 parents and community members attended the listening sessions, moderated by the district principals, on August 6. The district's leadership team had included in the proposed changes eight of 15 guiding principles from Ken O'Connor, who had presented a seminar for teachers in April. In a prepared statement released on Friday, Kewaskum Superintendent of Schools Michael Krumm and Board of Education President John Kenworthy certified that feedback from the listening sessions pointed the board of education and Krumm to concentrate on six points. The points regarding cheating and late work were removed.

Kewaskum Public Works Director Jerry Gilles indicated this week that the new components of the new wastewater treatment plant are set to go online in three weeks.

The Washington County Sheriff's Department radio system is in testing stages with plans to be fully implemented and working by next March. The \$14.6 million system is coming in \$3.2 million under budget so far. The county is paying for the entire system.

A project that repaired 1,370 feet of failing water main has been repaired on Hillside Drive. The project also saw the entire stretch of village road being repaved.

On July 5, 40 young adults and eight leaders from Holy Trinity/St. Michael's went to Rockford, IL, for Catholic Heart Work Camp. The theme of this year's work camp was Love Repeated. Margarete Buck was one of those on the trip. The weekend before camp, she had a patio and shed slab frame dug. During the camp, the concrete was poured. 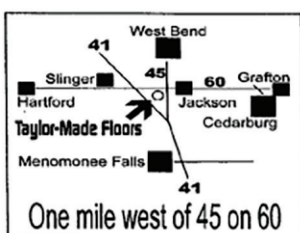

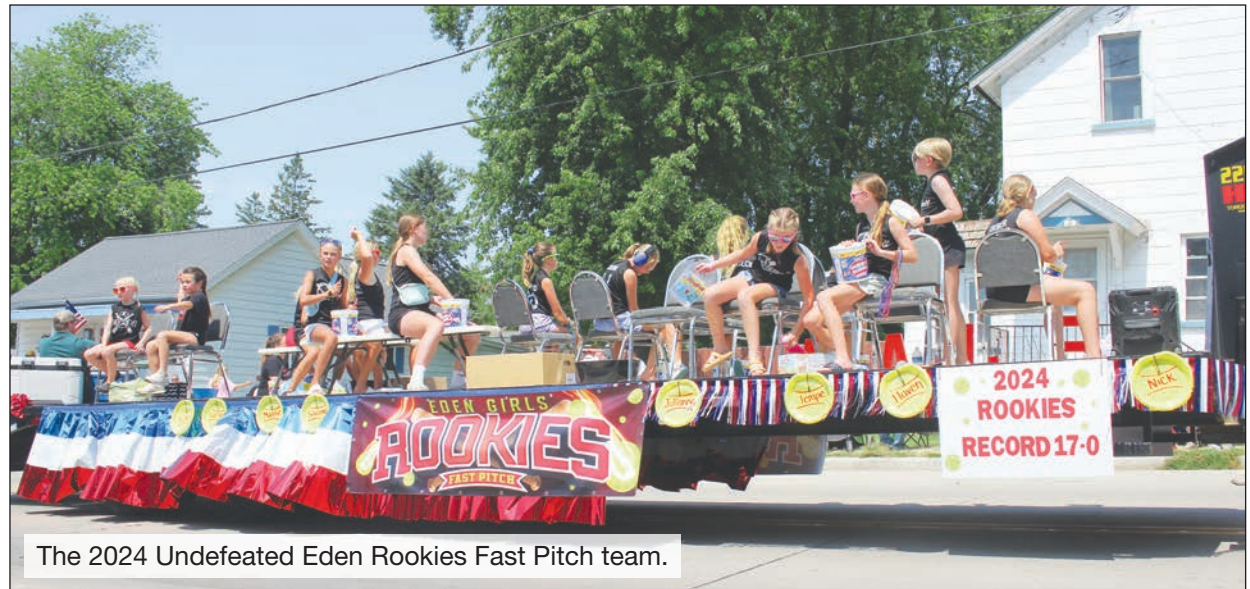

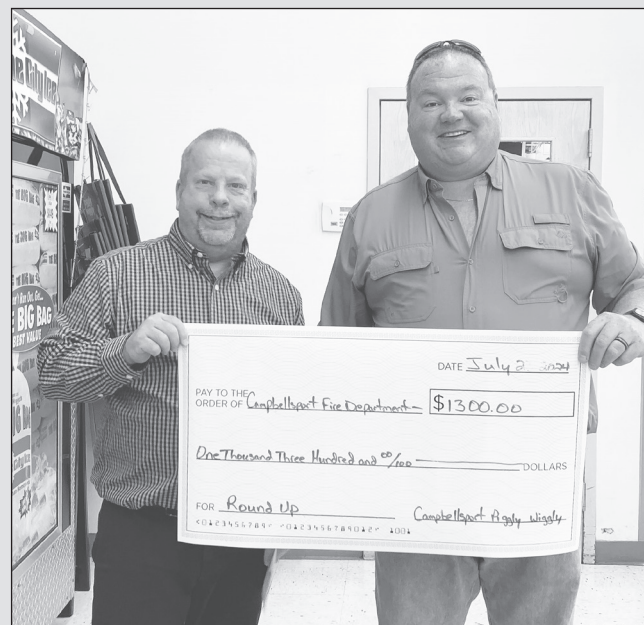

Wisconsin Ruffed Grouse Survey Shows an Increase in Drumming Grouse from 2023

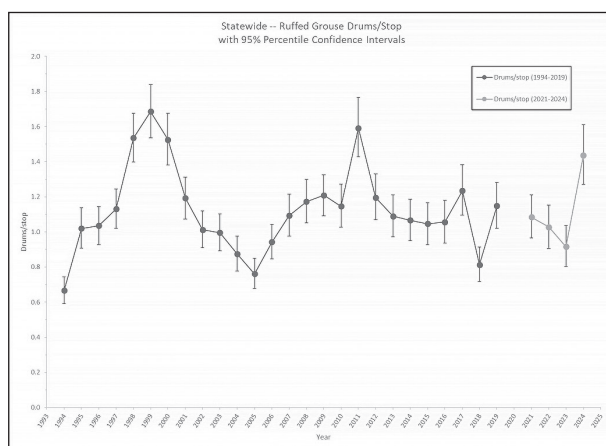

The Wisconsin Department of Natural Resources (DNR) released the results of its annual Roadside Ruffed Grouse Drumming Survey. The survey measured ruffed grouse drumming activity heard along roadsides throughout Wisconsin this spring and showed a 57% increase in statewide drumming activity compared to 2023.

Several agencies and groups, including the DNR, U.S. Forest Service, tribal partners and volunteers, collected the data via roadside surveys of breeding grouse.

“The late spring and summer of 2023 were abnormally dry, which resulted in prime nesting and brooding conditions for ruffed grouse. This is likely the most influential factor explaining the increase in the number of drumming grouse this year,” said Alaina Roth, DNR ruffed grouse specialist. “We are also likely entering the ‘up’ phase of our 10-year population cycle, which may be an influencing factor, too.”

Ruffed grouse typically follow a 10-year population cycle, with peaks occurring in years that end

in 0, 1 or 9. The surveys indicate ruffed grouse in Wisconsin are starting to enter the more populous phase of the abundance cycle. The next peak is anticipated to occur in 2029, 2030 or 2031.

Data is not available for 2020, so it is unknown whether 2019 or 2020 was the high point in the cy-

cle, but drumming numbers appeared to wane in the years immediately following 2020.

Since 2021, survey data has been organized and analyzed by ruffed grouse priority areas to help monitor key populations across the state, as defined in the Wisconsin Ruffed Grouse Management Plan 2020-2030.

The 2024 survey results for priority areas compared to 2023 showed:

A 41% increase in drumming in the Central priority area.

A 60% increase in drumming in the Northern priority area.

A 56% decrease in drumming in the Driftless priority area.

"In addition to positive survey results, the wet conditions across the state should provide excellent brood-rearing opportunities for waterfowl throughout the remainder of the summer," said Taylor Finger, DNR game bird ecologist.

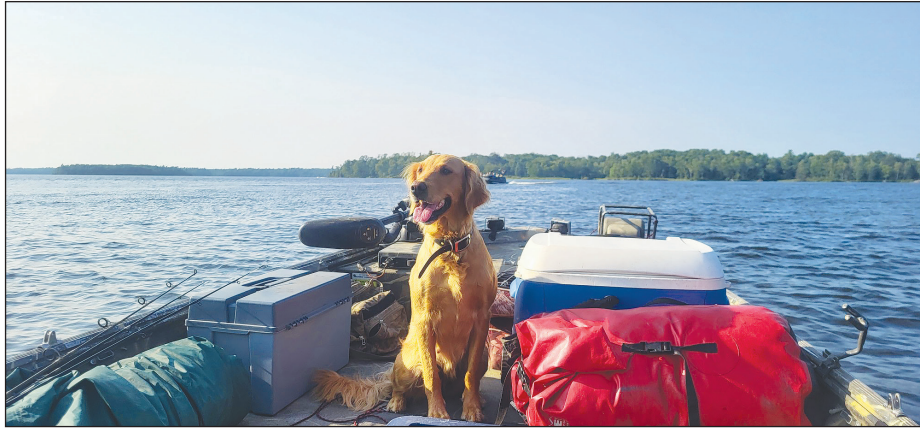
From 6 to 10, I sat by a campfire, listened to the very plentiful population of loons and watched Red and Ruby who were literally as happy as they could be.

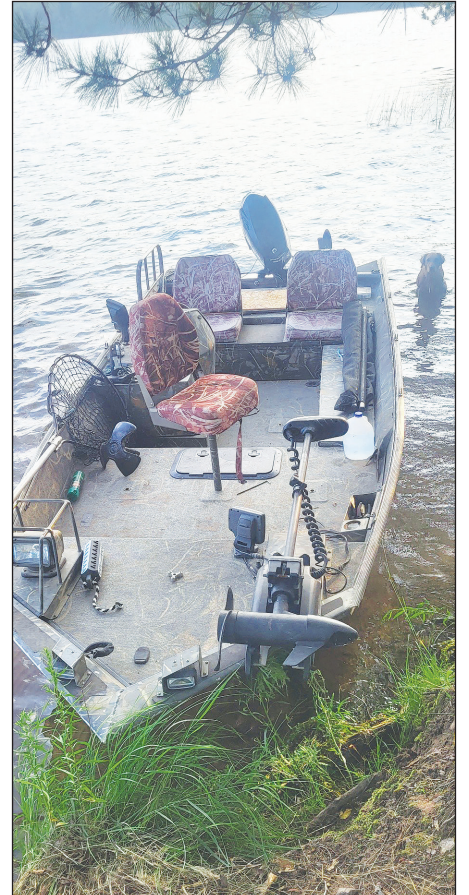
what I really need to do is some retriever training. On 6/15/22, Michelle Chiaro passed away. Michelle was an incredible woman and my love. Red was
